The same court on Tuesday granted bail to Husne Ara Begum, the former principal of the school, in the case.

On Monday, the court issued arrest warrants against Husne Ara and Lutfur Rahman after accepting charges against them.

On July 5, 2011, the victim's father filed a case against the two and Porimol Joydhor, a sacked teacher of the school's Bashundhara campus.

to Ghulam Azam.

Veteran lawyer Dr Kamal Hossain here yesterday said there is no alternative to caretaker government (CG) for a free and fair election in Bangladesh. Referring to the post-Ershad period and

Kamal also talked on a number of issues including the Tipaimukh project.

He observed that there should be a united protest against the Indian attempt to build the mega dam, but put stress on collecting adequate number of documents while taking a stand against the hydroelectricity project. He, however, said we need to maintain a

Youth found dead in **Botanical Garden**

A day after he went missing, a youth was found dead in the city's Botanical Garden yesterday.

The deceased, Md Rajib, 20, a resident of Senpara area in Kafrul, was an electrician.

Yasin Munshi, sub-inspector (SI) of Shah Ali Police Station, said a couple discovered the body covered in hyacinth near a lake in the Botanical Garden.

They called on the security guards there, who informed the matter to the police around 11:00am, he added.

Police found stab marks on the abdomen and throat of the body.

"Miscreants hacked the youth to death," said Anisur Rahman, officer-in-charge of Shah Ali Police Station.

Rajib was missing from his house since Tuesday evening, he said.

SI Yasin said Rajib had a quarrel with another electrician named Rubel, 20, in his locality who did not pay back loans that he took from Rajib.

An arbitration was also held to settle their dispute, he said adding that, local people last saw Rajib in front of his house along with Rubel. Police raided Rubel's house when he could not be con-

tacted over mobile phone.

Police suspect that Rubel and his friends killed Rajib and fled the area.

PW gives false statement

Say Sayedee's lawyers

Defence counsels of Jamaat-e-Islami leader Delawar Hossain Sayedee yesterday suggested that prosecution witness AKM Abdul Awal MP gave a false deposition to the International Crimes Tribunal because Sayedee was his political rival.

"You are the present lawmaker and Sayedee is a former MP with different ideologies," said counsel Majur Ahmed Ansari, adding, "So, driven by envy, you instigated the filing of a false case against Sayedee with help of the government, and gave a false statement against him."

Awal, the 12th prosecution witness in the case filed against Sayedee in connection with crimes against humanity committed during the Liberation War, said it

The tribunal led by its chairman Justice Md Nizamul Huq yesterday finished recording the cross-examination of the ruling party lawmaker from Pirojpur.

Awal had testified in the case on Tuesday.

The court went into session at 10:30am by holding a hearing on the bail petition filed by former Jamaat leader Ghulam Azam. After the hearing, the court began recording the crossexamination of Abdul Awal.

The 58-year-old faced questions about the peace committee and collaborators' force in Pirojpur area, area they were operating and their commanders, and about the time when Pirojpur was liberated in 1971.

Answering to questions, Awal told the defence counsels that he did not file any case against any collaborator or give any testimony against Sayedee over the last 40 years.

At the fag end of the crossexamination, counsel Manjur Ahmed Ansari told the witness that the allegations he brought against Sayedee in his testimony are false.

He concluded by saying that Sayedee was not in Pirojpur or Parerhaat, where he allegedly committed crimes against humanity, as the witness claimed, up to mid-July 1971 from the beginning of the
