Bird poachers active in Lalmonirhat

Bird hunters have become active, especially in different bordering areas of Lalmonirhat district, during the winter that sees a large number of migratory birds.

Most of the perpetrators engage in the unscrupulous act for seasonal earning while others do it just as pastime.

"A section of people are seen moving around Dalai Lama Beel, a large water body at Durgapur village, for hunting birds that come to the country during this season," said Abdus Sattar, a member of Durgapur union parishad in Aditmari upazila.

"We the local people protest bird hunting at Dalai Lama Beel but our urge often falls into deaf ears," he said.

Monsur Ali, a schoolteacher at Kulaghat village, said, "Bird hunters crowd this area on Dharla River basin for hunting birds every winter season. Their illegal act goes on openly. Sometimes the villagers protest it but to no effect."

"I hunt birds every winter as it is my hobby. I go to different villages for hunting birds. I can hunt six to ten birds a day," said Harun Shaikh, 42, a resident of Thanapara in Lalmonirhat town, who recently came to Vatibari village in Lalmonirhat Sadar upazila for hunting birds.

Hamidur Rahman, 45, a resident of Karnopur village in Lalmonirhat upazila, said, "Many people hunt wildlife to earn money. We go to different remote villages especially in the border areas for hunting wildlife, especially different birds."

"Each of us can hunt 10 to 12 birds a day. Many town dwellers purchase the hunted birds for eating," he said.

Seeking anonymity, another hunter said, 'I know there is law against hunting of wildlife including birds. But many people hunt wildlife during the winter season."

"I hunted eight bats from Kurul village of Lalmonirhat Sadar upazila yesterday and sold them in the town today for Tk 80 to 120 each," said Sobur Miah, 48, who was seen

man holds a bat to attract customers on Hospital Road in Lalmonirhat town as the animal also falls prey to poachers.

selling a hunted bat at Hospital Road in the town a few days ago.

"I have been hunting birds for the last ten years. I don't know about any law against bird hunting," he said.

Tobibor Rahman, 40, a resident of Shaheed Shahjahan Colony village in Lalmonirhat town, said, "I have purchased two bats from a hunter in the town this morning for eating."

Tendons of BNP man severed, AL leader hacked

Criminals severed tendons of legs of a union BNP leader in Shailkupa upazila on Tuesday.

The victim, Shariful Islam, 55, is the vicepresident of Kacherkol union BNP. He hails from Kachua village in the union.

Officer in-charge (OC) Ahsan Habib of Shailkupa Police Station said a gang of 20-30 criminals swooped on Shariful when he went to his cropland at the village around 9:00am.

The gang cut off tendons of his legs and left the scene. On information police reached the spot and sent Shariful to Kushtia Sadar Hospital, the OC added.

Shailkupa upazila BNP General Secretary Rakibul Hossain Khan Dipu alleged that local Awami League cadres attacked Shariful and cut off his tendons. He strongly condemned the incident and demanded immediate arrest and exemplary punishment of the culprits.

Refuting the allegation, Shailkupa upazila AL President Amjad Hossain said Shariful has become a victim of local BNP's internal feud. AL men were not involved in such heinous act, he added.

No case in connection with the incident was filed with the police station concerned as of 5:00pm yester-

Meanwhile, a local Awami League leader was injured in an attack by his rivals over a land dispute at Kamraband village in Tahirpur upazila of Sylhet yesterday, reports UNB.

Locals said there had been a longstanding dispute between Tota Miah, general secretary of Badaghat Union Awami League, and Monju Mollick Shemu of the village, over the ownership of a land.

A gang led by Monju Mollick's sons Iqbal, Amir and Babu attacked the house of Tota Miah at around 8:30am and hacked him with sharp weapons.

The injured AL leader was admitted to Tahirpur Upazila Health Complex.

8 'modern-day slaves' rescued

They were confined to a brick field in Khulna

Eight workers were tortured in a barbaric manner confining them to a small room at a brick field at Dakkhin Gilatala under Khan Jahan Ali police station in the city.

The horrific incident took place at the brick field owned by local Awami League (AL) leader Akram Hossain, also former chairman of Phultala upazila.

The victims were identified as Nesar Gazi, 55, Tariqul Islam, 30, Nazrul Islam, 50, Hasan Ali, 25, Jasim Uddin, 18, Rafiqul Islam, 30, Iman Ali, 25, and Taleb Gazi, 32. All of them are residents of Joypur

village under Monirampur upazila in Jessore. The incident of torture came to light

when local journalists visited the spot on Tuesday noon.

The workers said they were confined to a dark room and kept almost unfed in the last five days. They broke into tears after seeing the sunlight and getting chance to meet the journalists.

One of the victims, Nazrul Islam, 50, said he along with others have been working in the brick field, M/s Hossain Bricks, at Dakkhin Gilatala, for last one month.

He said the management confined them to a dark room from Friday.

"We had to remain half-fed and sometimes unfed with just one kg of rice, one kg of chira (flattened rice) and half a kg dal (pulse) supplied to us during the confinement. We had to respond to the call of nature by calling the management staff," narrated Nazrul.

The workers were inhumanly oppressed during the cold season, he said.

Brick field manager Akhter Hossain said labour leaders Rafiqul, Majid and Moti took Tk4 lakh in advance in the name of supplying workers to the brick field.

The workers were confined as they did not work as per agreement. We told them that they would be released if the

advance money is returned to the management, he said.

Brick field owner Akram Hossain said that the labour leaders took over Tk 4.34 lakh in the name of supplying

workers to the brick field. They, in phases, brought 33 workers and of them, only eight workers worked while the rest left the field. They were held basically in a bid to realise the money. The matter was brought to the

The owner, however, denied the allegation of confining them to a small room. The workers were freed after the visit

Officer in-charge (OC) of Khan Jahan Ali PS Mohammad Humayun Kabir said he did not get any allegation of torture on the workers.

However, he agreed that such incident of torture might take place at brick fields.

"We shall look into the matter if such allegation comes to us," he added.

Later, the gang abducted Shawkat from the spot and demanded Tk2,50,000 from his family as ransom.

Two girls commit 'suicide'

Youth beaten to death
