and strong, independent and accountable institutions to be in place in order to have sustainable democracy and development, particularly in the run-up to the next general elections.

Meanwhile, EU Ambassador in Dhaka William Hana, at a meet-thepress programme at Jatiya Press Club yesterday, said he was encouraged to see the dialogue initiated by the president on the formation of a new Election Commission.

He said such dialogue should continue in order to resolve issues relating to the Election Commission and future general elections.

Replying to a question about the concerns expressed by the leader of the opposition when he met her, British minister Mitchell said the opposition was always critical of the government as part of its job.

Asked to comment on the claim made by the prime minister during his meeting that there was no violation of human rights in Bangladesh, he said the British government always took up cases of violation of human rights in the United Kingdom and it had the reputation of standing against it wherever it happened.

Prof Yunus and Grameen Referring to his meeting

with Nobel Laureate Prof Yunus, Mitchell highly appreciated the Grameen Bank microcredit Minister refrained from programme to lift the poor

out of extreme poverty.

"I am placing on records the immense admiration and respect for the work of Prof Yunus by the British government," said Mitchell.

People of Britain have deep respect "for a man who quite literally has altered the lives of millions of people around the world", he said, adding that Prof Yunus contributed significantly in alleviating poverty by helping the poorest of the poor.

Lauding what Prof Yunus has done in Bangladesh and outside to improve the economic condition of the poor, he said "I would like to express my strong support to Prof Yunus. There is also strong support from Britain for Yunus and honour for his very brilliant work."

He also recalled his visit to Grameen Bank and meeting with Prof Yunus around five years back when he (Mitchell) was in the opposition.

"It is a stunning example that Grameen Bank has delivered to many difficult parts of the world in bringing people, especially poor women, out of extreme poverty. This is a record. "I have known interest

rates of Grameen Bank are lower than comparable national banks," he added.

In reply to a question, he said he had expressed his admiration of Prof Yunus during his meeting with Foreign Minister Dipu Moni.

About his observation on terrorism in Bangladesh, the British minister said Bangladesh was pretty free from extremism.

British High Commissioner in Dhaka Robert Gibson and Country Representative of DFID Ms Gwen Hines were present at the press conference.

During his three-day visit, Mitchell also met the finance minister, representatives of the private sector, non-government organisations, and civil society, intellectuals and dalit leaders at Manusher Jonno.

In Dhaka, he visited UKfunded projects by UCEP and Brac and also Khulna.



## Only 'real' sanctions will stop Iran: Israel PM

AFP, Jerusalem

The current regime of US and EU sanctions against Iran is not enough to force Tehran to halt its nuclear programme, Israeli Prime Minister Benjamin Netanyahu said yesterday.

Although Western sanctions against the Islamic republic have been stepped up, Israel remains sceptical that Tehran will abandon its nuclear programme without harsh steps against its oil-based economy and its banking sector. "As long as there won't be real and effec-

tive sanctions against Iran's petroleum industry and central bank, there will be no real effect on Iran's nuclear programme,"

Netanyahu told MPs at a parliamentary committee, with his remarks transmitted by a spokesman.

"The current sanctions employed against Iran harm the Iranians, but not in a way that could bring to a halt in the country's nuclear programme," he said.

"Without significant sanctions on the central bank and petroleum exports, Iran will continue to advance its nuclear plans."

Israel has made no secret of its desire to see crippling sanctions in a bid to halt Iran's nuclear programme, which world powers believe masks a weapons drive but which Tehran insists is for civilian energy and medical purposes alone.

"The government answered these questions many a time and gave assurances that the war crimes trial will be of international standard," he

"If it were me, I wouldn't even bother answering such questions", the NHRC Chairman said while addressing a roundtable discussion at CIRDAP Auditorium in the city yesterday.

The Liberation War Museum in association with International Human Rights Clinic at the University of California and Allard K Lowenstein International Human Rights Clinic at Yale Law School organised the discussion on 'Non-Retroactivity of International Crimes Tribunal and Defining the Crimes against Humanity'.

Mizanur Rahman said that the tribunal is a domestic tribunal under the national legal system and it meets international standards, as the "national standards are in compliance with international standards".

Laurel E Fletcher, clinical

professor of Law at the University of California, Berkeley, said such trials run the risk of turning into political show trials, where laws are bent to produce predetermined results.

She highlighted the need for a transparent mechanism through which the civil society can share its views with the tribunal.

"Several international cases show that new pieces of evidence brought in by civil society members actually helped the trial," said Fletcher.

Law Minister Shafique Ahmed said nobody would be prosecuted only for political revenge.

"I request the international community not to be misled by such false allegations by lobbyists engaged by those accused in the war crimes trial", he said.

Barrister Sara Hossain, honorary director of Bangladesh Legal Aid and Services Trust (Blast), urged all not to put any form of pressure on the tribunal and allow the trial to move at its own pace.

security was widely questioned following the killing of a student, handed in his resignation to the vice chancellor before noon yesterday, a deadline set by the agitating teachers for his removal.

"I have submitted the resignation letter willingly, considering the welfare of students and the university," Prof Arzu told reporters.

VC Prof Shariff Enamul Kabir confirmed that he had accepted Prof Arzu's resignation.

On January 9, massive protests erupted on the campus after Zubair Ahmed, a student of the English department, succumbed to his injuries that he had suffered from beatings by a group of Bangladesh Chhatra League activists the previous day.

Students and a section of teachers opposed to the vice chancellor took to the streets with a set of demands, including the removal of the proctor and his associates, and punishment of the killers.

The crisis further intensified as Prof Arzu on January 12 allegedly assaulted Prof AA Mamun, president of JU Teachers' Association, at a meeting of the association called to scrutinise the JU

administration's role during and after the attack on Zubair. Replying to a query at his

briefing at the JU Senate Bhaban, Prof Arzu once again claimed that the allegation of assaulting Prof Mamun was nothing but propaganda. The teachers continued their class boycott yesterday

for the third consecutive day.

They brought out a protest march and held a rally on the vice-chancellor's office premises at noon. Later, briefing reporters on the campus, Prof Nasim Akter Hossain, convener of

the agitating teachers' platform Shikkhak Samaj, welcomed Arzu Miah's decision to resign.

"We will return to the classrooms and perform other professional activities from tomorrow [today]," she said.

Prof Nasim, however, said the teachers would continue their movement until the administration met their other demands -- removal of the rest of the proctorial body members, punishment of the outgoing proctor, and reconstitution of the committee formed to investigate Zubair's murder.

Students also brought out a procession on the campus yesterday and submitted a memorandum to the VC to press home their demands. They vowed to continue their agitation until the killers got due punishment. **JUSYNDICATESITS** 

The highest decision making body of the institution at an emergency meeting last evening called upon teachers, students and others concerned to participate in academic and administrative activities as usual.

Chaired by VC Prof Shariff, the meeting also asked the probe committee to get its job done soon and submit a report with recommendations.

Expressing sympathy for the bereaved family members of the slain student, the syndicate urged the media to help maintain a congenial atmosphere at the institution by publishing authentic news, said a press release.
