Boro to be costly as diesel, fertiliser prices spiral

Boro farmers will have to count additional production cost this season due to increase in prices of diesel and fertiliser.

In the district, the extra cost for the purpose will stand around Tk 50 crore, said agriculture experts.

This year the Department

of Agriculture Extension (DAE) in the district set a target to cultivate boro on 78,212 hectares of land while last year the paddy was cultivated on 78,490 hectares, officials said.

Higher price of diesel and fertiliser might be the cause behind the slight fall in cultivation target, said farmers.

Farmers in the district

will use 24,600 diesel-run shallow pumps and three diesel-run deep tube-wells in the ongoing boro season to irrigate 61,500 hectares of land out of a total 78,212 hectares while electricityrun shallow pumps and deep tube-wells will irrigate the rest, DAE sources said.

Farmers informed that it needs 370-litre diesel to

irrigate a hectare of land during three-month boro season that usually requires 18 times irrigation on an

Four months ago, diesel sold at Tk 46 per litre while its present government rate is Tk 61. Accordingly, farmers have to spend additional Tk 34 crore for buying diesel for irrigation of 61,500 hectares of land. Given the fact that diesel in rural areas is selling for Tk 63-64 per litre, the cost will be even more.

Besides, a bag of urea is selling at Tk 1000 which was Tk 600 before June last year. As farmers will need five bags of urea containing 50 kg each to spray on a hectare of boro land, they will need additional Tk 2000/ to buy the fertiliser for the same land.

Accordingly, farmers have to spend additional Tk 16 crore to buy urea for 78,212 hectares of boro land.

And so, farmers in the district have to spend additional Tk 50 crore for buying diesel and urea in this boro season, said agriculture

Farmers Tayed Ali, Wahed of Kishoreganj upazila, Ramjan Ali, Mohabbat Hossain of Dimla upazila said they cut cultivation target as the price of agricultural products like paddy, jute and vegetables have decreased alarmingly while prices of diesel, urea and agricultural tools are increasing.

Mostafizar Rahman, district training officer of the DAE, admitted that farmers have to spend additional money for buying fuel and urea.

He, however, claimed that farmers' total expenditure will not increase that much as the government reduced the prices of murate of potash and triple super phosphate.

Masked men burn down Shibir-run school

Criminals vandalised and burnt a school at Karotia in Tangail Sadar upazila early yesterday.

At midnight, a masked gang went to Lighthouse School, run by Islami Chhatra Shibir men at Rokeya Manzil of Karatia Jamindar Bari, police said.

They threw the tables, chairs and benches, as well as documents and papers out of the school building and set those afire. They also set fire to four classrooms of the institution, police said.

Being informed, fire service men from Tangail rushed to the spot and doused the fire.

"We set up the school at Rokeya Manzil of Karotia Zamindar Bari after renting

Banting, the motowalli (supervisor) of the endowment estate, following house rent rules," Jahanur Chowdhury, principal of the school, said.

"However, a dispute took place between the motowalli and his younger brother Morshed Ali Khan Panni Tipu over the matter and Tipu recently directed the school authorities to leave the building.

"We were making preparations to shift the school to another place but a gang burnt it before our exit, making education of 550 students of the school uncertain," the principal said.

costlier this season as prices of diesel and fertiliser saw steep rise during last couple of months.

Charges were yesterday pressed against three people allegedly for instigating a man to commit suicide at Tongbhanga village in Hatibandha in August 2011.

Police said Sayeed Sabid Rubel, 30, committed suicide over a family feud at his rented house at Tongbhanga village in the upazila on the night of August 3 in 2011.

Rubel's mother Reshma Bewa filed a case against his wife Lazina Begum, motherin-law Parul Begum, 48, and sister-in-law Hira Begum, 25, with the Chief Judicial Magistrate's Court, Lalmonirhat, on August 8 the same year.

As per order of the court, Hatibandha Police Station recorded the case on September 30 in 2011. After investigation officer of the case, submitted the chargesheet to the court, accusing the three of instigating Rubel to commit suicide.

In the case statement, the complainant said her son Sayeed Sabid Rubel of Surkimil Colony in chargesheet.

Lalmonirhat married Lazina Begum, daughter of Nurul Islam Master of Purbo Thanapara village in Lalmonirhat Sadar upazila in January 2010.

Rubel had an altercation with his wife Lazia over her investigation, Sub-Inspector affair with a man. He also Anisur Rahman, also the informed Lazia's mother and sister of the matter, but the duo sided with Lazia. Failing to settle the issue, he committed suicide, the complainant said.

Bogra trader to face tax evasion case

The National Board of Revenue (NBR) is going to take legal action against a businessman in Bogra for evading tax.

Md Abdus Salam, deputy commissioner of taxes at Bogra Circle-1 of the NBR, told this correspondent yesterday that they would likely to file a case against Gouri Shankar Prosad, owner of GS International in Bogra, today. Earlier on December 8,

2011, a board meeting of the NBR decided to take legal action against the businessman following an investigation report submitted by its Central Intelligence Cell (CIC). NBR sources quoting the report said the businessman

evaded Tk 16.30 crore tax by preparing fake documents on import of commodities, including onion and garlic, during the fiscals 2007-2008 and 2009-2010. Refuting the allegation,

Gouri Shankar said the NBR move is meant for harassing him.

"Despite repeated request to assess the actual amount of tax that I have to pay, they did not give me the assessment report."

However, NBR official Abdus Salam said Gouri Shankar never submitted any application to the NBR for the assessment.
