Protests grip  
Maldives

Hundreds of protesters have taken to the streets in the Maldivian capital Male amid a stand-off between President Mohamed Nasheed and the judiciary, officials and residents said on Thursday.

Anti-government activists demonstrated overnight keeping up pressure on Nasheed who initiated the arrest Monday of the head of the country's criminal court on charges of misconduct and favouring opposition figures.

The government on Wednesday raised fears of Islamic extremism taking hold in the Indian Ocean atoll nation, which is best known for its upmarket tourism and as a destination for honeymooners.

Says Myanmar president

Myanmar's president has promised that his country will not turn back from the path to democracy and called on Western nations to end sanctions which he blamed for hindering reform efforts.

"My message is that we are on the right track to democracy," Thein Sein said in an interview with the Washington Post published yesterday.

"Because we are on the right track, we can only move forward, and we don't have any intention to draw back."

The country formerly known as Burma now has a nominally civilian government following a controversial November 2010 election, but its ranks are filled with former generals including Thein Sein.

The regime has surprised observers with

a series of reforms, including talks with democracy icon Aung San Suu Kyi, who has been allowed to stand in an April by-election, and the release of hundreds of political prisoners.

"Our government is only about nine months old. In terms of democratic experiences and practices, we still have very little experience and practice," Thein Sein was quoted as saying.

"If you would like to see democracy thrive in our country, you should take the necessary actions to encourage this by easing the sanctions that were placed on our country."

The April 1 by-elections, where democracy icon Aung Sung Suu Kyi will participate, are seen as a major test of the regime's reform credentials.

## TIB-TII, AI slate BSF atrocities

Dr Iftekharuzzaman and TII Executive Director Anupama Jha said, "It is extremely regrettable and absolutely unacceptable that members of a security force of a democratic country can abuse power so despicably and indiscriminately to collect bribe".

Welcoming the immediate suspension of the jawans by the BSF authority, they called upon the BSF and the Indian government to ensure justice in a manner that would deter any future recurrence of such inhuman brutality for shameless act of bribery. Failure to do so will grossly undermine the democratic credentials of India.

The statement said, "Allegation of the victim's probable involvement in smuggling can never justify the kind of extra-judicial torture and violence that BSF frequently resorts to, causing killings, injuries and other forms of injustices in the

border on a regular basis."

It said, this particular incident graphically reinforces the perception that elements within the BSF, being corrupt beneficiaries, are not only responsible for alleged illegal activities across the Indo-Bangladesh Border, but also for systematic and indiscriminate violation of human rights.

The top officials of Transparency International further said, "The departmental court of inquiry that has been taken up is important, but not enough because of potential conflict of interest".

They demanded that a judicial probe be immediately constituted to ensure the fullest possible justice.

Commending the role of the India media in bringing the incident to public attention, TIB and TII said, "As the world's largest democracy and as a state party to the UN Convention against Corruption, India has the responsibility to demon-

strate that it is committed to human rights and justice as well as to effectively control corruption".

A video clip of nearly five minutes was aired on January 18, on some Indian TV channels, including NDTV showing a Bangladeshi young man being beaten by some uniformed BSF members in Murshidabad district of Paschimbanga.

The video showed the victim pushed to the ground, stripped, kicked and tortured indiscriminately.

## AI SAYS SUSPENSION NOT ENOUGH

The suspension of eight guards of the BSF for torturing a Bangladeshi caught on the border "is not a sign that human rights violations are being addressed", the Amnesty International said yesterday.

"This incident of apparent torture is only the tip of the iceberg - dozens of Bangladeshis are believed to be tortured or ill-treated after

being picked up by Indian border security guards every month," said AI's Bangladesh Researcher Abbas Faiz.

That eight Indian guards have been suspended is not in itself a sign that BSF officials are on the look out to address human rights violations - these guards were suspended only after the video footage was aired by Indian TV, embarrassing the BSF.

"Many such incidents take place with no action taken against the Indian border guards because the victims do not dare to speak out for fear of repercussions."

"Many of the people who cross this border have families on both sides. The Bangladeshi government has lodged a complaint with the Government of India but this should not be the end of the story. Bangladesh must keep the pressure on India to take decisive steps to protect Bangladeshi citizens, and prevent such incidents recurring," the AI official added.

Parliament to  
decide on  
Nato supplies  
resumption  
Says Gilani

Pakistan's Prime Minister Yousaf Raza Gilani yesterday said that while former ruler Pervez Musharraf gave into US demands on a single telephone call, the decision to resume Nato supplies would be made by the parliament, Dawn News reported.

Speaking to media representatives in Lahore, the prime minister said that as opposed to the appeasing attitude of the Musharraf government, not only had the current democratic government suspended Nato supplies to Afghanistan, it had also boycotted the Bonn conference.

He further said that the parliament would decide the issue of resuming supplies to Nato forces.

The premier said the government was functioning in accordance with the mandate bestowed upon it by the people.

He said that his appearance before the Supreme Court showed that he respected the judiciary and its orders.

The prime minister reiterated the pledge that the Pakistan People's Party-led coalition government would come up with solutions of issues faced by the public on a day-to-day basis.

## India questions tribal 'isolation' policy

Many of India's protected tribal groups live in "beastly" conditions and the government should review long-standing laws that keep them in isolation, the country's tribal affairs minister told AFP.

His comments were prompted by the "Human Zoo" scandal involving a video of naked Jarawa tribal women on the tropical Andaman Islands being told to dance for tourists, who had allegedly bribed a policeman to gain access to their reserve.

Deo, who has vowed to visit the Andaman Islands on a special trip within weeks, said that the issue of how to deal with protected tribal groups was highly divisive and that the government needed to listen to tribal people.


"We have to start a dialogue," he said.

But other groups and campaigners, such as Survival International, say tribes such as the 402-strong Jarawa tribe should be left alone.

The London-based Observer newspaper, which first published the video that triggered the controversy, said its journalist saw tourists toss bananas and biscuits to tribespeople on the roadside.

Other tribes on the Andamans, such as the Sentinelese, shun all contact with the outside world and are known to be hostile to any encroachers.

Their last remaining territory, North Sentinel island, is out of bounds even to the Indian navy in a bid to protect its reclusive inhabitants who number only about 150.

HYSAWA (Hygiene, Sanitation and Water Supply) Fund has applied for grants from the Danish International Development Agency (DANIDA), Australian AID and the Government of Bangladesh (GoB) towards the cost of the HYSAWA Fund Project (2012-2015). The HYSAWA Fund has been established as a non-profit company registered under the Companies Act, 1994. HYSAWA Fund, upon receiving formal proposals and/or applications from eligible Local Government Institutions (LGIs), Union Parishads (UPs) in particular, and subject to certain conditions, provides grants to these LGIs to implement demand-driven and community-based hygiene, sanitation and safe water supply projects. HYSAWA Fund intends to apply part of the proceeds of these grants to pay towards the eligible payments under 5 (five) service packages for providing training to Union Parishads (UPs) and other stakeholders.

2. The overall objective of the assignment is to develop technical, financial and management capabilities of participating UPs and other stakeholders. The training organizations of each package will provide 'Foundation and Refresher's Course' for UP chairman, members and secretary, covering the following courses: (i) Sub-Project Planning, Implementation and Monitoring (ii) Public Procurement & Contact Management (iii) Accounting and Book Keeping (iv) Cross Cutting Issues (v) Admin. & Office Management (vi) Supervision, Monitoring & Reporting; and for Support Organization (SO) and Partner NGO (PNGO) staff (i) Hygiene Promotion and Community Led Sanitation course. Detailed Terms of Reference (TOR) will be provided in the Request for Proposals.

- Should have 10 (ten) years of overall experience in providing training. (max. 5 pages) (successful completion certificate from previous clients/employers should be provided with the EOIs.)
