Sri Lanka warns ex-Tamil rebels against revolting

IANS, Colombo

Sri Lanka has warned former Tamil Tiger rebels not to engage with any group which may be attempting to overthrow the government.

The warning came after a splinter group of a Marxist political party in Sri Lanka claimed it has established contacts with some former rebels who were rehabilitated by the government and released into society, Xinhua reported.

If any former rebels, rehabilitated and released into society, were found to be having links with groups looking at creating an unstable situation in the country, they will be arrested, said the military official in charge of the programme to rehabilitate former rebels from the Liberation Tigers of Tamil Eelam (LTTE).

Commissioner General of Rehabilitation Major General Chandana Rajaguru, however, said that so far they have not come across or received information regarding such activities. He said former rebels are

free to engage in politics but they cannot look to overthrow the government through violent means.

The banned organisation on January 8 circulated provocative leaflets based on fugitive Maj Syed Ziaul Haq's internet message throughout the country, the army said at a press conference on January 19.

The Bangladesh chapter of Hizb-ut-Tahrir was banned on October 22, 2010 for its anti-state subversive activities.

However, instead of ceasing its activities, the outfit tried to bring out processions and hold rallies on several occasions in and outside the capital and advertised several of its publications. It circulated the internet

message of Maj Ziaul, who met a serving officer on December 22 last year and instigated him to engage in activities subversive of the state and democracy. The banned outfit also

circulated a provocative leaflet in Bangla and English in December asking army officers to remove Sheikh Hasina from power and establish Khilafat". The army at its press con-

ference said a few arrested and suspected officers involved in the foiled plot were linked with the outlawed outfit. "If you review the mode of

activities of militant organisations, their indoctrination system, ideology and how they work, you will know that two to three officers who admitted their links with Hizb-ut-Tahrir relate to the patterns [mentioned above]," said Brig Gen Mashud Razzaq while responding to journalists' queries. "Besides, information

given on email has been mentioned in Hizb-ut-Tahrir leaflets," he added. He, however, said the links

could be confirmed once investigations had been completed. Against the backdrop of

the latest developments, the law enforcement agencies have strengthened their efforts to trap Hizb-ut-Tahrir activists in the country. A number of activists have

already been arrested in the act of distributing posters, leaflets and other publica-

The outfit, however, continues promoting its activities, thus defying the government ban and challenging the law enforcers. Its members are continuously posting Tahrir posters on walls, bringing out processions, distributing leaflets and carrying out motivational activities across the country.

Posters at different strategic points across the country contain calls to support the outfit to topple the government and implement its proposed Islamic govern-

Talking to The Daily Star, several top-ranked officials of the elite Rapid Action Battalion (Rab) and Detective Branch of police expressed their inability to combat the outfit's activities. They have stressed the need for a separate tribunal to check unabated militancy.

They said they had already launched a crackdown on Tahrir, pointing out that the arrest of five activists in Uttara was a part of the ongoing crackdown.

Lt Col Ziaul Ahsan, director of the Intelligence Wing of Rab, told The Daily Star, "It is tough to stop Tahrir men as they get all kinds of support from the organisation if they are arrested. Families of the detained activists also get financial support. As a result, they don't bother much about the arrest." Since the ban, some 500

Hizb-ut men have been arrested, but most of them are now out on bail.

In such circumstances, L Col Ziaul Ahsan opined, a specific and separate tribu nal should be in effect to fight the militants.

Specials courts through a specific tribunal system should be set up at all district headquarters by enacting a new law for the trial of the militants," he observed.

"As Tahrir has strong financial support, members from JMB, Hizb-ut-Tawhid Allah'r Dal and other militant organisations are also joining it," added Lt Col Ziaul. "Some teachers of several universities, English medium schools and madrasas, doctors and businessmen have been identified as new leaders in the banned organisation."

Monirul Islam, deputy commissioner of DB (South) said the law enforcers had arrested a large number of people in connection with Tahrir, but most of them resumed their activities after they came out of prison on

He said students coming from solvent and educated families were being exploited and getting involved in Hizbut because of motivation based on wrong explanations of Islam and least care from their parents.

Hizb-ut-Tahrir is an international Islamist political party founded in Jerusalem in 1953. It commenced its activities in Bangladesh in

The presence of at least two members will be required to make a quorum at a committee meeting.

'The committee will recommend two names against the vacant post of the chief election commissioner and two for each of the election commissioners in line with the majority view at its meeting," the circular added.

In case of a tie, the committee chief will cast the deciding vote.

The Cabinet Division will provide secretarial assistance for the search committee.

In light of the outcome of his talks with 24 political parties, the president on January 12 sent a letter to the government, proposing legislation to form a search panel to set up a new election commission.

The president also mentioned that if enacting a law was not possible for time constraints, the government can form a search committee through a gazette notification, said a Bangabhaban source.

The Workers Party and Jatiya Party -- two major components of the ruling Awami League-led grand alliance -yesterday said it would have been better if the government had enacted a law to form the search committee.

Workers Party President Rashed Khan Menon and JP Secretary General Ruhul Amin Hawlader, however, welcomed the move and said no government in the past had taken such an initiative.

Chief Election Commissioner ATM Shamsul Huda also welcomed the government

decision. He, however, said passing a law to regulate the appointments would be well worth it.

BNP REJECTS Meanwhile, the main opposition BNP has rejected the formation of the search committee, saying it will not accept anything until the caretaker government sys-

FROM PAGE 20 Of the foreign aid, the government in the first six months of this fiscal year spent only 17 percent -- lowest in the last four years, Implementation Monitoring and Evaluation Department (IMED) stats

While it spent 35 percent of the allocation from the local fund, highest over the same period

The Finance Division yesterday issued a notice saying unutilised foreign fund will be deducted from the revised Annual Development Programme (ADP).

The government has taken the step in line with IMF conditions to cut expenditure, the official said.

The lending agency advised the government to issue a circular to the ministries concerned by January this year indicating that shortfalls in the externally-funded ADP budget will not be substi-

tuted with taka funding. This year, subsidies on fuel import for rental power plants have exerted huge pressure

on budget. As the price of fertiliser, food grains and fuel oil went up in the international market, expenditure on subsidy and interest payment for these items increased to exceed the projection in the original budget, the notice

Over the rest of the current fiscal year, expenditure in these sectors is likely to increase further. It compels the government to allocate additional fund for these sectors.

The finance and planning

ministries have already discussed with different other ministries the amount of foreign funds they can use in the current FY. They estimated this time the use of foreign funds will not only fall below the projection but also decrease compared to the previous year. Finance Minister AMA

Muhith at a meeting of the Metropolitan Chamber of Commerce and Industries (MCCI) last week said, in the last fiscal year local funds were allocated to substitute foreign funds but this year it will not be possible.
