Fertiliser stacked in the open as godown space too scanty

Rain, dew cause damage to the agri input

Huge urea and potash fertilisers have been kept under the open sky at the buffer stock of Banbladesh Chemical Industries Corporation (BCIC) at Shibganj village and BADC godown at Madarganj village in Thakurgoan Sadar upazila due to shortage of space in the warehouses.

Exposed to melting by rain and dew, the fertiliser often decreases in amount, making farmers unwilling to receive it, dealers said.

"Now 25,000 tonnes of fertiliser is reserved at Shibganj Buffer Stock although its godown has the capacity to keep only 7,500tonne. Shortage of space in

> "The two godowns can keep 1,800 tonnes of fertiliser while the current stock is 4,300 tonnes. Sacks of fertiliser have been kept under the open sky since December due to the space shortage," BADC godown in charge Md Nurul Amin said.

As the tin-sheds of the godowns have become older, the fertiliser sacks get wet and damaged when it

rains, he added. Modasser Hossain, a fertiliser dealer in the dis-

trict, said sub-dealers often

decline to receive dampened fertiliser sacks as the farmers do not want to take such fertiliser.

"We have to count losses as farmers do not want to take dampened sacks of fertiliser that decreases in amount due to melting by rain and dew. They also think the damp fertiliser loses its effectiveness," said Mahbubur Rahman, subdealer of Bokosher Hat in Akcha union under Thakurgoan Sadar upazila.

When contacted, Belayet Hossain, deputy director of the Department of Agriculture Extension in Thakurgaon, told this correspondent over cell phone, "It is true that urea fertiliser decreases in amount when it melts in rain. But it does not lose its quality."

SYLHET SHRINE BLAST CASE

No headway in 8 years, IO changed 7 times

Investigation into the case for bomb attack on the premises of Hazrat Shahjalal's shrine on the night of January 12 in 2004 is yet to see any progress, although the case was revived early 2010, a year after the present Awami League-led government took over.

Five people were killed and 40 others sustained injuries in the bomb blast during the annual Urs (religious congregation) at the shrine premises where thousands of people from across the country attended.

Earlier in December 2008, police filed 'final report' in the case as the investigators failed to find any clue to the Investigation Department tragic incident.

"I was given the task in mid 2008. During the four years before that, six officers ran the job one after another but there had been no clue to the incident," said the then investigation officer (IO) of the case -inspector of Criminal

CID Inspector Shamimur Rahman Pir, the present IO of the case, told this correspondent, "I was given the charge of investigation in February 2010. The job is really tough as there has been no significant development during the long time after the bomb attack. However, we are trying our best."

Wife set afire for dowry, husband arrested

A man set his wife afire allegedly for dowry at Ramchandrapur village in Sadarupazila on Sunday night.

The victim, Mazeda Khatun, 25, is the second wife of Shahidul Islam, son of Abdul Gani Biswas of the village. Despite having first wife

named Champa Khatun and four children, Shahidul, a rickshaw-van puller married Mazeda, daughter of Babar Ali of Palashbari village in Kurigram district about a year ago, Sadar police station SI Azizur Rahman said. After marriage, he

demanded Tk 50,000 in dowry from Mazeda. As she refused to comply with his demand, both Shahidul and Champa tortured her off and on.

On the night, the two poured kerosene on Mazeda and set her on fire. Then they took her to Jhenidah Sadar Hospital.

On information, police rushed to the hospital and arrested Shahidul. But his first wife fled the scene. Police also took deposition of Mazeda under Section 164.

Contacted, the Resident Medical Officer (RMO) of Jhenidah Sadar Hospital, Dr Rashed AL-Mamun said Mazeda sustained grievous burn injuries.

As her condition worsened, she was referred to Dhaka Medical College and Hospital (DMCH).

Human rights activists shifted Mazeda to DMCH burn unit yesterday noon where her condition is stated to be critical.

Female banker commits suicide

A female banker committed suicide by hanging herself from the ceiling fan of her house near BM College in the city on Saturday.

The deceased, Sumana Sultana, 44, was senior principal officer of Barisal zonal office of Rupali Bank and mother of two children. Her husband Monirul Islam works at Rahamatpur Agriculture Research Office as an officer of its mushroom project. She left behind a son studying in class V and a daughter studying in class II.

Family sources said Sumana had a mental illness and was under treatment of a psychiatrist.

On return from a coaching centre along with her children, she went to the bedroom asking a domestic help to bring clothes from the roof of her house.

When the domestic help came back from the roof, she found the body hanging

from a ceiling fan. Hearing screams, children and neighbours rushed to the spot and took her to Sher-e-Bangla Medical College and Hospital where the attending doctors declared her dead.

Sumana's husband was not present at the house during the incident.

Fire kills boy

A five-year-old boy was burnt alive at their house at Debpur in Burichong upazila early Sunday.

The deceased, Mehedi Hasan, was son of Abdul Awal, a worker of Comilla Spinning Mill. Fire service sources said the fire originated from an electric short circuit at the house at around 3:00am.

Mehedi was burnt alive as he could not come out of the house. He was staying alone in his room as his father was not present while his mother, also a worker at the mill, was on duty during the incident.

ASI, constable sued on extortion charge

An assistant sub-inspector (ASI) and a constable of Hakimpur police station in the district have been sued on charge of extorting a woman, threatening to implicate her son in false

The accused are ASI Shah Alam, and constable Enamul Haque.

Sadiya Begum, wife of Bazlur Rahman of Uttar Basudevpur village in Hakimpur upazila under Dinajpur filed the case against them with the Court of Chief Judicial Magistrate Sohag Talukdar on Sunday afternoon, court source said.

The court took the case into cognizance and asked

Biman Karmaker, ASP (Phulbari Circle) of Dinajpur, to register a case, conduct an investigation in this regard and submit report before the court by February 19.

"Some policemen of Hakimpur upazila of Dinajpur picked up my son Md Saju on December 4 last year," Sadiya Begum mentioned in her case.

"ASI Shah Alam and constable Enamul Haque came to my residence on the same night and demanded Tk 1 lakh, threatening to send my son to jail after implicating him in various cases if I do not meet the demand. Scared, I gave Tk 32,000 in cash and a cheque worth Tk 50,000 to them," she said.

"Next day, I verbally informed the officer in charge of Hakimpur police station and he assured me of taking action against the two police men. But the OC has not taken any action against them still now. And so, I filed the case with the Chief Judicial Magistrate's Court of Dinajpur seeking justice," Sadiya Begum said.

When contacted, Hakimpur police station OC Helal Uddin said, "I have taken action against the ASI and the constable following the complaint of the woman. An investigation is pending in this regard. I am yet to know about filing of any case against the two policemen."

Madrasa girls demand removal of teacher

Students of Khan A Sabur Mahila Madrasa run by Khulna City Corporation (KCC) formed human chains followed by protest demonstrations in front of the madrasa on Sunday and yesterday demanding removal of and legal action against their teacher Moulana Mizanur Rahman for his alleged sexual harass-

Demanding the same, they have continued boycotting classes since January

Guardians and other teachers have also warned of joining the movement of students demanding removal of the alleged teacher.

Moulana Mizanur Rahman, an Arabic teacher of the madrasa, was placed under suspension on the basis of a probe report submitted by the additional

deputy commissioner (Education) of Khulna on March 13 last year. This action was taken as

allegations of sexual harassment and other malpractices against Mizanur Rahman were found true during investigation. The probe into allega-

tions against Mizanur Rahman was ordered following a petition submitted by 20 teachers of the madrasa on November 1 in 2009. The teachers also wrote

several letters to the chairman of Madrasa Education Board demanding Mizanur Rahman's removal from

Students started boycotting their classes on January 13 this year as the suspended teacher was reinstated in his service on January 12 by order of madrasa Principal Moulana Abdus Sobhan, ignoring recommendations of the probe report.

Besides, Principal Abdus Sobhan and Chairman of

madrasa governing body Mostajabul Huq Mostafa are reported to have threatened students of stern action for boycotting of classes.

When contacted, KCC Mayor Talukder Abdul Khaleque admitted to the allegations of sexual harassment against Mizanur Rahman and students' movement by them.

"I have taken the matter seriously as the madrasa is being run by Khulna City Corporation. The crisis would be resolved properly," the mayor said.

Asked about the matter, Principal Moulana Abdus Sobhan said, "Members of the managing committee will sit in a meeting shortly to take final decision about whether the accused teacher should be removed from service or reinstated."

Mizanur Rahman termed the allegations against him as false and refused to comment on recommendations of the probe report.
