A Dhaka court yesterday adjourned till February 16 the hearing of a money laundering case against BNP Senior Vice Chairman Tarique Rahman and his business partner Giasuddin Al Mamun.

Judge Mohammad Mozammel Haque of the Special Judge Court-3 adjourned the hearing following a prayer seeking time by the defence lawyer.

Meantime, two prosecution witnesses -- Hosne Ara Begum, the then officer-in-charge of Cantonment Police Station and Mir Alimuzzaman, the then inspector of Detective Branch of police -appeared before the court yesterday to face crossexamination by Mamun's lawyer.

Both the witnesses gave their statements before the court on December 8 last year.

Mamun was present at the court while Tarique

is now in London. Tarique was detained on March 7 in 2007, but allowed to go abroad for treatment next year.

BCL factions clash at JnU: Six injured

Violent clashes between two factions of Bangladesh Chhatra League yesterday left at least six activists hurt at Jagannath University and vehicular movement suspended on adjacent North-South Road for more than one hour.

Equipped with machetes, knives, iron rods and other weapons, several hundred BCL men from both the groups staged showdowns from 11:00am to 12:30pm creating panic on the campus, witnesses said.

Sources say the clashes erupted following two incidents on Monday over establishing supremacy on social organisation Magura Zila Chhatra Kalyan Samity and Jagannath University Cultural Centre.

The university authorities sealed off the cultural centre on Monday

Later on Monday night, a scuffle broke out between the rival groups at a restaurant near the university over the supremacy in Magura Zila Chhatra Kalyan Samity. Witnesses say during the clashes

chase and counter-chase took place between the two groups led respectively by Saiful Islam Akand, convener of BCL university unit, and Khandaker Arifuzzaman, joint convener of the unit.

At one stage, Arifuzzaman group drove away Saiful group from the campus.

Vehicular movement on the North-South Road remained suspended for more than an hour causing severe traffic jam in the area.

Panicked students were seen created anarchy and destabilised the running to save themselves and taking shelter at different classrooms and even in the toilets. Police also obstructed traffic

movement on the road to avert van-

dalism and destruction by the BCL Leaders of the BCL central committee rushed to the spot and eased

the situation at 2:00pm. However, tension was prevailing on the campus.

Proctor of the university Dr Kamal Uddin Ahmed termed the incident "very sad" and expressed concern over the situation. "The incident was triggered by their earlier feuds, which are not related to the interests of the general stu-

dents," Dr Kamal commented. "We are going to take stern actions against those who have

peaceful situation," the proctor added. He said as the vice-chancellor is

abroad, actions will be taken after having a discussion with him. Khurshid Hossain, deputy commissioner of Lalbagh division police,

said they had to keep traffic off the road for a while to avoid vandalism. Asked, he said they did not arrest anyone as the university authorities

did not file a complaint with them. In a separate incident, several hundred students of Dhaka Polytechnic Institute in Tejgaon Industrial Area took to the street for about half an hour blocking Tongi

Diversion Road yesterday morning. They staged the demonstration demanding some changes in their examination system and curriculum.

2 lawyers to meet Quader Molla at jail

The International Crimes Tribunal yesterday allowed two lawyers to meet Jamaate-Islami leader Abdul Quader Molla at Kashimpur Central Jail in Gazipur next month.

Any two of the three counsels of Quader Molla will meet him between 9:30am and 12:30pm on February 3, 10 and 17 to discuss the case filed against him on charges of committing crimes against human-

The lawyers are M Tajul Islam, Farid Uddin Khan and Sajjad Ali Khan.

The three-member tribunal headed by its Chairman Justice Md Nizamul Huq passed the order after the detainee filed a petition on Sunday seeking permission in this regard.

Quader Molla, assistant secretary general of Bangladesh Jamaat-e-Islami, is among the six Jamaat and two BNP leaders who are facing trial in the court for committing crimes against humanity.

The prosecution on December 18 last year filed charges against him with the court. The charges include killing, looting and arson in the city's Mirpur and Mohammadpur areas and in Keraniganj during the Liberation War in 1971.

Ten days later, the tribunal took the charges into cognisance.

The court will hold hearing on charge framing against the accused on Sunday.

JU teachers demand punishment of former proctor

Draped in 'funeral clothes', the agitating teachers opposing the vice-chancellor of Jahangirnagar University (JU) yesterday brought out a procession and a protest rally on the campus to realise their demands.

They urged the university administration to meet their demands including punishment of former JU proctor Prof Arzu Miah for his alleged attack on the university teacher's association president, punishment of Zubair Ahmed's killers and restructure of the current committee to investigate into his murder, and cancellation of the appointment of unqualified teachers. Zubair, an English

department student, succumbed to his injuries after he was attacked by a group of Bangladesh Chhatra League activists on January 9.

30 injured as RMG workers attack police in Savar

At least 30 people, including an assistant commissioner and two constables of police, were injured yesterday when workers of a readymade garment factory attacked a police team in Savar.

Faizul Kabir, a deputy director of Industrial Police, told The Daily Star that a group of unruly workers of Hallmark Fashions Limited attacked policemen around 9:00am when the Savar land office, led by assistant commissioner (AC) (land), with the support of police knocked down a gate of the factory built illegally on its adjacent road.

The small group of policemen fired eight rounds of bullets in the air and took shelter in the nearby Tetuljhora School and College to flee the attack. The angry workers also attacked the school with brick

chips and bamboo sticks, injuring many students, teachers and policemen. Police Constable Muktar Hossain was admitted to

Remove illegal structures from 2 Madaripur temples

HC asks govt

The High Court yesterday directed the government to remove illegal structures from the temple premises in a village of Madaripur immediately to protect the religious place.

During hearing a rule, it ordered the deputy commissioner (DC) of the district to ensure that the people of Hindu community can perform prayers and religious festivals at Gopal Mandir (temple) and Kali Mandir at Palita village of Rajoir upazila without any hindrance.

The court also directed the DC and the superintendent of police to prosecute a Nirmal Kanti Halder of Palita under the criminal law for damaging the temples and cutting trees of their premises subject to investigation.

The HC bench of Justice AHM Shamsuddin Choudhury Manik and Justice Jahangir Hossain Selim also ordered the DC to submit a report on compliance of the orders to it by February 12.
