\$63m Japanese support

Japan will provide 63 million US dollar (5.04 billion yen) for improvement of maternal, neonatal and child health programme in Bangladesh.

To this effect, an exchange of notes was signed yesterday by Japanese Ambassador in Dhaka Shiro Sadoshima and Senior Secretary at the Economic Relations Division Iqbal Mahmood.

The loan agreement of the project was also signed between the senior secretary and Chief Representative of JICA Bangladesh Office Dr Takao

A Japanese ODA loan will be utilized for the "Maternal, Neonatal and Child Health Improvement Project-Phase I under the Health, Population and Nutrition Sector Development Programme (HPNSDP))," said a press release of the embassy of Japan.

'Have Bapex excavate gas fields'

Speakers at a human chain yesterday demanded that the government appoint Bangladesh Petroleum Exploration and Production Company Ltd (Bapex) instead of Russian company Gazprom for excavating the country's gas fields.

Bangladesh Poribesh Andolon (Bapa) organised the human chain at Picture Palace More of Khulna city where the speakers also demanded cancellation of the agreement with American company ConocoPhilips for excavation of the seashore's gas fields, as the agreement is 80 per cent export oriented.

The speakers said although the foreign companies were responsible for the explosions at Tengratila and Magurchara gas fields, they did not pay a single penny as compensation.

Advocate Firoj Ahmed, coordinator of Khulna division branch of Bapa chaired the programme while Prof Mohammad Majaharul Hannan, and journalist Sohrab Hossen also spoke.

Call to amend labour law

To bring an amendment to this law, although a trio- proposal, made by the labourers, owners and the government, had been placed to the labour ministry, it was not yet placed and passed in the Jatiya Sangsad, they said.

150 JnU students sued

The authorities of Jagannath University (JnU) filed a case against at least 150 students on Tuesday night in connection with Tuesday's violent clash between two factions of Bangladesh Chhatra League (BCL) on the campus.

Proctor Dr Kamal Uddin Ahmed filed the case with Kotwali Police Station, said Sub-inspector Mokbul Hossain.

Police is trying to identify the accused through video footages and photographs published in different media, the SI added.

Meanwhile, BCL central committee expelled 17 leaders and activists from the organisation for their involvement in the clash.

At least six activists were injured the clash between two factions of BCL on JnU campus, which halted vehicular movement on adjacent North-South Road for more than one hour on Tuesday.

'Sayedee escaped, concealed in a burka'

A prosecution witness yesterday told the International Crimes Tribunal that Jamaat-e-Islami leader Delawar Hossain Sayedee, veiled in a "burka", had escaped on a bull cart from a group of pursuing freedom fighters in Jessore.

Julfikar Ali, the 16th prosecution witness, was testifying under crossexamination yesterday in the case charging Sayedee with crimes against humanity during the Liberation War in 1971.

Julfikar said he took part in the war under Sector 8 Commander Major Manzur. Soon after the Liberation War, he and a group of freedom fighters went to Jessore's Bagharpara in search of collaborators, he said.

There they came to know that a person was hiding in the house of one Rowshan Ali, he said, adding that afterwards he even "saw the person with Rowshan in Bagharpara Bazar."

When "Commander Solaiman

Shaheb" gave the order, "we surrounded Rowshan Ali's house but failed to find Sayedee there. "When we asked for the person's

identity, Rowshan said the man was Delawar Hossain Sayedee. "Later we searched for him (Sayedee) and came to know that he

had fled on a bull cart wearing a burka towards Talbaria," said Julfikar. Afterwards, they came to know that Sayedee had come to Rowshan's house from Pirojpur and was

involved in rape, looting, arson and

torture during the Liberation War, he "I saw him (Sayedee) in 2005 or 2006 addressing a programme in Bagharpara. At the meeting he said, 'I would not have survived without Rowshan bhai's help'. He then called

Rowshan to the podium," said

Julfikar. When Julfikar finished his deposition, identifying Sayedee in the dock, defence counsel Mizanul Islam started his cross-examination.

Replying to a question, Jufikar said he had been involved with Awami League politics even before the Liberation War and was currently the general secretary of Bagharpara Upazila Awami League. Counsel Kafil Uddin Chowdhury,

replacing Mizanul, asked Julfikar whether he had heard of a book, "Muktijuddhe Jesseore", written by Rokonuddoula, the Jessore correspondent of Daily Sangbad. Julfikar said he had not.

"Do you know that Rokonuddoula mentions your name as a collaborator in this book?" asked Kafiluddin.

Julfikar said he knew of no such thing and it was not true.

With the tribunal's permission Julfikar said, "I was caught by Razakars (collaborators) after a weeklong battle and they peeled off my skin. One cannot be a Razakar if someone just says so in his book."

He added that he had been getting freedom fighters' allowance for many days.

The victim, Shamima Akhter, 32, employed in a garment factory, was murdered and cut up into four pieces by her husband, Mukul Hossain, 40, said police. Mukul was arrested by

police on January 22 after he gave inconsistent statements while filing a GD over Shamima's disappearance. During remand he revealed that he had murdered Shamima after a quarrel over his extramarital affair, said police.

Mukul yesterday showed police the spot on the canal where he had dumped a sack containing the body parts.

Ctg ghat workers call off strike

Chattagram Ghat and Gudam Sramik Sangram Parishad yesterday postponed their indefinite work abstention programme after getting assurance of a 20 percent increase in the wage of workers carrying bags to and fro the vessel and the store house from February 1.

The Parishad took the decision after a meeting with Chittagong Chamber of Commerce and Industry (CCCI) President MA Latif MP at CCCI in the port city.

The Parishad Convenor Mohammad Alamgir said the lighter vessels and store house owners assured at the meeting to increase the wage for carrying each size of bag by 20 percent from February 1.

For instance, according to the new wage chart, each worker will get Tk 9 for carrying a 90 kg bag, which was earlier Tk.7.50, he added.

He, however, said the work abstention programme would be continued in case the wage is not increased as promised from February 1.

Mentionable, the Parishad started their indefinite work abstention programme on Tuesday at 16 ghats of the Karnaphuli river to press home their nine-point demand including increasing the wage of workers.

BDR CARNAGE TRIAL

Heated debate over video footage

Defence and prosecution lawyers yesterday were locked in a heated debate over presenting a video footage at Metropolitan Session Judge's Court, Dhaka which is conducting the trial of the February 25-26, 2009 carnage in BDR's Pilkhana headquarters.

The video shows two of the accused, deputy assistant director (DAD) of the then Bangladesh Rifles (BDR) Towhidul Islam and signalman Salauddin, going to the prime minister's office to present their demands.

Prosecutor Mosharraf Hossain Kajol said they wanted to play the video as a witness, Nayek Tarun Kanti Roy, who gave his deposition and was cross-examined yesterday, identified the two from the video.

Tarun also identified Salauddin in a photograph taken during the mutiny, he added. The debate ensued when Kajol, with the

court's permission, asked the court staff to set up a temporary screen to play the video from a projector. The visibly agitated defense lawyers told

the court that they did not get a copy of the video. "We will not see it," said defense counsel Aminul Islam.

Aminul then stood up. Quoting section 9 of

the evidence act, he said, "He (Tarun) is not a seizure list witness (a person who documented the evidence during the incident). He cannot produce the video since he did not capture it." Kajol replied that they will produce the per-

screen while the arguments continued. The court, in the recording of the court proceedings, counted it as "the video and photograph of DAD Touhid and Salauddin". In his deposition, Tarun said he saw three

of the accused, nayek subedar Fazlul Karim, havildar Anisuzzaman and signalman Matiur Rahman, carrying Major Gazzali's body in a hessian over the road before Signal Sector around 11:30am on February 25, 2009.

Defense lawyer Faruk Ahammad, during the cross-examination, asked Tarun whether he knew that Major Gazzali's body was identified 10 months after the mutiny.

"I did not know that," replied Tarun. "You did not see them carrying the body," accused Faruk. That is not true, answered Tarun.
