### One strangled in Ashulia

The man might be a drug addict as some syringes were found near the place, said the police.

### TWO DHAKA DIST OFFICIALS Probe allegations

HC asks ACC

The High Court yesterday directed the Anti-Corruption Commission (ACC) to investigate allegations against two high officials of Dhaka Zila Parishad of misappropriating crores of state money in the name of expending it for development projects.

During hearing on two separate petitions, the court ordered the government to keep chief executive of Zila Parishad David Paul Khondkar Swapan and its assistant engineer Mokhlesur Rahman Hitler away from their offices during the investigation. Petitioner's counsel Manzill Murshid said that it has been

reported in the newspapers on different dates last year that David Paul and Mokhlesur Rahman have misappropriated around Tk 100 crore by showing "fake bills or vouchers" in the name of donation to different development projects.

Mizanur Rahman, a contractor, has filed the petitions recently with the HC seeking necessary orders in this regard.

The HC bench of Justice AHM Shamsuddin Choudhury Manik and Justice Jahangir Hossain Selim passed the order after hearing the petitions.

## Suspected Tahrir adviser discloses some names

Detained physician Golam Haider Rasul, who was arrested on suspicion of being a policymaker of banned Islamist outfit Hizb ut-Tahrir, yesterday reportedly disclosed names of doctors, teachers and businessmen involved in the organisation's activities.

He made the disclosure on the second day of a seven-day remand after being arrested by Rapid Action Battalion (Rab) from the capital's Uttara, said Habu Miah, sub-inspector of Uttara Police Station and investigation officer (IO) of the case.

Members of the elite force arrested cardiac surgeon of United Hospital Golam Haider on January 24 with leaflets and other publications of the banned organisation in his possession.

"Golam Haider has disclosed many names, which will assist us in arresting his accomplices including leaders, activists and financers of the Hizb-ut-Tahrir," said Habu Miah.

Haider mentioned some names including the names of doctors, teachers and businessmen, said the police officer.

The IO said Haider admitted his involvement in the banned organisation and that the doctor still believes in the organisation's philosophy of implementing Khilafat system in the state. Golam Rasul disagrees with Rab official

Golam Rasul, father of detained Golam Haider Rasul, disagreed with a remark made by a Rab official in a report published in The Daily Star on January 25 on the arrest of his son. In the report, Lt Col Ziaul Ahsan, chief of

Rab's intelligence wing, said that Golam Rasul said he himself supports the Hizb ut-Tahrir. In an e-mail on January 25, Golam Rasul denied the allegation and said, "I was never a

supporter or member of Hizb ut-Tahrir, I am not a supporter now, nor will I be one in future."

### **Textiles mill fined**

## Special body to thwart cyber crimes against country

**Bangladesh Telecommunication Regulatory** Commission (BTRC) launched a special body to thwart cyber crimes against the country and ensure national security.

The body, "Bangladesh Computer Security Incident Response Team (BD-CSIRT)", the first of its kind in the country, started working to this end on Wednesday.

"The BD-CSIRT is mainly assigned to identify the sites, persons or institutions engaged in harmful activities against the state, society and political and religious beliefs using mobile phones, websites and different social networking sites," said BTRC Chairman Maj Gen (retd) Zia Ahmed.

It will also recommend taking punitive measures against the offenders. In some cases, it will take action directly, after informing BTRC, as per the authority given by the telecom act, Zia told the news agency on Wednesday.

BTRC Director General (Legal and Licence) AKM Shahiduzzaman said a person five years of imprisonment and fines ranging from Tk 5 lakh to Tk 5 crore.

"The punishment would be handed down under Sections 69 and 74 of Telecommunication Act," he added. Three BTRC cyber crime experts, trained

abroad, have already started working in this regard, said Zia. He said the body, decided at a BTRC special

meeting on January 23, was formed as different kinds of value-added services like ebanking and e-ticketing are currently operational, requiring a strong security system. The 11-member body is headed by BTRC

Vice-Chairman Giasuddin Ahmed while the director of systems and services was made member-secretary. Other members are -- BTRC deputy direc-

tor of legal and licensing and representatives from International Internet Gateway, mobile phone operators, internet service providers, PSTN operators and cyber cafe associations.

Earlier, BTRC used to take action against the offenders whenever anybody filed a convicted of cyber crimes may face two to complaint, added Zia.

### Clarification

Mubasshar Hussain, president of the Institute of Architects Bangladesh (IAB), in a clarification to one of his remarks in the report "Building code violated" published on January 25, said an architect is not responsible for a building's structural failure.

He was quoted to have said the signatory architect is fully responsible for the overall supervision of an underconstruction building.

Hussain writes an architect is only liable for any failure/damage resulting from architectural design. In the reported incident, it was a structural failure, he adds.

He further writes, "Regarding the issue of an architect putting signature for obtaining approval from Rajuk but otherwise not having any relationship to the project, as per **Building Construction Rules** 2008 and ...the Code of Conduct of Ethics and Professional Conduct 2010 of the IAB clearly considers this as an unethical and punishableact".

# Concern over secret killing

Opposition Chief Whip Zainul Abdin Farroque and Workers Party President Rashed Khan Menon yesterday expressed concern with one voice over increasing instances of secret killing and disappearance in the country.

They spoke at an annual meeting of the Crime Reporters' Association of Bangladesh (CRAB) held at the Dhaka Reporters' Unity office.

Farroque described secret killings and forced disappearances as a new trend in crime during the incumbent government's rule.

Menon in his speech said secret killings had increased but Rapid Action

Battalion covered up such incidents by describing those as crossfire deaths. If the people having the responsibility

to maintain law and order make up stories, things will get even worse, he said. Of the 29 people disappeared

recently, the bodies of 16 were recovered, said Farroque adding that instances of imposing section 144 had also increased under this government. Expressing concern about the coun-

try's law and order situation, he said seven girls had been raped before their parents in the last three years of the

Awami League-led government. Referring to rights bodies' statistics, he said 365 journalists had fallen victim to torture during the period. Of the the policemen involved were not punished, rather they were given protection by the government. The workers party president,


