Gate Station of Pashchimanchal Gas Company Limited (PGCL) at Kharkhari area in the city.

"We are ready to start whenever the government gives the go-ahead," said Rezaul Karim, general manager (marketing) of PGCL.

Contacted, Rajshahi Mayor AHM Khairuzzaman said gas supply is likely to start in a month or two. The Tk 112 crore Rajshahi

gas supply project was approved by the Executive Committee of National Economic Council in July 2006. The expenditure was later revised to Tk 105 crore.

Although the project was initially scheduled to complete by June 2009, it took longer due to delay in release of funds and complexities related to installing gas pipelines in rivers. Finally it was completed last year.

Witnesses said Shafique was hit by a bullet when police, under attack, opened fire on the violent activists of Jamaat and Islami Chhatra Shibir around 4:45pm.

M Obaidullah, commissioner of Rajshahi Metropolitan Police, said they were yet to know how the man was killed. He claimed that police fired rubber bullets and shotgun shells only to scatter the rioting party men and that they had targeted nobody. "Moreover, the killing took

place when the law enforcers already started falling back,' he added. The RMP commissioner

also claimed that gunwielding Jamaat-Shibir activists fired at police.

Following the clashes, some 53 people were arrested from different parts of the city.

At least 19 policemen were injured as Jamaat-Shibir men hurled brick chips and lobbed cocktails, witnesses and RMP

The injured, including inspectors Tofazzal Hossain of Detective Branch and Khan M Shahriar of Boalia Police Station, were admitted to Rajshahi Medical College

officials said.

Yesterday, huge contingents of police were deployed at different points, including Saheb Bazar, Rajshahi College and Shah Makhdum College, in the city from 3:00pm as the four-party alliance was set to hold agitations.

Around 4:00pm, BNP leaders Mizanur Rahman Minu and Nadim Mostafa brought out separate processions from Lokhnath School and Rajshahi College points.

Police soon intercepted Nadim's procession while Minu and his men marched to Bhubon Mohon Park and held a rally there. Later at about 4:30pm, a big

procession of Jamaat and Shibir marched from Hatim Khan to Lokhnath School but was stopped by police at the northern corner of the school. Enraged, Jamaat-Shibir

men started pelting law enforcers with brick chips and stones. The area was engulfed in smoke as they exploded three cocktails.

The activists chased the cops twice up to the Rajshahi College point.

After reinforcement, police chased the Jamaat-Shibir men firing rubber bullets and teargas canisters.

At one stage, Shafiqul was found lying "unconscious" on the road and minutes later, a police van took him to hospital, witnesses said.

Shafiqul was seen throwing brickbats at police moments

before a bullet hit him, they The disturbances lasted til

filed a murder case with the Ashulia Police Station on January 9 mentioning names of three JU students --Ashikul Islam, Rashidul Islam and Khan Mohammad Rais -along with 10 to 12 unnamed students as accused. Police later arrested four

accused students based on information from the university probe committee. They are among the 13 students, who were expelled yesterday. The nine other expelled

students will also be included in the murder case, said the JU registrar.

On expiry of the two-year expulsion of the six students, the university authorities will decide their fate, he said.

The syndicate decided to provide Tk 2 lakh to Zubair's family and offer a member of his family a job in the university according to his or her educational qualification.

The syndicate also formed a one-member committee headed by Treasurer Prof Nasir Uddin to probe the alleged assault on the JU Teachers' Association president by former proctor Prof Arzu Mia.

Agitating university teachers, however, rejected the syndicate decisions saying that they are aimed at deceiving students and teachers.

Jagannath, Comilla and Jatiya Kabi Kazi Nazrul Islam. Once it is passed in parliament, these three universities won't have to bear the expenses including salaries and wages from their own funds after a certain period of time as per the existing law.

The cabinet also approved the draft "Money Laundering Prevention Act, 2012" keeping a provision of maximum 12 years of imprisonment as well as a fine of Tk 10 lakh or double the value of the property and a minimum four-year imprisonment for related offences.

It also endorsed drafts of the Anti-Terrorism (amendment) Act, 2012; the Mutual Assistance on Criminal Matters Act, 2012, and the National Efficiency Development Policy aiming to create skilled manpower.

If the mutual assistance act is passed in parliament, Bangladesh will get other countries' cooperation in repatriation of convicted criminals and brining back siphoned-off money. The country will also be able to ask other countries to return its convicted criminals holed up there and vice versa. This

handover could be done even without any bilateral extradition treaties in effect.

The cabinet also approved proposal for according a reception to the foreign heads of government and state, politicians, philosophers, artistes, litterateurs and writers in recognition of their outstanding contributions during the War of Liberation of Bangladesh in 1971. The reception would be accorded anytime between March 27 and April 30 instead of an earlier decision of March 26.

In the first phase, some 129 personalities from different countries including Argentina, Australia, Bhutan, Canada, Cuba, Denmark, Germany, India, Irish Republic, Italy, Japan Malaysia, Nepal, Poland, Russia, South Korea, Sweden, the UK, the US, Venezuela and Vietnam will be accorded reception.

Briefing reporters after the meeting, Cabinet Secretary M Musharraf Hossain Bhuiyan said the cabinet approved the proposal for extending the timeframe for holding DCC elections as the EC expressed its inability to hold the polls within the 90-day timeframe.

on Infrastructure to India and South Asia Dato' Seri S Samy Vellu made the offer during a meeting with Communications Minister Obaidul Quader at the Setu Bhaban in Mohakhali.

Samy Vellu, who is leading a seven-member delegation, handed over an offer letter to Quader. Malaysia earlier showed interest to finance the mega construction.

Companies from various countries, including South Korea, Indonesia and China showed their interest for the bridge construction after the \$2.97 billion project was stalled five months ago following allegation of corruption by leading financer World Bank.

Malaysia is the first country to make a formal offer in this regard.

"They are very keen to construct the Padma bridge. They made an offer to us and we have accepted it," Quader told reporters after the meet-"We will take decision

after scrutinising their offer," he said, reiterating that the government do not have much time to waste. "We want to start construction works of the long-cherished bridge within the tenure of the present government."

Meeting sources said

Malaysia offered financing for only the road bridge with two approach roads. The original design has both road

and rail bridges. "The government will go for an alternative financer to construct the bridge if the ongoing impasse with the World Bank is not removed in the next few months," said a senior communications ministry official, requesting anonymity.

In that case, he said, the government will go for the

Malaysian offer. At the talks with the communications minister, the Malaysian delegation also expressed their interest to construct a mono-rail in the city and an expressway between Dhaka and Chittagong.

The World Bank in August last year suspended its funding for the project on graft allegations. It recently extended the deadline for loan activation for the project by six months.

Meanwhile, Prime Minister Sheikh Hasina on Saturday asked the donor agency again to prove the allegation of corruption in the project, saying that the government will not accept its fund for this mega project unless it can establish the accusation.

Hospital sources said Bana Bhante breathed his last around 3:15pm at the intensive care unit.

Because of his spiritual power acquired through years of meditation in the deep forests of the hill district, local Buddhists consider him to be a living embodiment of the values of Lord Buddha.

He was born on January 8 in 1920 in Moghban union of Sadar upazila in Rangamati. His original name was Ratindra Chakma. He started meditation in

1950 and continued till he became ill. It is widely believed that he has never committed any crime and done any injustice to anybody since his boyhood. The Buddhist community

in Rangamati constructed the Rajban Bihar and requested him to take the helm in 1975. Bana Bhante wrote several

books about Buddhism
