Post-UP poll clash after 7 months

12 injured in Narail

At least 12 people were injured and three houses vandalised during a clash between two rival groups at Rampur village in Kalia upazila of the district yesterday morning.

Locals said the clash was a sequel to a previous rivalry between two groups--one led Alauddin Chowdhury and the other by Gazi Moniruzzaman Niamat--of the village.

Both contested for the post of Joypur Union Parishad (UP) chairman in the election held in June last year, but failed to capture the seat. Another candidate, Ayub Hossain, was elected, defeating the two.

Chowdhury beat up Nazir Ahmed, a cousin of Gazi Moniruzzaman Niamat, and ransacked his house.

As Niamat's men assembled at Nazir's house, Alauddin's supporters equipped with lethal weapons swooped on them, resulting in a clash between the two groups.

At least 12 people from both sides were injured and three houses vandalised during the clash that continued for two hours from 10:30am.

Being informed, police rushed to the spot, dispersed the clashing groups and brought the situation under control.

Sugar mills workers agitate for wage commission

Workers of four sugar mills in Thakurgaon, Natore and Jhenidah agitated yesterday demanding early declaration and implementation of wage commission.

Workers of Thakurgaon Sugar Mills demonstrated on the mill premises on Tuesday to press home their demand, reports our correspondent.

Suspending operation from 9:00am to 11:00am, over 100 workers of the mill brought out procession in front of factory. Parading entire mill area the procession ended in front of administrative building.

The programme followed a brief rally which was addressed by president of Thakurgaon Sugar Mills Workers' Union Jobaidur Rahman, worker's leader Masudur Rahman Rana and Saiful Islam.

The leaders urged the government to meet their demands for the sake of better life as the prices of essential commodities shot up in the last few months.

The workers of the mill will form a human chain and organise a workers rally on the mill premises today demanding the same, they said.

On Monday afternoon, workers of Panchagarh Sugar Mills observed the same

programme at their mill.

The workers of Natore Sugar Mill and North Bengal Sugar Mill also observed a two-hour work abstention yesterday morning demanding implementation of the wage commission, reports our Natore correspondent.

The workers started their work abstention at 9:00am and took position in front of their respective sugar mills in Sadar and Lalpur upazilas.

The agitated workers of Natore Sugar Mill burnt the effigy of finance minister and also demanded the resignation of finance, commerce and industries ministers.

After the two-hour agitation, the workers decided to observe a daylong strike on February 15 in case of no initiative at government level.

Khandakar Shahidul Islam, president of the North Bengal Sugar Mill Workers Association said, they will also observed a full-day work abstention on February 15 if their demand is not met within the time.

Workers of Mobarkganj Sugar Mills in Kaliganj upazila of Jhenidah also agitated for the same demand yesterday, reports our correspondent. They observed work abstention for two

hours and held a sit-in front of the office of mill MD.

2 Jasod Gonobahini men arrested with firearm

Arms recovered in 3 districts

Rapid Action Battalion (Rab-6) arrested two alleged members of Jasod Gonobahini, an underground party, from Mirzapur village under Shailkupa upazila early yesterday.

The arrestees are Amirul Islam alias Babul Joarder, 50, son of Abdul Goni Joarder of Mirzapur village and Roman Joarder, 27, son of Golam Nabi Joarder of the same village.

Commanding Officer Captain M Ashraf Ali of Rab-6 in Jhenidah said, on a tip-off, a Rab team led by commander himself launched a drive at Mirzapur village under Shailkupa upazila and arrested the active members of Jasod Gonobahini. They also recovered a shuttergun and a bullet from their possession.

They were holding a secret meeting at

Amirul's house at the time of raid, he said. The rest of the cohorts of Amirul manage to flee, the commander added.

In Gaibandha, Rab-5 in a drive recovered two firearms and ammunitions from village Bishawnathpur in Gobindaganj upazila early yesterday, reports our correspondent.

A team raided the houses of Fazlu Prodhan and Chinu Prodhan in the village and recovered a country-made revolver, a .22 gun, one magazine, five 7.62 point bullets, four 303 rifle

College girl gangraped

Rapid Action Battalion (Rab) on Sunday night rescued a schoolgirl from Bhatoi Bazaar under Shailkupa upazila and arrested three people in this connection.

The arrestees are Eliyas Hossain, 45, son of Bholai Chowdhury of Bhatpara village under Kaligonj upazila, Motiar Hossain, 38, son of Hanif Biswas of Bhatoi village under Shailkupa upazila and Mortuza Hossain, 23, son of Abdul Mojid of the same village.

They allegedly abducted the 7-year-old schoolgirl of a resident of Dudshar village under Shailkupa upazila. The victim is a student of class two at a primary school.

According to the mother of the girl, the accused lured the minor girl with sweets at a religious meeting at the village. Finding her nowhere they informed Rab and the elite force

rescued her daughter from Bhatoi bazaar. In Bagerhat, a 22-year old college girl was gang raped at Chitalmari on Monday. Police sent the victim to Bagerhat Sadar

Hospital for medical examination, Chitalmari police station officer in-charge (OC) Hasan Hafizur Rahman told our correspondent.

The rape victim has filed a case against three people under Women and Children Repression Prevention Act, the OC said.

Police could not arrest any of the culprits so far. The victim passed HSC exam last year.

The victim told this correspondent that there was a longstanding dispute between her family and the accused over a piece of land.

Accused Obaidul Fakir used to stalk her on her way to college, she said. "As I did not respond to the indecent

proposals he along with his cousin Abu Bakar raped me," the victim said.
