The BNP was scheduled to bring out mass processions on Sunday (January 29) across the country, but the government imposed a ban on rallies and gatherings in Dhaka and other metropolitan cities for Sunday. On January 26, the ruling party's city unit called a rally for January 29, which also created tension in the political

Complying with the ban, the BNP rescheduled its procession programme to Monday (January 30). For its part, the Awami League also postponed its rally.

Interestingly, the ruling party once again called a rally for Monday, with the pro-Awami League youth organisation Juba League announcing a human chain for the day.

The BNP on Sunday brought out processions in all districts since there was no ban on processions there. But police resorted to gunfire on the processions in Chandpur and Laxmipur that left four people dead. On Monday, a Jamaat-e-Islami man was killed in Rajshahi during a clash with police.

The situation went against the government when police fired on opposition processions and obstructed scheduled processions in the cities by imposing bans, observed BNP high-ups who did not wish to be named.

"In fact, the last few days' events reflect the government's overall failure to run the country. So, it is natural people's support will come towards us," RA Gani, senior member of the BNP standing committee, told The Daily

He said it seemed that the government was deliberately trying to trigger a conflict, "but people do not like it and that is why everything, whatever the Awami League did in the last couple of days went against the Awami League".

"They [the ruling party] wanted to foil our mass processions but people rejected the attempt by making the programme successful across the country," he said. He noted that the people appreciated the BNP's decision to defer the date for bringing out the processions while the Awami League was highly criticised for coming forward with programmes to counter the opposition.

before India was partitioned by the British colonial administration into two independent states, several leading Muslim scholars rather inexplicably suggested that Urdu be the lingua franca of the new state. That view was, however, opposed by reputed Bangalee scholars, whose view was that since the Bangalees of Pakistan's eastern wing would constitute the majority segment of the country's population, it was only proper that Bangla be adopted as the language of the state. For his part, Dr Muhammad Shahidullah, writing in the daily Azad published from Calcutta, stated that having Urdu as the only language of the state and pushing Bangla into the sidelines would only undermine the interests of the Bangalees of

Pakistan. The demand for Bangla as the state language of Pakistan received a boost when Abdul Haq put forward some strong arguments in its favour through published articles in June and July 1947. And then came the weekly Millat, edited by Abul Mansur Ahmed, where the logic behind Bangla being the language of the Pakistan state was put across editorially. Similar arguments in favour of Bangla were making it clear that while the Bangalees were prepared to accept Pakistan as a country for themselves, they remained focused too on the thought that their cultural traditions could not be trifled with. Abul Hashim spoke loud and clear, through the election manifesto of the Muslim League in 1946, on the issue of Bangla being the language of the state that was about

Once Pakistan came into being on 14 August 1947, a rising crescendo of voices added new force to the demand for Bangla as Pakistan's lingua franca.

Hasina and meet his Bangladeshi counterpart Dipu Moni in the first highlevel meeting between the two nations since Indian premier Manmohan Singh's visit to Dhaka in September last year, sources said yesterday.

Krishna is to convey to Bangladesh that India is hopeful of overcoming the political complexities that have clouded the implementation of two key decisions -- the Teesta river water-sharing agreement and ratification of the agreement on exchange of adversely held enclaves and land boundary demarcation.

The West Bengal state government headed by Mamata Banerjee has opposed signing the treaty on water sharing and voiced reservations against exchange of the enclaves falling in the state.

The main purpose of Krishna's visit is to reassure the Bangladeshi leadership that efforts are well underway to forge a consensus in India on the two issues.

There has been disappointment and disquiet in Bangladesh over the stalemate on these two issues and the reported objections of Trinamool Congress to them.

Krishna will contend during his visit that although the Congress-led UPA government can - under the Constitution - assert its authority to go ahead unilaterally on foreign policy issues, but since it has a coalition government, it would like to proceed on the basis of a consensus by all coalition partners, sources

The external affairs minister is expected to impress on Dhaka that the process of evolving a consensus in a coalition government like in India takes time. He will be reassuring his counterparts that this should not give rise to misgivings about India's intentions.

Kamaruzzaman operated in Mymensingh, Jamalpur, Tangail and Sherpur areas during the Liberation War of Bangladesh in 1971, according to the charges.

The three-judge tribunal headed by Justice Md Nizamul Huq yesterday directed prosecution to submit copies of the formal charges against Kamaruzzaman and other relevant documents to the tribunal's registrar by February 6.

It also asked defence to collect copies of the charges from the registrar's office on February 7 so that it could prepare for the legal battle.

The court said it had taken the charges against the Jamaat leader into cognisance after examining the formal charges, probe reports and documents submitted by the prosecution and seeing enough preliminary evidence for a trial.

On December 28 last year, the tribunal sent the formal charge against Kamaruzzaman back to prosecution as the charges were not classified and organised properly.

After the court passed the order yesterday, Prosecutor AKM Saiful Islam told reporters that Kamaruzzaman, chief organiser of Al Badr Bahini (collaborators' force), was in charge of executing the plan of the Pakistani armed forces operation Search Light on the night of March 25, 1971.

Kamaruzzaman personally took part in operations at many places during the LiberationWar, he said.

Defence counsel Tajul Islam told reporters the case had been filed against Kamaruzzaman in order to harass him. He was not, said the lawyer, involved in any crimes against humanity committed during 1971.

Kamaruzzaman is among six Jamaat leaders, including its former chief Ghulam Azam and two BNP leaders, facing war crimes charges before the court. All of them have been arrested and one of them is on bail.

"Media in the countries competing with us prominently display the pictures of people lying dead on the streets and also report that there is no congenial environment for investment in Bangladesh," said AK Azad, president of the apex business body.

"Investment will face a setback if there is no stable political situation in the country. As a result, no local businesses will invest, let alone foreign investors," he said, adding the confrontational political situation will affect the growth of gross domestic product (GDP).

The top business leader made the remarks at the concluding ceremony of the month-long 17th Dhaka International Trade Fair at Sher-e-Bangla Nagar in the capital. His remarks came a day

## Air raids on Qaeda bases in Yemen

Air raids struck al-Qaeda elements in southern Yemen overnight and killed 15 people, including a long-hunted militant leader, tribal chiefs said, adding that extremists responded by killing two soldiers yesterday.

The four Monday night raids were "carried out by US planes," according to a local military official who spoke on condition of anonymity They hit targets in the Loder and Al-Wadih areas of Abyan province, a tribal chief said.

Al-Qaeda militants control much of the province after taking advantage of months of political turmoil, which has forced President Ali Abdullah Saleh to agree to step down next month, to overrun swathes of the south.

Three of the raids targeted a school in which al-Qaeda fighters and chiefs of local militant network were meeting around midnight, the sources said.
