# Now tree felling fest by UP member and co

Over 100 roadside trees cut down in Narail

A union parishad member and his men cut down at least 100 roadside trees in Baoisona union under Kalia upazila of the district in the last two weeks.

Locals told this correspondent yesterday that Sahadat Hossain, a member of Baoisona Union Parishad (UP) in collusion with UP Chairman Mohammad Forkan Molla and local LGED staff felled at least 100 trees along Boisona-Nolamara-Jugania road and sold them to others.

Md Nazrul Islam, 60, of Baoisona village said member Sahadat and his men felled some roadside trees in presence of Golam Kudus, an employee of Kalia LGED office, a week ago. "Sahadat told me that he bought the trees at an auction at Kalia LGED office and sold them to others," Nazrul said.

Mukul Hossain, 32, a farmer of Dumuria village under Baoisona union, said he saw Sahadat member and Syed Mollah, a timber trader of the area, and their men cutting down the roadside trees five days ago.


Muradul Islam, a member of Ward No 3 of Baoisona Union, said a gang of criminals felled the tress and took them away. He declined to say anything

union land office, seeking anonymity said UP member Sahadat, Chairman Forkan and upazila LGED office staff were involved in felling the trees. "Though Naragati Police Station is only 5-km off the spot, police did not take any action," he added.

Refuting the allegation of his involvement, UP

Chairman Forkan said he knew nothing about such heinous act. Despite several attempts, this correspondent could not talk to member Sahadad as his cellphone An employee of Boisona remained off.

## Rail barricade for express train

Locals put up barricades on rail tracks at Rohonpur Railway Station under Gomostapur upazila of Chapainawabganj district yesterday morning demanding 'Mohananda Express' train service from the station.

A Rajshahi-bound local train, which was scheduled to leave Rohonpur station at 7:15am, remained halted at the station for six hours, causing sufferings to the commuters.

The Mohananda Express train runs between Chapainawabgabj and Khulna via Amnura.

demanding the express train service Alam Bachhu and Rohonpur municifrom Rohonpur instead of Chapainawabganj. To meet the demand, Railway West Zone on January 26 sent a letter to Rohonpur station, saying that Mohannanda express train will run between Rohonpur and Khulna

from February 3. As locals did not see the express

train at Rohonpur station yesterday morning, they became agitated and put up barricades on rail tracks.

Rohonpur people had long been Upazila Parishad Chairman Khurshed pality Mayor Golam Mostofa reached the spot at around 1:00pm.

They assured the locals that they would immediately sit with the railway authorities to discuss the issue. Following the assurance, the agitating people withdrew the barricades at around 1:30pm.

#### Deed writers in Sylhet confine sub-registrar for demanding bribe

A few deed writers yesterday kept the sub-registrar of Sylhet Sadar confined to his office for two and a half hours as he allegedly demanded bribe from them.

Police later freed the sub-registrar, Gazi Abu Hanif, and escorted him out of the office at 4:30pm. Hanif was also temporarily relieved of his duty.

Mainul Islam, general secretary of the Sylhet divisional chapter of Deed Writers Association, alleged that Sub-Registrar Gazi Abu Hanif yesterday declined to sign a few deeds, although those were prepared and produced before him rightly.

As he demanded Tk 5,000 for each power of attorney and Tk 10,000 to one lakh for sale deeds, the deed writers locked in a heated exchange with the official, Mainul said.

At one stage, the writers supported by clients kept him confined. On information, district Registrar Anwar Hossain brought police who freed the sub-registrar and arranged his departure from the office.

The district registrar also brought Sub-Registrar Ahsanul Habib from Jaintapur upazila who registered the pending deeds yesterday. Contacted, Anwar

Earlier, over a hundred students brought out a procession to realise their four-point demand including amendment to Polytechnic Act, 2010 on the campus.

At one stage, they threw brickbats and ransacked the academic building, vandalised its windows and residence of the principal.

During the attack, the general students ran helter- skelter for safety.

On information, a police team from Patuakhali police station rushed to the campus and brought the situation under control.

We are boycotting our classes since Tuesday as part of the countrywide programme, said a student.

Contacted, engineer Zakir Hossain, principal of the polytechnic institute said that the students, at a meeting in the evening, assured him that in future they would observe all their programmes peacefully on the campus.

## Tigers kill four in 3 days in Sundarbans

Tigers killed at least four people on Monday, Tuesday and Wednesday in the Sundarbans in Khulna and Satkhira districts.

The dead were identified as Khalilullah Gazi, 32, son of late Sattar Gazi of Mathbari village, Rahmat Ali Gazi, 60, son of late Mohor Ali Gazi of Sathalia village and Abdul Majid, 35, son of Abul Kalam Biswas of Kalna village under Koira upazila in Khulna and Kawser Ali Moral, 52, son of Mohammad Ali Moral of Jatindranagar village in Shyamnagar upazila of Satkhira.

On Monday at 3.00p.m. bawali (woodcutter) Rahmat Ali was killed by a tiger near Nalbunia canal of the forest. Forest guards recovered his body at about 5:30 p.m. on the same day from deep forest.

The second death occurred on Tuesday morning when Khalilullah Gazi was attacked by a tiger

while cutting golpata leaves of a tree near Marki canal in the Sundarbans.

At 5.00 p.m. on Wednesday, bawali Abdul Majid was killed in the same area by a tiger. His body was recovered in evening by forest guards from inside the forest.

Three separate UD cases were filed in this connection with the Koira Police Station.

Sundarbans DFO Zahiruddin said a tiger attacked Kawser and dragged him inside the deep forest while he was catching crabs with the permission of the Forest Department at Babhakhali canal on Tuesday evening.

On information, Forest Department members rushed to the spot and recovered his body.

Zahiruddin said that the tigers have become aggressive more than before because of losing their habitats due to mindless felling of trees, increase of poachers and severe food crisis.

#### Bid to set Pabna BNP leader's house on fire

Locals foiled an alleged attempt to set fire to the residence of Engineer Habibur Rahman Tota, general secretary of the newly formed Pabna district unit of BNP, at Shibrampur in the town on Wednesday night.

Tota claimed that unidentified criminals threw petrol on the corridor and set fire. Family members with the help of locals extinguished the blaze, he said.

The BNP leader said he was busy with organisational activities in another area of the town during the incident. District BNP president KS Mahamud condemned the attack on the house and demanded immediate arrest of the persons involved.
