

Govt to improve TCB capacity

GM Quader tells parliament

UNB, Dhaka

Commerce Minister GM Quader yesterday informed the parliament that the government is taking steps to improve the capacity of Trading Corporation of Bangladesh (TCB) to intervene in the market more effectively.

"We are going to build a new godown in Chittagong with 40,000 metric ton capacity and also increase the number of authorised dealers up to 5,000," he said replying to a supplementary question of treasury bench lawmaker Shafiqul Islam.

The minister said the state-run TCB was about to be abolished during the previous government's tenure. "The present government, after taking the office, decided to revive the TCB to intervene in the market for the welfare of the common people."

Market monitoring is the prime duty of his ministry, he said.

Responding to another question of Monirul Islam (Barisal-2), Quader said due to the capacity constraints it was not possible for the TCB to intervene in the market to a great extent.

About the price hike of essentials, he said Bangladesh is a country of free market economy. The government cannot provide all essential items for the people at subsidised rates.

"From my ministry, we are trying to monitor closely to make the market stable," he said.

Replying to Jatiya Party lawmaker Ziaul Haque Mridha (Brahmanbaria-2), the minister said in the near future, the government would be able to provide services through TCB in all upazilas.

17 killed, 68 injured in road crashes

Seventeen people were killed and another 68 injured in road accidents in nine districts yesterday and Sunday.

The districts are Dinajpur, Sirajganj, Chittagong, Pabna, Comilla, Tangail, Noakhali, Rangpur, and Natore. Our Dinajpur correspondent

says: Five people were killed and 35 others injured in two accidents in Phulbari and Chirirbandar upazilas of the district yesterday. In Phulbari, a Dinajpur-bound

bus hit a roadside tree after one of its wheels broke loose at Kurail, killing three unidentified persons and inuring another 35. Twenty of the injured, six of them

critically, were taken to Dinajpur Medical College Hospital, said Biman Karmakar, an assistant superintendent of police (Phulbari circle).

In Chirirbandar, a loaded tractor hit an oncoming crowded rickshaw van on Ranibandar-Khansama road at Chander Dah village, killing a minor boy and a woman yesterday.

The woman aged around 28 died on the spot while the boy of about 8 years of age succumbed to his injuries in Dinajpur Medical College Hospital.

Our Sirajganj correspondent reports: A bus plunged into a roadside ditch at Jhaoil in Kamarkhanda upazila early yesterday, killing three passengers including a woman and her daughter on the spot. The deceased were Mofizuddin,

60, of Hatibandha in Lalmonirhat, Momota Khatun, 24, wife of Nazrul Islam of Islampur upazila in Jamalpur, and her daughter Nausin, 4, said Aslamuddin, a sub-inspector of Bangabandhu Bridge West Police Station.

The injured passengers were

taken to Sirajganj Sadar Hospital.

Our Chittagong correspondent says: Two garment factory workers were killed and two others injured as a city bus ploughed into a crowd of waiting passengers in Pahartali of the port city yesterday morning.

Dulali Dey, 40, and Lucky, 22, were declared dead in Chittagong Medical College Hospital (CMCH) while the injured were under treatment there. All of the victims, who were work-

ers of Gaus Fashion Industries Ltd, were waiting for a bus at Pahartali, said Zahirul Islam, in-charge of CMCH police outpost. Our Pabna correspondent

reports: A bus overturned on Pabna-Sujanagar road at Kalidoho yesterday, killing its helper and injuring 10 passengers. The dead was Abul Kalam, 30.

Pension of two judges

HC asks govt to explain

The High Court yesterday asked the authorities concerned to explain in two weeks why they should not be directed to pay pensions to two retired Supreme Court (SC) judges.

Justice Mohammed Mumtaz Uddin Ahmed of the Appellate Division retired on December 31 last year and Justice Md Abdul Hye of High Court (HC) Division retired on December 14 the same year. The two judges, who were not confirmed like nine others

during the regime of the BNP-led four-party government

despite the chief justice's positive recommendations, were

reappointed as regular HC judge on March 24, 2009, as per an SC verdict. Justice Mumtaz was promoted to the Appellate Division on May 16 last year. In response to two separate writ petitions filed by the retired judges, the HC yesterday issued two separate rules upon the government and the SC authorities to explain why

they should not be directed to take effective steps to pay the pension of the petitioners. Secretaries to the ministries of law and finance and SC

registrar have been made respondents to the rule.

The HC bench of Justice AHM Shamsuddin Choudhury Manik and Justice Jahangir Hossain Selim also fixed February 17 for holding hearing on the rules.

Petitioners' counsel Manzill Murshid told The Daily Star that his clients had submitted two separate applications to the chief justice on different days of January this year to take necessary steps so that the government authorities could pay their pensions.

But the retired judges did not receive any reply from the office of the chief justice, he said.

Manzill said it was apprehended that the authorities were not paying pension to the retired judges on the ground that the tenure of their continuous service did not complete seven years which is necessary for payment of their pension as per provision of Supreme Court (Leave, Remuneration and Pension) Ordinance 1982.

EC sectt asked to make road map for next elections: Sakhawat

The Election Commission (EC) has asked its secretariat to prepare a full-fledged road map for the next parliamentary polls, Election Commissioner M Sakhawat Hossain said yesterday.

"The 10th parliamentary election is just one and a half years away but by this time the new EC has a lot to do. That is why, we have directed the secretariat to start preparing a work plan," he said.

The tenure of Chief Election Commissioner (CEC) ATM Shamsul Huda and Election Commissioner Muhammed Sohul Hussein expired Sunday while Election Commissioner M Sakhawat Hossain is to retire on February 14.

The search committee formed to recommend names for the new chief election com-

missioner and election commissioners is expected to submit its report to President Zillur Rahman today.

Talking to reporters at his EC secretariat

office, Sakhawat Hossain yesterday explained the EC reform proposal that sought control over the cabinet division and the ministries of home affairs, public administration and the LGRD during general elections. According to the proposal, during the gen-

eral elections the cabinet division and the three ministries will have to consult with the EC before making any election related decision. Sakhawat Hossain said the EC had drafted

the proposal in light of the experiences gathered during the last caretaker government.

Meanwhile, the EC secretariat yesterday

sent the law ministry a set of proposals on electoral reforms.
