exempts the prime minister, ministers, state and deputy ministers from paying taxes on their remuneration.

Criticism has been raging against the provision, with the demand that such provisions be repealed. But lawmakers did not pay heed to it and instead have been enjoying the "discriminatory" benefits for around 38

The original law, Members of Parliament (Remuneration and Allowances) Order of 1973, did not exempt MPs from taxes on their remuneration. But the then government in 1974 amended the law by introducing the "discrimina- Act, tory" provision. The speaker, deputy speaker, prime minister, ministers, state ministers and deputy ministers were also exempted from paying taxes on their salaries and remuneration with the introduction of a similar

legal provision. Eventually, the AL-led government moved to scrap the provision, termed "discriminatory" by Law, Justice and Parliamentary Affairs Minister Shafique Ahmed, who placed the two bills in the House on Monday.

Bangladeshi's income above a certain limit is taxable. So there is discrimination between the common people and the MPs regarding

taxation," the law minister said in his brief statements tagged with copies of the

The statement does not reflect the law minister's personal opinion; It rather reflects the position of the Sheikh Hasina-led cabinet which on November 28 last year approved the proposals for amending the laws, thereby making it mandatory for the speaker, deputy speaker and MPs to pay taxes on their remuneration.

Ten days earlier, on November 17, the cabinet also endorsed proposals regarding amendments to the Prime Minister's (Remuneration and Allowances)

1975 and the Ministers, Ministers for State and Deputy Ministers (Remuneration and Privileges) Act, 1973 to make it mandatory for the prime minister, ministers, state ministers and deputy ministers to pay taxes on their remuneration.

The AL-led government however remains silent about the "discriminatory" provision that allows MPs to import duty free cars. The original law of 1973 did not contain such a provision. It was introduced on May 24, "Usually any 1987, during HM Ershad's rule, to give MPs undue benefits as a way of making them happy and ensuring their loyalty to the then autocratic regime.

democracy after the fall of Ershad in 1990, MPs in all parliaments since 1991 have been enjoying the benefit of importing one vehicle during his tenure without having to pay customs duty, sales tax, development surcharge and import permit fee.

This provision was abused by MPs in previous parliaments. For instance, in the last parliament, lawmakers imported over 275 luxury vehicles, thus depriving the state exchequer of Tk 280 crore in taxes. Taxes for most of the cars ranged between 73.91 and 196.10 percent, media reports said quoting NBR officials.

Many legislators of the eighth parliament sold their luxury cars--- BMWs, Cadillacs and Porsches--though the laws did not permit so within three years of purchase. For personal use, they preferred inexpensive and cheap-to-run cars. The army-led joint forces seized a number of those luxury cars from businessmen during the past emergency regime. And in the wake of gross abuse, the provision was scrapped

government through an ordinance promulgated by the president in 2007.

But the current parliament, did not, however, ratify the ordinance. It of MPs?

Since the restoration of restored the provision in April 2010 to allow MPs to import vehicles free of duty. The matter did not end there. A new provision was inserted in the law to provide each MP with transport allowance of Tk 40 thousand per month. And, interestingly, the provision also allows the prime minister, speaker, deputy speaker,

ministers, state ministers, deputy ministers, chief whips and whips to enjoy the benefit.

Since the restoration of the provision, a total of 310 MPs of the current Parliament applied for importing duty free vehicles and 273 of them imported vehicles until January 19 this year, according to information available in the parliament secretariat.

None of the country's citizens, excepting MPs, is entitled to enjoy the benefit of importing vehicles free of duty, although one of the fundamental rights guaranteed in the constitution ensures that all citizens are equal before the law.

In light of the law minister's statement, one may raise some questions. Isn't the provision that allows during the past caretaker MPs to import vehicles free of duty "discriminatory" between MPs and other citizens? And doesn't the provision raise questions about the sense of decency

Although the election is non-partisan in nature, Jatiya Party and Jatiya Samajtantrik Dal--two components of the ruling Awami League-led alliance--have already announced the names of leaders who will get party support in the polls to the DCC North and DCC South.

The Awami League did not announce the names of any leaders to be blessed by the party.

However, Haji Selim, joint secretary of Dhaka City unit of Awami League, and Sayeed Khokon, organising secretary of Dhaka city unit of Awami League, are campaigning for their candidacies in DCC South. Both of them expect that the party will extend its support to them.

Talking to The Daily Star recently, Selim and Khokon said they were relentlessly conducting public relations.

"The party has met the expenditure for the printing of posters," Prodhan told The Daily Star.




