Eight state-owned Jute Mills in Khulna-Jessore industrial belt face financial crisis due to drastic fall in sale of jute products in the last six months.

Source in Khulna zonal office of Bangladesh Jute Mills Corporation (BJMC) said Jute goods worth about Tk 336 crore have remained unsold in the warehouses of the mills.

They said jute goods worth Tk 70 crore of Crescent Jute Mill, Tk 75 crore of Platinum Jute Mill, Tk 65 crore of Khalishpur Jute Mill, Tk 40 crore of Jessore Jute Industries, Tk 24 crore of Eastern Jute Mill, Tk 19 crore of Aleem Jute Mill, Tk 13 lakh of Carpeting Jute Mill and Tk 30 crore of Star Jute Mill are lying unsold in the warehouses of the mills.

Apart from the present financial condition of the eight jute mills, four major industries in Khulna are still waiting for reopening.

These are Khulna Newsprint Mill, Textile nearly 300 workers and employees out of jobs. Mill, Daulatpur Jute Mill and Khulna Hardboard Mill.

Daulatpur Jute Mill was closed down on December 7 in 2009, throwing over 2,000 workers and employees out of jobs. The authorities shut down the mill on ground of severe financial crisis. The jute mill needs Tk 65 crore for reopening.

The mill is expected to reopen next month as 90 percent of its maintenance work has already been completed, claimed Project Director Monowar Hossain.

Khulna Hardboard Mill was shut down on December 15 in 2002 and reopened on September 14 in 2005. But the authorities concerned closed the mill again in July last year due to severe financial crisis, throwing

Mysterious death

Mystery shrouded the death of SSC student Mizanur Rahman, son of Idris Pada of Sabujbagh area in the district town.

Quoting family members, police said Mizanur was reading in his room Wednesday evening while other members of the family went to a nearby residence for watching a TV programme.

Morium Begum, mother of the victim, entered the house at about 9:00pm and found the body hanging from the ceiling of the room.

Morium said earlier, some local youths forcibly brought an unidentified boy into their residence at around 5:00pm and beat him up mercilessly.

The youths then gave Mizanur death threat as he protested the assault, she added. She alleged that the gang killed her son following the incident.

Md Monirul Islam, officer in-charge of Patuakhali police station, said criminals might have strangled Mizanur and hung his body from the ceiling of the house.

Huge quantity of jatka seized from 4 launches

Current nets destroyed in two districts

Coastguards seized around 160 maunds of jatka (hilsa fry) from four launches in Dhaleshwari River in Sadar upazila of Munshigan yesterday morning.

Acting on a tip-off, a team of coastguards intercepted the Dhaka-bound MV Panama, MV Zahid-3, MVTipu-2 and MV Prince of Shohag and recovered the hilsa fries. None was arrested in this connection, reports UNB.

Station Commander Ferdous Ahmed said the jatka will be sold at an auction in presence of Sadar upazila fisheries officer M.A. Azad and the money will be deposited to the government exchequer.

The government has banned catching of jatka from February 1 to May 31.

In Rajbari, a mobile court seized current nets worth Tk. 7 lakh from different areas of Goalunda upazila yesterday.

The mobile court, led by Md. Golam Zakaria, executive magistrate of Rajbari collectorate office, recovered the nets from several parts of the Padma River in separate drives, reports our Manikganj correspondent.

The mobile court burnt the seized current nets at Daulatdia launch ghat at around 2:00pm.

The mobile court also arrested two fishermen -- Akkas Ali, 30, and Chand Khan, 50, of Char Delondi village under Debgram union of the upazila and fined Tk. 1,000 each for catching fish illegally.

All because of bringing corruption charge

A female teacher of Dighinala Model Government Primary School in Dighinala upazila of the district was hospitalised as she became senseless following alleged verbal assault by headmaster of the school on Tuesday. Headmaster Chandra

Kumar Chakma hurled abuse at Geeta Chowdhury, 48, an assistant teacher of the school, at his office room on Tuesday to vent out his wrath following a recent corruption allegation made by all the seven assistant teachers of the school against the headmaster, said the colleagues of Geeta.

As Geeta fell senseless, she was rushed to Dighinala upazila health complex where the on-duty doctor referred her to Khagrachhari Adhunik Sadar Hospital in the evening, they added.

"The headmaster called me to the office room at around 2:30pm of Tuesday. As soon as I entered the room he started seriously scolding me, apparently in reaction to the corruption allegation against him. At one stage I became senseless," a tearful Geeta told this correspondent at Khagrachhari Adhunik Sadar Hospital. She demanded exem-

plary punishment of the headmaster.

"Geeta became senseless due to the serious mental pressure. She needs complete rest for a week," said Sanjib Tripura, resident medical officer of Khagrachhari Adhunik Sadar Hospital.

Nilima Tripura and Sirajul Islam, assistant teachers of Dighinala Model Government Primary School, said the headmaster misbehaved not only with Geeta, but with all the teachers and tried to harass them in different ways after they submitted the corruption allegation to the district primary education officer

on January 9. Contacted, headmaster Chandra Kumar Chakma denied the allegations and said Geeta was hospitalised due to her physical illness.

District Primary Education Officer Md Nurul Islam said, "The allegations against the headmaster have been primarily found true. Stern action will be taken after investigation."

Man murdered in Chuadanga
