Two killed in stampede

Two devotees were killed in a stampede at an annual Urs (religious congregation) of 'Bishwa Oli Khwaja Baba Faridpuri Darbar' at Atroshi in Sadarpur upazila yesterday. The victims are Sufia Begum, 55, of Bashulikandi village and Amena Khatun, 60, of Char Kasem Nagar village in Narsingdi district. The incident took place at around 2:00pm at the western side of the main gate in the three-day Urs, where thousands of devotees gathered to attend the Akheri Monajat (concluding prayers), said police. The stampede occurred when people were trying to come out from the gate at a time after offering the prayers.

Man jailed for stalking

A mobile court sentenced a man to twenty-eight day imprisonment for sexually harassing a female student in Nachole upazila town on Monday. The stalker is Monirul Islam, 40, son of Nazrul Islam of Kaloir village in Nachole upazila. Nachole police said, Monirul used to tease the girl on her way to coaching centre for long. On information, police arrested the stalker from Nachole Bazar in the evening and produced him before the court.

BSF returns boy

Indian Border Security Force (BSF) returned a boy yesterday, four hours after his capture following a flag meeting with Border Guard Bangladesh (BGB) at Shingnagar frontier in Shibganj upazila. The boy was identified as Mohammad Babu, 12, son of Abdur Rakib of Tarapur Morolpara village. Lt. Col. Jahangir Hossain, commanding officer of 39 BGB Battalion, said Babu mistakenly entered Indian territory near main pillar no 168 at around 11:00am while cutting grass. BSF men then detained him.

One held with arms, ammo

Police arrested a suspected member of a criminal gang along with two US made pistols, eight bullets, a mobile phone and Tk 5000 from a house at Abadchandipur village in Shyamnagar upazila early yesterday. The arrestee is Md Jalal Gazi, 25, son of Arshad Ali Gazi of Pankhali village. Quoting villagers, Hashem Khan, officer in-charge of Shyamnagar police station, said Jalal along with his two cohorts, including the gang leader Abdul Majid, came to the residence of his father-in-law Liakat Molla at the village. On suspicion, local people caught him from the spot while others managed to flee.

Hotel boy found dead

UNB, Sylhet

A hotel boy was found dead at his workplace at Chandnighat under South Surma of the city on Monday. The deceased was identified as Abdul Hamid, 30, son of late Abdur Rahman Master of Dohalia Rammagar village in Doarabazar upazila of Sunamganj district. On information, police recovered the body from Al Taqdir Hotel at about 10:00pm. Police said Hamid used to stay at the residential hotel at night. He went to sleep on Sunday night as usual but did not wake up till Monday evening. Other hotel boys then went to his room at about 6:00pm only and found Hamid lying dead on his bed with bed cover wrapped around his neck. Later, they informed police.

Rickshaw-puller murdered

Police recovered the body of a rickshaw-puller from Hakimpur upazila Health Complex early yesterday. The victim was identified as Mizanur Rahman, 30, son of late Mojibur Rahman of Nayapara village in Nawabganj upazila. His left eye was found gouged out. Quoting a night guard of the health complex, Md Shiddique, sub-inspector of Hakimpur police station, said two unidentified men brought the victim to the health complex at about 4:00am and fled the scene when the guard went to inform police.

Criminals ransack, loot courtrooms in Jamalpur

Criminals looted courtrooms in Jamalpur and office of a bus company in Jessoré early yesterday.

Police and court sources in Jamalpur said, an unknown gang tied up the night guards of the court in the town and broke open the doors of 18 rooms.

The criminals ransacked the files of cases and looted Tk 94,000 in cash. They also took away some counterfeit currencies and heroin kept as case evidence, reports our correspondent.

Police picked up six night guards and a sweeper for interrogation.

Meanwhile, the lawyers of the district held a press conference yesterday afternoon at the Bar Bhaban, demanding the security at the court.

They also demanded a police camp at the court premises.

In Benapole, Jessoré, another gang looted Tk 4 lakh in cash from the office of Shohag Paribahan, a transport company early yesterday.

Sahidul Islam, manager of the local office said, a gang numbering 4/5 entered the office in the early hours and took its guards and staff members hostage at gunpoint.

Later, the criminals looted Tk 4 lakh in cash from the cash box, reports our correspondent.

In Moulvibazar, robbers looted cash, gold ornaments and other valuables worth about Tk 7 lakh from a house at Fathepur village in Sadar upazila early Monday, reports UNB.

Local people caught two

robbers when they were fleeing in a microbus.

Police said, a gang of armed robbers numbering 8/10 stormed into the house of Radhika Rani, breaking the door open at about 3:00am.

Later, the thugs looted 9 tolas of gold ornaments, Tk 5000 in cash and other valuables taking the members of the house hostage at gunpoint.

At one stage, the house members cried out for help when the gang was preparing to decamp with the booty.

Hearing their hue and cry, villagers rushed in and caught the two robbers -- microbus-driver Mayad Miah, 28, of Brahman village and Emdadur Rahman, 25, of Hamarkona village in the upazila along with the microbus.

7 get life for murder

Seven people were sentenced to life term imprisonment yesterday in a murder case in Biral upazila in 2,000.

The court also fined Tk 1,000 each, in default, to suffer one year more in prison.

The convicts are Shukhdev Chandra Sarker, Haradhan Chandra Sarker and Subal Chandra Sarker sons of late Dulal Chandra Sarker of village Dakkhin Beragaon in Biral upazila, Kekar Chandra Sarker, son of Baku Chandra Sarker, Rajkumar Bakshi, son of Geluram Bangshi, Benuram Bangshi, son of Sanatan Raj Bangshi of Jassore-Dangapara in Bochaganj upazila and Babu Raj Bangshi son of late Soren Rajbangshi of Beldangapara in Bochaganj upazila in the district.

According to the prosecution, following a dispute between two rival groups over sugarcane harvesting at Dhakkin Melagaon in Biral upazila, Dhoresh Chandra Sarker was murdered in November 24, 2000.

Hiralal Chandra Sarker, younger brother of the victim filed a murder case with Biral police station on the next day accusing seven people.

3 drown in Sylhet boat capsiz

Three people drowned as a boat capsized in Chengerkhal (canal) under Sylhet Sadar upazila on Monday night.

The dead are Sagar Das, 35, Kali Das, 30, workers of Kewachhara Tea Garden, and Sharif, 4, son of Tera Mia of Baraghari village in the upazila.

Police and locals said the boat was carrying eight passengers from Mawakandi Bazar ghat to the other bank at around 9:00pm.
