# Honduras prison fire kills 357



A massive fire swept through an overcrowded prison in Honduras and killed more than 350 inmates, including many trapped screaming inside their cells, officials said yesterday.

A senior official at the attorney general's office, Danelia Ferrera, said 357 people died in the blaze that began late on Tuesday night at the prison in Comayagua, about 75 kilometers north of the capital Tegucigalpa.

It was one of the worst prison fires ever in Latin America, and local radio reports said many of the inmates were burned to death inside their cells.




