# NEWS IN brief HC order on 2 missing Shibir men

The High Court (HC) yesterday asked the government to explain in three weeks why it should not be directed to produce two Islami Chhatra Shibir (ICS) leaders, who were detained from Savar area on February 4, before the court to prove that they were not detained illegally.

The HC bench of Justice Abdul Awal and Justice Md Akram Hossain Chowdhury passed the orders in response to two separate writ petitions challenging the detention filed by relatives of the ICS leaders on February 12.

According to the petitions, Rapid Action Battalion (Rab) personnel, in plain cloths, detained ICS leaders Al Mukaddas and Md Waliullah on February 4 night at Nabinagar in Savar while the duo were going to Kushtia Islami University by a Hanif Enterprise bus. However, Rab said they have not detained the two.

#### **Body of girl recovered from Turag**

Police yesterday recovered the decomposed body of a girl from the river Turag.

The body, aged around 22, was found floating in the river. It was dumped into the river around 20 days ago, suspected Ziaul Karim, officer-in-charge of Turag Police Station.

He said locals recovered the body around 12:00pm when it got stuck with a pillar of Chandalvog Bridge.

#### RHD on SC LAND

## HC summons 3 ministry officials

Tension runs high at Roads and Highways Department (RHD) as the High Court summoned three communications ministry officials today for failing to hand over Supreme Court's land, currently housing RHD, as per its earlier directive.

Communications Secretary MAN Siddique, Chief Engineer Aminur Rahman Laskar and Superintendent Engineer (admin and evaluation) Faridul Alam are scheduled to appear by 10:30am and explain why contempt charges should not be brought against them.

A division bench comprising Justice AHM Shamsuddin Choudhury Manik and Justice Jahangir Hossain Selim passed the order on Tuesday after hearing a contempt of court petition filed by SC lawyer Asaduzzaman Siddiqui.

On July 28, 2011, following a writ petition by advocate Manzill Murshid, the HC passed an order asking RHD to hand over the 7.9-acre land in 15 days.

Established 30 years ago, RHD built several structures on the premises, also called Sarak Bhaban, including its offices, a library and a 323-seat auditorium.

The ministry covers 21,000 kilometres of roads and highways and several hundred bridges through RHD.

With 1,500 fulltime employees and tonnes of official

documents, RHD officials are struggling to shift office.

# Part time work offers knowledge, allowance

"Can I interest you in any book, sir?" piped up an inviting voice at the Amar Ekushey Boi Mela yesterday. Walking into the Bangla Academy

premises in the city, this correspondent was greeted by a book salesman in his mid-twenties poking his head out of the rows of books on display inside a stall. Picking up a conversation, the

enthusiastic salesman, Shaharul Islam, reveals that he is a student of Dhaka University and has experience working in the fair, of five consecutive years to be precise.

"I actually like working with books. That is why I am here," said the student of information science and library management department at the stall of Dibya Prokash.

"I can go through whichever book I want, a wonderful way to enrich my general knowledge. It helps me academically as well," he said, adding that he has a friend working with him.

Shaharul is not the only student

working there. Most stalls had college and university-going students working as salespersons, aiming to get their hands on books and earning some money in the process. A saleswoman, Madhuri Rani

Das, a student of Government Kabi Nazrul College, said she usually works part time in such events to help herself financially.

She assures you that her academic activities are not hampered as the fair starts at 3:00pm, past her college hours, during weekdays and at 11:00am on weekends, when her college is closed.

A salesman of Agami Prokashoni, Sharif Ahmed, a DU student, said, "I am here to gain some experience in the profession and come up close with eminent writers. Plus, I can use the money I earn here to buy books."

The owner of Ittadi Grantho Prokash, Johirul Abedin Jewel, says his publication house chooses students as its salespersons as they are more enthusiastic and efficient in convincing people to buy books.

"Booksellers should be educated to inform buyers about books and student are the right people for this task," he said.

Such a huge number of students working in different bookstalls is a good sign, says Murshiduddin Anwar, deputy director of Bangla Academy. "They are with books. Besides, they

are also earning some money." Yesterday saw the arrival of 103

new books at the fair but with fewer visitors than on previous days. A discussion and cultural programme were held in the evening.

Shishu Prohor today

Only children and their guardians would have access to the fair between 11:00am and 3:00pm today and tomorrow, the Bangla Academy authorities announced yesterday.

This exclusive four-hour period for children, termed Shishu Prohor (children's hour), will be repeated on February 23 and 24.

The aim is to encourage guardians into bringing their children to the fair and acquainting them with books and the habit of reading, said the deputy director.

#### Jamuna Denim fined Tk 52.6 lakh

The Department of Environment (DoE) yesterday fined Jamuna Denim, a sister concern of Jamuna Group, Tk 52.6 lakh for dumping untreated toxic wastes into the river Turag.

A DoE team paid a surprise visit to the dyeing factory at Konabari of Gazipur last Tuesday and found the factory discharging untreated liquid wastes into the river, in spite of having an effluent treatment plant (ETP). The factory kept the

ETP inactive and continued polluting the river intentionally to lower production costs, DoE sources said. The team tested the toxic waste and detected that

oxygen level was only 0.67 mg per litre while the minimum oxygen level in water should range between 4.5 and 4.8 mg per litre. Since its inception in

2006, the factory has discharged over 1,50,000 cubic metres of toxic industrial wastes.

The DoE served a show cause notice to the managing director of the factory following which he appeared for the hearing. Director of DoE (en-

forcement and monitoring) Munir Chowdhury then fined the factory and warned to shut down the factory, if the company does not comply with the Bangladesh Environment Protection Act and activate the ETP.

The company got its environment clearance certificate in 2010 which expired 10 months ago, DoE sources said.

The government announced the river Turag an Ecologically Critical Area (ECA) since November, 2009.

### HURRIED PASSAGE OF BILLS

# Criticise absentee MPs not House, says Speaker

Speaker Abdul Hamid yesterday criticised those who speak against hurried passage of bills in parliament.

"It will be fair if they learn about the parliamentary practice before saying something in talk shows [in televisions] or writing in newspapers," the Speaker said in the parliament yesterday.

He said amendment proposals submitted by MPs on a bill determine the time for passage of a bill. "The Speaker has no alternative but to begin the procedure for passage of the bill hurriedly if MPs, who submit amendment proposals, remain absent," he said.

Therefore, those who write in newspapers or speak in talk shows should not criticise the Speaker or the parliament if a bill is passed hurriedly, rather they should criticise the MPs, who remain absent despite submitting amendment proposals, he added.

The Speaker made these remarks during

passage of the human trafficking prevention and curbing bill. None of the 14 opposition MPs, who submitted amendment proposals on the bill, was present at that time.

Alongside this bill, the mutual assistance to curb criminal activities bill was also passed by the House yesterday.

The Speaker said, "It took 12 minutes to pass the two bills and, of it, I alone spoke for four minutes."

The parliament on November 29 last year passed a bill in four minutes splitting the Dhaka City Corporation into two. The hurried passage of the bill drew much criticism.

## Mamata 'biggest villain' in Indo-Bangla ties

The Times of India dubbed Indian Paschimbanga Chief Minister Mamata Banerjee as 'the biggest villain' in the relation between Bangladesh and India and warned the Indian government to rectify policies before time is over.

"Unless immediately rectified, a watershed moment in India-Bangladesh relations would be wasted," read the article of the Indian daily yesterday.

The article said Indian Prime Minister Manmohan Singh's trip to Dhaka last September was meant to elevate the India-Bangladesh relations to new heights, but five months on, New Delhi has failed to deliver on big-ticket issues and risks, losing most of the goodwill it had previously garnered.

Mamata embarrassed the Indian PM by refusing to accompany him on his Dhaka visit to protest the Teesta river water-sharing agreement.

By this abrupt decision, she not only put the Indian PM in an awkward situation but also left the government of his Bangladeshi counterpart Sheikh Hasina red-faced.

The waters of the Teesta are a vital source of sustenance for north Bengal and Bangladesh.

Even if Mamata wasn't satisfied with the proposed watersharing formula, there was room for further negotiations. Mamata has now reportedly expressed reservations over

the operationalisation of the 1974 Land Boundary Agreement, signed in Dhaka during the Dhaka meet, the article added.

# Domestic help found dead

A teenage domestic help was mysteriously killed at an apartment in the city's Sabujbagh area yesterday. The deceased, Halima Akhter, 14, hailed from Ghatail in Tangail. She joined her current work 12 days back.

Sabujbagh police recovered the body from the top floor of a six-storied building of her employer at Ahmedbagh in Sabujbagh around 3:00pm.

Employer MA Zaman, a private service holder, and his wife Anjuman Ara Begum, a banker, and their two children were out of house when the incident occurred, said the employer's family members and police sources. When the two children returned from school, they found

their flat locked from inside, said family members. Later, when the door was opened using duplicate keys, the body was found lying in the master bedroom and two almiras were found broken, they added.

Anjuman suspected that miscreants killed their domestic

help and took away valuables from the almiras, though she

could not ascertain which things were robbed. Abdus Salam, a security guard of the building, said one of the two persons, who had reconnected the cable line on Tuesday, visited the flat yesterday but left within a short time.

Abdul Quayum, officer-in-charge of Sabujbagh Police Station, said they picked up the building security guard and five persons of the cable line provider for interrogation on the matter.
