### Campaign to save tigers

Wildlife Trust of Bangladesh (WTB) will launch a campaign today to raise awareness among the mass people regarding the aims and objectives of The Sundarbans Tiger Project. The programme includes a colourful rally, painting competition, discussion meeting and cultural function participated by country's eminent artistes. WTB has taken up a five-year long campaign to create awareness among the people on how to save the tigers in the world's largest mangrove forest, said Anwarul Islam, chief executive of WTB.

### Jatka seized in Munshiganj

Coastguard members seized 30 maunds of *jatka* (hilsa fry) from a launch at Dhaleswari River in Sadar upazila yesterday morning. Pagla Coastguard camp commander Ferdous Ahmed said, a team raided the Dhaka-bound MV Bandhan coming from Bhola and seized the *jatka* in the early morning. None was arrested in this connection. Later, the seized *jatka* was dumped under the earth in presence of Sadar Upazila Fisheries Officer MA Azad. The government banned catching of *jatka* from February 1 to May 31.

### Phone exchange looted

A gang of armed robbers looted divisional telephone exchange office in the district town early Wednesday. The gang took away Tk 3000 in cash, two bicycles and other valuables from the employees of the exchange. Sources said the masked robbers numbering 10/12 swooped on the exchange office at around 4am and took senior telephone operators Sima Rani Dash, Rabeya Khatun, Line man Mujibur Rahman and guard Abdur Razzak hostage at gunpoint. Later, they damaged revenue section, optical mask room, rectifier room and furniture and some important documents of the office.

### Indian liquor seized

Border Guard Bangladesh (BGB) members recovered 320 bottles of Indian liquor worth Tk 4.80 lakh at Dashghar near Lauerghar border camp in Tahirpur upazila early Wednesday. BGB-8 camp officer Major Golam Kibria said on secret information a patrol team led by Habildar Mustak Ahmed conducted a drive in the area at around 3am recovered the Indian liquor in abandoned condition. Another report from Sylhet adds: Police arrested a drug peddler along with 244 bottles of Indian liquor at Anjagram village in Jaintapur upazila on Tuesday midnight. The arrestee was identified as Russell Ahmed, 24, son of Shahabuddin of Kandigram village in the upazila.

# Thakurgaon docs struggle to cope with child patients

Doctors at Thakurgaon Sadar Hospital are struggling to cope with the child patients admitted to the hospital with diarrhoea and cold related diseases including pneumonia.

At least 188 patients have been admitted to children's ward of the hospital, which has only 18 seats, in the last two days.

Of the patients, 146 were affected with diarrhoea while others with pneumonia and other cold related diseases. As the hospital cannot accommodate the growing number of patients, most of them are staying on veranda and corridor.

Besides, about 150-200 patients are receiving treatment at outdoor every day. About 160 child patients, most with diarrhoea, pneumonia and respiratory problems, received treatment there yesterday, said hospital sources.

During a visit to the hospital yesterday, this correspondent saw many child patients lying on the floor of the children's ward.

The diseases broke out due to rotavirus and weather change, said Dr Shahajahan Nawaj, a child doctor of the hospital.

As there is no child specialists at the upazila level and in adjacent district Panchagarh, child patients

are crowding here, the doctor added.

Only three nurses are looking after the child patients. So it is difficult for them to tackle the situation, he said.

Rotavirus is the most common virus that causes severe diarrhoea among infants and children. It is often called stomach flu,

despite having no relation to influenza.

If such child patients come to hospital in time, it is easy for the doctors to save the patients by giving proper treatment, he said.

Earlier, similar diarrhoea and pneumonia broke out in Thakurgaon due to severe cold last month.

## NETRAKONA JUBO LEAGUE CHIEF MURDER

# Charge-sheet after 10 years

Charge-sheet in the Swapon Joarder murder case was submitted to the Senior Judicial Magistrate's Court yesterday evening, 10 years into the killing of the district Jubo League chief.

Earlier at a press briefing on Wednesday night, Netrakona CID Inspector Khandaker Fazle Rahim told the local journalists at his office that the charge-sheet will be submitted against five people.

The charge-sheeted accused are Morshad Habib Bhuiyan *alias* Jewel, Mazharul Islam *alias* Mamun, Saiful Alam *alias* Sohel, Masud Rana *alias* Liton and Delwar Jahan Mohammad Hasan Bin Shafiq *alias* Sohag.

The CID inspector said that on November 28 in 2001, an armed gang shot dead Swapon Joarder at Teribazar in Netrakona town when he was returning to his residence at Ukil Para from the party office.

Ranjit Joarder, elder brother of Swapon

Joarder, filed a murder case with Netrakona police station, accusing five people on December 3 in 2001.

On April 23 in 2009, the Chief Judicial Magistrate of the district sent the case to CID for investigation as police and Detective Branch (DB) of police failed to detect the killers.

On investigation, CID Inspector of Netrakona Fazle Rahim submitted the charge-sheet accusing the aforesaid five.

Name of an accused, ATM Mostafiz Chunnun, ex-president of Netrakona district Jubo Dal, was dropped from the charge-sheet as the allegation brought against him was not convincing, the CID officer informed adding that, Sohag was indicted after necessary investigation.

Contacted, Ranjit Mallik, complainant of the case told this correspondent that he was very happy as the CID police could finally identify the killers and submitted the charge-sheet against them after ten years.

## SAAD MURDER IN RAJSHAHI

# Two main accused arrested

Police arrested two main accused in the Rajshahi College student Saad murder case from Sher-e-Bangla Nagar in the capital city yesterday.

According to investigating officer (IO) sub-inspector Alamgir Jahan of Rajpara PS, the arrestees are Sweet Raza, 22, son of Rezaul Karim of Rohonpur and Al Awal Koel, 21, son of Abdul Alim of Gomostapur in Chapainawabganj district.

Acting on a tip off, a police team from Rajpara PS caught both of them from near the Eye Hospital area around 6am.

The IO said that four of the six accused,

who were earlier arrested in judicial confession, described Sweet and Koel as the key accused.

The four accused are Oishi Khatun, Masud Ibne Ali *alias* Shawon, Kaisar Ahmed Anik and Rashedul Islam Bipu.

In their confessional statement they said that Sweet and Koel masterminded the murder after failing to realise ransom money from Saad's parents.

Nadimuzzaman Saad, a student of HSC first year at Rajshahi Model School and College, was abducted from his home on January 17 evening.

He was murdered on the following day and dumped into a septic tank.
