Myanmar lifts campaign restrictions on complaints

Myanmar election authorities lifted restrictions on political campaigning yesterday in an unusually swift response to complaints by pro-democracy leader Aung San Suu Kyi's party.

The National League for Democracy said earlier in the day that the restrictions risked making upcoming byelections unfair.

The state Union Election Commission's decision to lift all restrictions was unusual. Bureaucratic wheels grind slowly even where there are no political hurdles in the country where an elected, nominally civilian government took office almost a year

ago after a half-century of military rule. NLD spokesman Nyan Win had said the party was facing difficulty in getting permission to use public venues for its meetings ahead of the April 1 polls.

"What we want is fair play but the

restrictions have increased lately. It is very difficult to say that the upcoming by-elections could be free and fair," NyanWin told reporters.

Later yesterday, however, he said the state Union Election Commission had informed the party that "all restrictions are lifted for the organizational activities."

"There is now a flicker of hope," NyanWin commented.

Suu Kyi, a former political prisoner and 1991 Nobel Peace Prize laureate, is running for one of the 48 parliamentary seats being contested in April. Her party overwhelmingly won a 1990 general election but the military them. refused to allow it to take power.

The NLD boycotted a 2010 general election, saying the rules were unfair. It agreed to rejoin electoral politics last year when the new military-backed elected president, Thein Sein, began implementing democratic reforms.

The government has released politi-

cal prisoners and amended some election laws among other changes, while arguing that Western political and economic sanctions imposed because: of the repression under the past military regime should be lifted.

The U.S. and other nations have specifically cited a fair election as a benchmark by which Thein Sein's . administration will be judged.

Nyan Win, also the NLD's campaign manager, had said some government organizations blocked the party's : campaign activities even though the election commission had approved .

He said Sports Minister Tint Hsan had objected to the NLD's use of football fields in three constituencies -Hlegu in northern Yangon, the central city of Mandalay and the Irrawaddy · delta town of Phyapon - after local: election commissions had approved: such meetings.

Putin vows to boost Russian army ahead of vote

Russian strongman Vladimir Putin vowed yesterday that Russia would strengthen its military might and offer an "asymmetrical and effective" response to the deployment of a Nato missile shield. "We must not tempt anyone

with our weakness," Putin wrote in a fiercely worded article on national security in the state newspaper Rossiiskaya Gazeta, ahead of his bid for a third Kremlin term in March 4 presidential polls. "Therefore we will never in any circum-

stances give away our potential of strategic deterrence and will strengthen it," he said in his sixth campaign article laying out his political beliefs.

Drawing historic parallels with World War II, he cited Marshal Georgy Zhukov and warned against repeating the Soviet Union's disastrous entry to the war, taken by surprise

Russia must implement strong countermeasures to respond to Nato's planned deployment of a missile shield in Europe, he said, continuing a debate that has simmered for nearly a decade.

The mix of European radar and interceptors -- a key part of a global shield being studied by

the United States -- are designed to protect against potential attacks from Iran amid worries about the Islamic state's nuclear programme.

But Russia fears the system could one day make its own shrinking nuclear arsenal ineffective and has outlined a series of retaliatory steps it may take should Nato ignore its concerns.

"The time demands decisive steps to strengthen a single system of air and space defence of our country. We are being pushed towards these actions by the policy of the United States and Nato on the question of deploying a missile shield," Putin wrote.

Nigeria army says kills 8 Islamists

Nigeria's military killed eight Islamist insurgents who attacked a market in the volatile northeastern city of Maiduguri yesterday, and deactivated three bombs in controlled explosions, the spokesman for the joint military taskforce (JTF) there said.

The Maiduguri-based sect Boko Haram is waging an increasingly violent insurgency against the Nigerian government, striking beyond its northeastern heartland to hit targets across the north and in the capital, Abuja.

"The JTF has killed eight BH (Boko Haram) members this afternoon who attacked and wounded three civilians at the Baga Road market," Lieutenant Colonel Hassan Mohammed told Reuters by telephone. "The sect members were engaged ... in a shootout."

Grounds of the verdict could not be known immediately, since the HC did not release the full text of verdict.

Roy, however, said the HC came up with the verdict on the ground that the advertisements, upon which the NU authorities made the recruitment, were wrong as those did not mention the number of posts, quota and some other particulars for the candidates.

There were also anomalies in the recruitment process, he added.

Advocate Zafar Ahmed, counsel for the NU, said more than 1,100 were appointed to different posts including deputy registrar, assistant registrar, section officer, programme officer and driver between November 2003 and November 2004 when Prof Aftab Ahmed was

the vice-chancellor. The appointment came on the basis of wrong advertisements published in five national dailies -- daily Sangbad, Bangla Bazar, New Nation, Ajkaler Khabar and The Independent, he said, adding, police have unearthed the irregularities

through an enquiry. Advocate Zafar said the enquiry found anomalies in advertisements and recruitment process.

1,100 NU staff Ruling Awami League lawmaker Fazle Rabbi Miah filed the writ in 2004 challenging legality of the appointment. The HC, however, rejected the writ and declared the appointment legal in 2006.

In August 23 last year, the HC endorsed the review prayer and ruled the appointments illegal.

Following three separate petitions submitted by the employees, the Appellate Division on December 4 last year directed the NU authorities to maintain status quo on termination of the employees and fresh recruitment to the university until further order.

The Appellate Division also asked the HC bench led by Justice Hasan Foez Siddique to hear and dispose of the writ filed by Fazle Rabbi.

Dr Kamal Hossain appeared for AKM Mozammel Haque, while Abdur Rob Chowdhury argued for Fazle Rabbi Miah and Rafique-ul Huq, Rokanuddin Mahmud and Khair Ejaj Mashud stood for the terminated employees.

Gaibandha, had always been devoted to politics. His son Sajjad Jahir

The movement spread to other parts of the then East Pakistan, now Bangladesh, after police opened fire on a procession that students brought out from Dhaka University on February 21, ignoring a ban on public gatherings. A number of students were killed in the

On February 4, 1952, Jalilar and his fellow activists observed a strike in all edu-

cational institutions in Gaibandha in line with a decision of the central Muslim Chhatra League. Kazi Abdul Halim, former lawmaker Lutfar Rahman,

Babu Nirmolendu Barman, Khan Ali Taiyab, Hasan Imam Tulu and Golam Kibria also played key roles in the language movement in Gaibandha.

Earlier, Jalilar was detained in 1949 for his involvement in the peasants' movement led by Ila Mitra in Nachole, Rajshahi. He was released after a year. He joined the Awami

Muslim League, led by Moulana Abdul Hamid Khan Bhashani, in 1949 and the United Front in 1954.

Bhashani-led National Awami Party in 1957, and fought in the 1971 Liberation War.
