

#### Traffic sergeant's death condoled

Leaders of Bangladesh Police Service Association yesterday expressed deep shock at the death of traffic sergeant Riaz Uddin, who was killed by a recklessly driven private car.

In a statement chairman of the organisation Md Mokhlesur Rahman and secretary Habibur Rahman said Bangladesh Police have lost a sincere and honest officer through the death of Riaz.

They prayed for the salvation of the departed soul and conveyed deep sympathy to the bereaved family members, said a press release.

Riaz, hit by a car while discharging his duty in the city's Panthapath area, was admitted to Dhaka Medical College Hospital on February 14. Later, he was referred to Square Hospitals where he died early Wednesday.

### WB set to choose PM made proposal new president

The World Bank Group will choose its next president from among competent candidates who must be nationals of its member countries. But past history shows that all WB presi-

dents were citizens of the US, the largest contributor to the lending agency. Current President Robert B Zoellick has

already announced that he will not seek reappointment at the end of his term, which expires on June 30.

The WB Board of Executive Directors held a meeting in this regard in Washington on February 17.

They reconfirmed the importance of a merit-based and transparent process in the selection of the next president, with all executive directors able to nominate and consider all candidates, says a WB press release.

They also agreed that candidates should have a proven track record of leadership, experience in managing large organisations

with international exposure and a familiarity with the public sector.

They must also have the ability to articulate a clear vision of the World Bank Group's development mission, a firm : ridicule him. commitment to and appreciation for: multilateral cooperation, effective and diplomatic communication skills, impartiality and objectivity.

### Poetry in CDs the new wave

Audio format of poems of eminent Bangla poets is fast gaining popularity alongside books at the Amar Ekushey Boi Mela.

Visitors are collecting a good number of CDs on recitations of their favourite poems from four stalls --Abritti Mela, Boikantha, Bangladesh Abritti Samonnay Parishad and Bangladesh Udichi Shilpi Gosthi -- set up before the city's Bangla Academy.

"We started getting a huge response from visitors from the very first day of the fair," said Mofidul Islam, chief executive of Abritti Mela.

They sold such CDs, each ranging in price from Tk 60 to Tk 100, worth over Tk 8 lakh last year and hope to make similar sales this year, he added.

Since most of these CDs are not available in shops around the city and outside, visitors find it convenient collecting them from the fair, said the sellers.

"I like both reading and listening to poetry recitations," said Robin, an ardent poetry fan who bought three CDs from the stall yesterday.

The sellers said most

visitors preferred romantic and patriotic poems by popular poets. "Poems recited by popular artistes have a different

taste. I became a fan of the CD format a couple of years ago," said one visitor, Kamrunnahar Keya, a government official.

Asked why he sells CDs in a fair for books, Mofidul, who also recites poems, said, "Poems recited by artistes played a significant role during different sociopolitical movements of Bangladesh.

"Poems are a part of literature. We are offering the same poems but in audio format, which does not contradict the basic spirit of this fair."

Mofidul said he did not face any problem getting space for his stall.

### REFUSING TO RECEIVE HC ORDER Contempt rule on DCC south

The High Court yesterday issued a second contempt of court rule against Dhaka City Corporation (South) Administrator Khalilur Rahman for refusing to receive its earlier order.

On February 9, the HC issued a contempt of court rule against Khalilur and five officials, asking them to explain why they should not be punished for demolishing a building near the city's Jatrabari kitchen market, defying its order.

In response to a contempt of court petition, the court had also summoned them to it yesterday to explain their roles in demolishing the building. Humayun Kabir, the building's owner,

filed the petition saying that some DCC officials led by a magistrate knocked down his building on February 7, ignoring a status quo order of the HC.

The HC on August 25 last year imposed the status quo and also issued a rule upon the government authorities concerned to explain why the acquisition of the building's

land should not be declared illegal. The six officials appeared before the HC bench of Justice AHM Shamsuddin Hossain represented the government.

During yesterday's hearing, the petitioner's counsel Manzill Murshid said the DCC administrator's office refused to receive its February 9 order from a Supreme Court messenger twice before finally receiv-

The HC bench yesterday called the messenger before it to hear about the allegation.

The messenger said the DCC administrator's office refused to receive the HC order under the instructions from "higher authorities".

The court then issued the contempt of court rule against the DCC administrator and asked him to appear before it on February 28. The HC bench yesterday also directed the

### Five vehicles penalised for polluting environment

A mobile court yesterday penalised five vehicles in the capital's Agargaon area and realised Tk 18,000 in fine for polluting the environment by emitting black fumes.

The Department of Environment (DoE) along with Bangladesh Road Transport Authority (BRTA) and traffic police conducted the drive led by DoE Executive Magistrate Md Kamruzzaman.

The court inspected 25 vehicles and penalised three diesel-driven and two CNGrun vehicles under the Motor Vehicle Ordinance, 1983, and the Environment Conservation Act, 1995 which was amended in 2010.

Magistrate Kamruzzaman said under the act, a vehicle owner can be sentenced to one-year imprisonment or fined up to Tk5000 for emitting black fumes.

According to the Environment Conservation Act, the permissible level of carbon monoxide for a CNG-driven motor vehicle is one percent while hydrocarbon is 1200 PPM (parts per million), said a DoE official.

The primary aim of the drive is to create public awareness about the environmental and motor vehicle laws, he said.

"However, we cannot make them follow the rules stringently by conducting regular drives due to our lack of manpower and logistic support," said DoE Director (planning) Quazi Sarwar Imtiaz Hashmi.

The BRTA and traffic police checked driving licenses, route permits, and registration and fitness certificates of the vehicles.

BRTA Motor Vehicle Inspector Mohammad Abdul Alim Chowdhruy who was present during the drive said no document-related anomalies were found during the drive.
