#### 21 Netrakona BNP men sued

A case was filed with Atpara police station accusing 21 BNP leaders and activists on charge of vandalising Atpara Awami League office. The accused include general secretary of Atpara upazila BNP Khairul Kabir Talukder also exchairman of Atpara upazila parishad and member of Atpara upazila BNP Zahirul Islam Khan Maju. Abu Naser Talukder Milu, general secretary of Atpara upazila AL filed the case yesterday morning. Police and AL sources said, at about 10:00 on Tuesday night, a group of BNP activists attacked the AL office with sharp and lethal weapons and vandalised wooden furniture including chairs and tables.

#### Train derails in Tangail

Train service on Joydevpur-Bangabandhu Bridge route remained suspended for three hours yesterday as an engine and two compartments of a goods train bound for Dhaka from Parbatipur in Dinajpur derailed at Gharinda Station in Tangail. The derailment took place at around 8:30am, causing untold sufferings to passengers. The train communication on the route resumed at about 12:30pm after a relief train from the capital cleared the line, said Jalal Uddin, station master of Gharinda. The train derailed due to a technical fault, he added.

#### Man murdered by nephew

A man was stabbed to death allegedly by his nephew at Barbakpur village in Jhikargachha upazila on Wednesday night. The deceased was identified as Mashiur Rahman, son of late Ramzan Ali of the village. Police said an altercation took place between Mashiur and his nephew Sujan at about 10:00pm over a piece of disputed land. At one stage, Sujan stabbed Mashiur indiscriminately, leaving him critically injured. Mashiur was rushed to Jhikargachha upazila health complex where the attending doctor declared him dead. Sujan went to hiding after the incident.

# Nilphamari boro farmers besiege power office

Several hundred boro farmers of Sadar upazila yesterday besieged the district office of Rural Electrification Board (REB), demanding uninterrupted power supply for smooth irrigation.

Police and REB officials said, farmers from at least 10 villages -- Khoksabari, Chaora, Gorgram, Kundupukur, Polashbari, Tupamari, Ramnagar, Laxmichap, Charaikhola and Itakhola -- gathered on Nilphamari-Saidpur road in front of the REB office at about 1.00pm and later besieged the power office.

At the time of protest, a meeting of the 'regional power management committee' was going on at the REB office, chaired by chief engineer of PDB Masud Al Faruk.

Agitating farmer Abdul Jabbar of Khokshabari village alleged he had cultivated boro on 16 bighas of land.

"As we get only one to two hours of power

supply a day, which is also disrupted four to five times due to frequent load-shedding, we cannot irrigate boro," he said, adding most of our boro plants have turned yellow".

Farmers Noor Islam of Dhakkhin Chaora village, Bimol Chandra Roy of Gorgram village complained that at least 20 power pump motors went out of order due to frequent load shedding.

During agitation, farmers tried to enter the REB office to meet the high officials of PDB and REB present at the meeting. But police closed the gate to prevent the farmers. At one stage, general manager (GM) of

REB in Nilphamari SM Habibur Rahman along with other officials went to the spot under police protection.

The GM assured the farmers of uninterrupted power supply within a few days.

During the siege, about a hundred vehicles remained stranded on both sides of the road causing immense suffering to the passengers.

## Three poachers held with venison



Rapid Action Battalion (Rab) arrested three poachers along with a slaughtered deer at Lawachhara forest in Srimongal of Moulvibazar district early yesterday. Rab sources said the poachers caught a spotted deer by setting traps in the forest. Acting on a tip-off, a team of Rab raided the forest at about 4:00 am and arrested Yunus Miah, Azadur Rahman and Nawsadur Rahman when they were taking away the slaughtered deer.
