Clean roads, footpaths in 48 hrs, HC asks govt

The High Court yesterday directed the government to free roads and footpaths from Zero Point to Sadarghat in the city in 48 hours to facilitate easy movement of people and vehicles.

The court said the authorities have to ensure that nobody will keep sand, rods and other materials, parked rickshawvans and carts and establish makeshift shops by occupying the road and footpaths.

The court issued the order following a writ petition moved by Advocate Manzill Murshid on behalf of Human Rights and Peace for Bangladesh.

The organisation submitted the petition yesterday to the HC, seeking direction the government to free the road from Zero Point to Sadarghat of traffic jam.

It said that lawyers, judges and litigants of Dhaka Judge's Court suffered from

traffic jam on North South Road everyday and lawyers cannot reach the court on time.

The HC also issued a rule upon the government to explain in two weeks why it would not be directed to evict or remove materials occupying the road and footpaths.

The HC bench of Justice AHM Shamsuddin Choudhury Manik and Justice Jahangir Hossain Selim came up with the rule after hearing on the petition.

The home secretary, inspector general of police, joint commissioner (traffic) and deputy commissioner (south) of Dhaka Metropolitan Police, administrator of Dhaka City Corporation (south), Deputy Commissioner of Dhaka and officers-incharge of Bangshal, Kotwali, Sutrapur and Ramna police stations have been made respondents to the rule.

Deputy Attorney General ABM Altaf Hossain represented the government.



Verdict in Apu murder case March 13

Judgment in the sensational Ashikur Rahman Khan Apu murder case filed against seven accused, including a cousin of home minister, will be delivered on March 13.

The case was filed with the Sutrapur Police Station on May 24, 2008, a day after Apu, a private university student, was shot dead and his two brothers were injured in Wari. After completion of the arguments, Judge Shahed

Nuruddin of the Speedy Trial Tribunal-1 set the date for delivery of the judgment of the case. The court also cancelled the bail of Mahbub Alam and issued

an arrest warrant against him as he was absent yesterday. Earlier, the government had made several moves to withdraw the case against all the seven charge-sheeted accused,

citing political affiliations. But in the wake of widespread criticism and publication of reports in two national dailies, the government made U-turn

and withdrew its earlier decision for withdrawal of the case. The seven charge-sheeted accused are Monjurul Abedin Russell, Mahbub Alam, Mohammad Ali alias Munna, Nawshad Hossain Mollah alias Robin, Iftekhar Beg alias Jhalak, Biplob Chandra Das and Atiq Ahmed Shiplu.
