#### 2,827 mobile phone sets seized at airport: Six arrested

Rapid Action Battalion (Rab) personnel seized 2,827 mobile phone sets yesterday and arrested six alleged members of a gang that had been getting delivery of imported goods from Shahjalal International Airport using fake documents.

The detainees are Monir Hossain alias Kamal, 36, of Feni, Mohammad Isanur, 34, Yusuf Ali, 37, Karim Hossain, 38, of Magura, Masum Billah, 28, of Barguna and Anwar Hossain, 36, of the city's Shahbagh.

Major Mohammad Sadiqur Rahman of Rab-3 said they conducted drives at Nurul Huq Tower in the city's Kotwali area and at Prembagan in Uttara and arrested the persons with 2,827 brand new mobile phone sets and two cartoons of accessories in their possessions.

The gang used to make fake documents in the name of the owners of the imported goods and took delivery of the goods, he added.

#### Dyeing factory fined Tk 65 lakh

The Department of Environment (DoE) yesterday fined a textile dyeing industry Tk 65 lakh and sealed off it for releasing untreated chemical and waste into the river Shitalakkha at Shiddhirganj in Narayanganj.

A DoE team found that Shah Dyeing and Finishing Mills Ltd was releasing untreated liquid waste into the river as its Effluent Treatment Plant (ETP) remained out of order, said a press release.

The DoE team, led by its Director (Enforcement) Mohammad Munir Chowdhury, fined the money and ordered Mohammad Shahjahan, the industry's managing director, to keep it shut until making its ETP functional.

The industry was running without DoE approval over the last 25 years contaminating the river.

#### Six stores fined Tk 30,000

A mobile court yesterday fined six stores of steel products Tk 30,000 for using weigh machines, which have not been verified and approved by the BSTI, says a press release.

During a drive in the city's Goalghat and Dholaikhal areas, the court filed six cases against the stores. The cases were later dropped as the storeowners paid the penalties.

Executive Magistrate Mohammad Selim Hossain led the drive with the assistance of Bangladesh Standards and Testing Institution (BSTI).

The penalised stores are M/S Bismillah Trading, Apon Steel Housing, Isamoti Enterprise, Gold Star Steel House, Madina Enterprise, and Roni and Brothers.


#### Sri Lankan team in city

#### Hizb-ut-Tahrir man arrested

Police yesterday arrested a suspected leader of the banned Islamist outfit Hizbut-Tahrir from the city's Kamalapur with a huge number of books and posters of the organisation.

Mahtab Uddin, 40, was arrested with 34 books and 455 posters in his possession from a flat located on the sixth floor of a building at south Kamalapur at around 3:00am, said Masudur Rahman, additional deputy commissioner of Media and Community Service of Dhaka Metropolitan Police.

He had been involved in the publicity and regrouping of the banned organisation, Masudur added.

#### Amini accuses PM of plotting to destroy army

Prime Minister Sheikh Hasina is plotting to destroy the army in the name of detecting religious fanatics, Islami Oikya Jote (IOJ) Chairman Mufti Fazlul Haque Amini said yesterday. Speaking at a discussion

at his party's office at Lalbagh in the city, Amini claimed that "Sheikh Hasina herself formulated the conspiracy as she doesn't want the army anymore".

Amini also referred to the Prime Minister's recent remark on Khaleda Zia attempting to use the army to return to power as "childish".

"Political parties never used army to come to power, then how can Khaleda come to power by resting guns on the shoulder of the army", he added.

### Lance nayek Ekram vowed to kill army officers, Maj Ishtiaq tells court

Hurling abusive words at slain BDR chief, Maj Gen Shakil Ahmed, on loudspeaker, lance nayek Ekram had declared that the DG (director general) had been killed, and now every army officer would face the same

Maj Ishtiaq Ahmed, who witnessed the incident during the Pilkhana carnage on February 25, 2009, said this in a Dhaka court yesterday. The witness said the soldiers held him hostage and attempted to kill him several times.

As soon as the mutiny broke out, Ishtiaq took shelter at the house of sepoy Uzzal. He stayed there for about 20 hours along with five other armed soldiers of record wing.

On the night of February 25, he saw his runner sepoy Rahim on television, laying down his weapons.

Speoy Rahim called Maj Ishtiaq's

wife over phone several times on that night and asked her furiously and indecently for his location. The next day, some BDR soldiers caught him as he left the house. They

took him to quarter guard. At that

time, some soldiers beat him up and took away his belongings. He was freed from captivity at about 4:30pm on February 26.

A metropolitan sessions judge's court, set up at the playground of Alia Madrasa of the city's Bakshibazar to try the accused in the carnage case, recorded Ishtiaq's deposition yester-

Abdul Kuddus also gave depositions before the court.

The defence counsel later crossexamined them. The court was adjourned till February 29.

A total of 74 people, including 57 army officers, were killed by the mutinous soldiers of defunct BDR (now Border Guard Bangladesh) on February 15-16, 2009.

### WAR CRIMES TRIAL Arguments on SQ Chy's four Joint body to monitor petitions end

The defence counsels yesterday finished their arguments on four petitions for BNP lawmaker Salauddin Quader Chowdhury before the International Crimes Tribunal.

After the counsels finished their lengthy arguments, which continued for the last three days, the prosecution yesterday began its reply on the petitions.

The detained BNP leader filed the petitions seeking bail in a case filed on crimes against humanity charges, transferring him from Gazipur's Kashimpur Jail-2 to any other prison, and conducting the proceedings against him following international standards.

The fourth petition sought discharge of the Chittagong lawmaker from the charges of crimes against humanity he is facing at the tribunal.

In the discharge petition, the defence counsels appealed for withdrawing six out of a total of 25 crimes against humanity

charges against Salauddin Quader. Defence counsel Ahsanul Haq Hena said the BNP leader was already facing those charges in other cases filed under the

Collaborators Act of 1972, which could lead to "double jeopardy", meaning nobody could be tried twice for the same offence according to the constitution.

Salauddin Quader Chowdhury, a six-time lawmaker, was produced before the court for yesterday's proceedings. He was also given an opportunity to

address the court briefly after his counsels finished their arguments. The Chittagong lawmaker used the opportunity to express his "unqualified apology" to the court for "unknowingly

breaking" the court's rules in the past. He then proceeded to answer some of the questions the judges asked when his counsel Fakhrul Islam was submitting the discharge petition.

Later, prosecutor Zead Al Malum said he would answer each of the 47 points the defence counsels had mentioned in their arguments.

The prosecutor is scheduled to continue his reply today.

Salauddin Quader is among two BNP and six Jamaat-e-Islami leaders facing charges of crimes against humanity at the tribunal.

#### RECRUITMENT OF WORKERS IN S ARABIA

Bangladesh and Saudi Arabia have agreed to set up a joint working group to supervise the issues regarding recruitment and welfare of Bangladeshi workers.

The official-level working group comprised of members of the relevant ministries of the two countries will take stock of the situation periodically and find out remedial approach, according to a release issued yesterday by the expatriates' welfare ministry.

The two sides also agreed that a Saudi delegation led by its labour minister would soon visit Bangladesh to see for themselves the measures put in place and explore possibilities of cooperation.

The decision was reached during a recent visit to the Arab state by a Bangladeshi delegation led by Expatriates' Welfare and Overseas Employment Minister Khandker Mosharraf Hossain.

The six-member delegation had meetings with Saudi Labour Minister Adel Fakeih, Governor of Riyadh Prince Sattam Bin Abdul Aziz and Deputy Minister for Interior Dr Ahmad Alsalim.

Saudi Arabia remains the largest labour importer from Bangladesh employing over two million workers. However, it significantly cut the recruitment since 2009.

Besides, the kingdom has also stopped allowing Bangladeshis transfer their jobs from one company to another, landing many of them in trouble.

During the meeting -- the first in three years -- with Adel Fakeih, Mosharraf informed him that Bangladesh has adopted measures for electronic registration of the jobseekers and sending them abroad on better terms.

Appreciating the contribution of the Bangladeshi workforce, Saudi Deputy Interior Minister Dr Ahmad Alsalim, however, noted that a few of them are indulging in some "legally and socially unacceptable activities."

The Bangladeshi minister hoped the two countries would soon embark on a new vista of cooperation with the establishment of the joint working group.
