Romney-Santorum clash apprehended in Ohio

Regardless of the outcome of Republican presidential primaries in Michigan and Arizona today, Mitt Romney and Rick Santorum appear headed for a showdown next week in Ohio.

Both candidates plan to dash there later this week. The candidates and their allies already are spending heavily on advertising in the Buckeye State. It's one of 10 that vote a week from today, with 419 delegates to the Republican National Convention at stake.

"An awful lot of Ohioans are just tuning in to this," said Terry Casey, a veteran Republican campaign strategist in that state. "It's going to be a sprint."

Beyond Ohio, Romney was looking to contests in the West while Santorum focuses on the South.

Rival Newt Gingrich, seeking to inject momentum into his struggling bid, was working to make his stand in his former home state of Georgia and nearby Southern states that also vote

Rick Santorum on the mega-contest day of March 6. The former House speaker told reporters Sunday: "We hope to win in Georgia, we hope to do well in Oklahoma and Tennessee. We may surprise people in Idaho. We think we

have a real fighting chance in Ohio." upcoming states, showing no willingness to abandon his quest to rack up enough delegates to ensure his followers have a voice at the late-summer convention and that the Republican Party which once spurned him welcomes him back into the fold.

All of the divergent strategies suggest the race could go deep into March if not beyond - without giving any of the candidates a significant edge.

It's a scenario that all the candidates are anticipating.

"Look, this is going to be a long race, and there's going to be some ups and downs," Santorum, a former Pennsylvania senator, said Sunday on ABC's "This Week."

On "Fox News Sunday," Romney, a former Massachusetts governor, chimed in with: "How long the process goes on, I think it's hard to predict."

Gingrich argued that a drawn-out campaign would give states like California, which holds its primary June Ron Paul also planned events in 5, a large role in the nominating contest. Heading into today's contests,

> Romney leads in the race to amass the most delegates with 123. Santorum has 72, while Gingrich and Paul have 32 and 19, respectively. The totals include endorsements from Republican National Committee members who will automatically attend the party's national convention and can support any candidate they choose.

opment of culture.

President Zillur Rahman, who assumed the presidency in February 2009, pardoned in November in the same year sentences Shahadab Akbar, son of deputy leader of parliament Syeda Sajeda Chowdhury.

Shahadab was sentenced to 18 years' imprisonment and fined Tk.1.6 crore in absentia in four cases filed by the Anti-Corruption Commission and National Board of Revenue during the tenure of the last caretaker government. The presidential pardon drew widespread criticism.

The criticism, however, did not lead to a careful exercise of the presidential power of pardon in subse-

quent times. In September, 2010, the president granted pardon to 20 death row inmates of the Jubo Dal leader Sabbir Ahmed Gama killing case. Most of them were Awami League adherents and activists. The clemency again triggered huge hue and cry.

Again, in July 2011, he granted controversial mercy to AHM Biplob, the son of ruling AL leader Abu Taher of Laxmipur and a death row inmate in the much-talkedabout Nurul Islam murder case.

Biplob appears to be a most fortunate man as the president has granted him mercy for the second time in seven months. This time,

Biplob's life sentence in each of two murder cases has been reduced to a 10year imprisonment.

Zillur's predecessor Iajuddin Ahmed had pardoned in 2005 Mohiuddin Jhintu, who was president of the then ruling BNP's Sweden chapter. Jhintu was sentenced to death two decades ago in a

seasoned politician, took over the presidency in February 2009, it was expected that he would work to brighten the image of Bangabhaban. His predecessor Iajuddin badly failed to uphold the dignity and integrity of the office of president, which is not only the symbol of the country's heritage but also plays an important part in the history of Bangladesh.

But the wholesale presidential clemency to ruling party men has pushed the presidency into political controversy, undermining people's expectations of it. And it has also raised questions about the presidential power to pardon, which though, according to legal experts, is necessary for peace and good governance. Article 49 of the

Constitution provides that the President shall have power to grant pardons, reprieves and respite and to remit, suspend or commute any sentence passed by any court, tribunal or other authority.

The philosophy of this the Constitution.

power, according to legal experts, is to afford relief from undue harshness or evident mistake in judicial proceedings. The administration of justice by the courts may not always be wiser or be certainly considerate of circumstances. To provide remedy in such case, the presidential power to pardon is used.

Like other powers, the president has to exercise this power on the advice of the prime minister. So, it largely depends on the prime minister whether s/he wants to contribute to upholding the image of the presidency by averting a mindless use of this extraordinary presidential power to pardon. In that case, the role of the law and home ministries is also crucial.

Similarly, the president

should also do something to avert such unpleasant situations regarding to the use of this power. In granting pardon, the president may use his office to scrutinise the evidence and facts before acting only on the advice of the prime minister. Like the premier, the president also took the oath of the office to preserve, protect and defend

said the culture of "sick politics" prevails in the country because politics has been polluted by black money, arms and muscle power.

"It is not possible to establish democracy by such sick politics. So we will have to cure the politics," he said.

Addressing the roundtable, immediate past election commissioner M Sakhawat Hossain said the next general election is the major challenge for the new EC because it is uncertain under which system it will be held.

"It would be better if the new commission takes forward the task we had initiated during our tenure,' he added.

Another former election commissioner M Sohul Hussain mentioned different activities of their tenure and said they could not strictly enforce several laws apprehending chaotic consequences.

Shujan Secretary Badiul Alam Majumdar placed an 11-point recommendation for amendment to the existing electoral laws.

The recommendations include keeping the provision of 'No' vote in parliamentary elections, making it mandatory for all parties to publish names of all leaders and activists on their website, and giving financial freedom to the EC.

Former adviser to a caretaker government M Hafizuddin Khan moderated the roundtable addressed by, among others, another former adviser ASM Shahjahan and local government expert Dr Tofail Ahmed.
