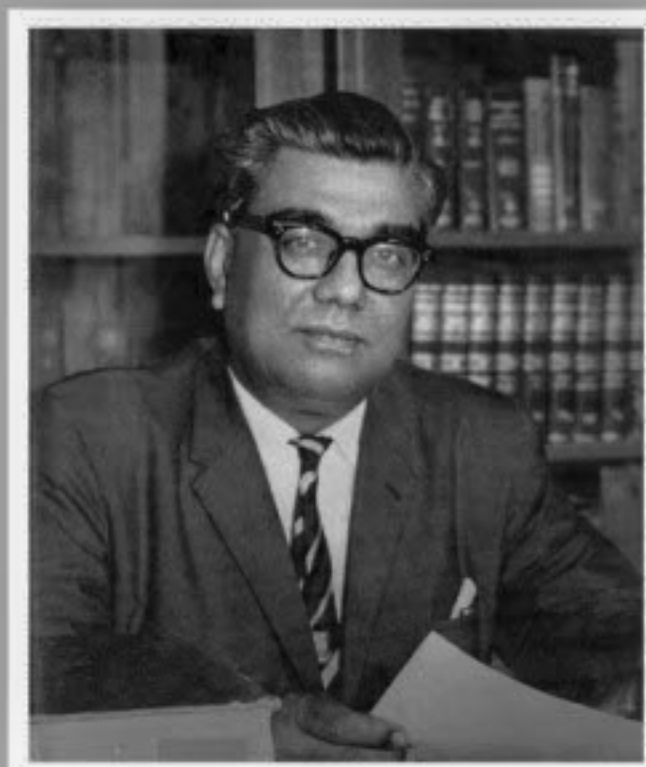


IN REMEMBRANCE OF (LATE) DR. MD. OSMAN GHANI
