Rumour of iron mine in Atrai River in Dinajpur

The banks of Atrai River in Khansama upazila under the district sees thronging of curious people from different areas of Dinajpur and adjacent districts as news about the presence of several hills with iron particles in the river spread in the last two weeks.

During a visit to the spot on Monday, this correspondent saw people collecting 'stone-like' mud from small hills in the riverbed. Many of them were using magnets, confirming the presence of iron in the mud that is much harder and heavier than usual mud.

Such mud and iron particles can be found in a few hills having 'hard to break' rocks with different colours including brownish and black in five kilometre area of Atrai River from Jyontiaghat of Khansama upazila to Dhanirdanga of Kaharol upazila in Dinajpur district, locals said.

"The hills have remained unchanged although river current causes erosion in the area," said Anju Ara Begum, 40, a resident on the riverbank at Guliyara village under Bhabki union of Khansama upazila.

"When a magnet is moved on the sands of the river, it gets covered with particles of iron," said Md

resident of the area.

"Presence of iron particles in the riverbed is now obvious," said Md Shafiqul Islam, chairman of Bhabki union parishad under Khansma upazila, who visited the area several times after hearing

Showing some collected stone-like mud that is much heavier than that from other areas, Nawsad Hossain, a visitor from Thakurgaon district said, "I could not believe it until I saw it myself."

"Primary observation suggests that iron mine may exist in the area. However,

4 tiger poachers jailed, fined in Bagerhat

A Bagerhat court has sentenced four poachers to jail and fined them all in a tiger killing case.

The court also ordered the convicts to pay Tk 25,000 each as compensation for killing the tigers.

Senior Judicial Magistrate Md. Jamal Hossain handed down the judgment on Tuesday afternoon.

The convicts are Jamal Fakir, 38, Hemayet Howlader, 65, Dhalu Molla, 38, of Uttar Tafalbari village and Khair Boyati, 63, of Pachimkhada village in Sharankhola upazila of Bagerhat district.

According to statement of

the case, coastguards and dences during the trial, forest guards in a joint drive in the guise of buyers on February 16 in 2011 recovered three pieces of skin, four skulls and 31 kilograms of limbs of tigers from Banglabazar village of

Sharankhola upazila. Poacher Jamal Fakir, arrested from the spot during the drive, later helped coastguards arrest the three others.

On February 17, forest official KM Kabiruddin of the East Wing of Sundarban Forest Division filed a case against the four poachers under Wildlife Protection Act.

The court, after recording statements of prosecution witnesses with evisentenced accused Jamal Fakir to four and a half years rigorous imprisonment (RI) and fined Tk 25,000, in default, to suffer more six months in jail.

Besides, Khair Boyati is to suffer 30 months of RI and pay a fine of Tk 10,000, in default, to suffer three months more in jail.

Accused Hemayet Howlader and Dhalu Molla got three years of RI. They were fined Tk 15,000 each, in default, to suffer four months more in jail.

Of the convicts, only Jamal Fakir and Khair Boyati were present at the court as the two others remained at large.

Two jail officials, 6 others sued as prisoner dies

Jail superintendent, jailer and six others were sued on Tuesday on murder charge following death of a prisoner of district jail at Dinajpur Medical College and Hospital on January 27 this year.

The accused are Md. Shajahan Ali, Jail Superintendent of Dinajpur, Joynal Abedin, Jailer, Purna Chandra Barman, Krisha Kanta Roy, Jagadish Chandra Roy,

Dinesh Chandra Roy, Amal Chandra and Jagadish Chandra of Dagrai village in Birganj upazila of Dinajpur.

Biren Barman of Shibpur village in the upazila and father of the victim, filed the case with Judicial Magistrate's Court here on Tuesday afternoon.

The court asked the jail officials to be present at the court on March 6 with documents on the dead prisoner.

In the complaint, Biren Barman said his son Rajen Barman, 28, a prisoner at Dinajpur jail died of torture on January 27.

Shilpa Rani, wife of Rajen, was murdered on September 18 last year. Later police arrested Rajen on charge of murder.

He alleged that six relatives of Shilpa Rani with the help of jail authorities including jail superintendent and jailer, tortured his son causing his death at hospital.

Contacted, the jail superintendent and jailer told this correspondent that Rajen died at cardiac arrest.

Meanwhile, a rumour spread that the missionaries were trying to convert Muslims to Christians. At this, a group of local people vandalised the team's car, leaving three members injured. Later, police picked up three people, including Teghoria Madrasa Principal Abdul Barik, for quzzing.

Under trial prisoner dies


Conference on physics held



Man put behind bars for torturing wife over dowry

A court here yesterday sentenced a man to two years imprisonment for torturing his wife for dowry.

The convict is Humayun Kabir, son of Billal Hossain Biswas of Narendrapur village in Sadar upazila in the district.

The court also fined the convict Tk 5,000, in default he is to suffer another three months in jail.

According to the prosecution, Humayun married Sabina Khatun, daughter of late Akbar Ali Biswas of Sirajsinga village in the same upazila on February 7, 2007.

As Humayun put pressure on Sabina for dowry, her mother gave him Tk 60,000. In 2010,

Humayun again demanded Tk one lakh in dowry and tortured Sabina several times as she refused to bring the money.

On March 5 in 2010, Sabina filed a case against her husband with the Court of Senior Judicial Magistrate Abdus Sabur Mia who pronounced the

dent reported that a housewife was beaten to death by the husband allegedly for dowry at Baikari village in Sadar upazila on Tuesday night.

The victim is Fatema Khatun, 18, daughter of Akram Sardar of Alipur Purbo Para village in the upazila.

Police arrested Fatema's husband Mominur Rahman and her brother in law Azizul Islam from Bakal check post area in Sadar upazila yesterday.

In Chapainawabganj, a rickshaw-puller killed his wife following a quarrel at Paikara village under Niamatpur upazila of Naogaon district early yesterday, reports our correspondent.

The dead was identified as, Ahiron Khatun, 22, wife of Nurul Babu, alias Tutul. Shafiul Islam, officer-in-

charge (OC) of Niamatpur Police Station, quoting locals as saying that Tutul picked up a quarrel with Ahiron over a trivial matter at around 1:00am. At one stage, he hit her wife with an iron rod, resulting in her death on the spot. Police

Politics banned at Rokeya University

The ban was imposed following a series of clashes between the activists of Bangladesh Chhatra League (BCL) and Jatiyatabadi Chhatra Dal (JCD) in the last two days.

The VC told this correspondent that stern action would be taken against those trying to continue political activities defying the decision. At least ten people,

including a policeman, were injured during a clash between the activists of BCL and JCD on the campus on Tuesday.

The VC said, although students politics was not allowed on the campus, some organisations took the advantage of liberal attitude of the authorities and spoiled the academic atmosphere.
