### Woman found killed in city house

Police recovered the decomposed body of a woman from inside a locked house at Uttar Kunipara of Tejgaon industrial area in the city early hours of yesterday.

The unidentified woman is thought to be 30.

She was strangled, said sources at Dhaka Medical College morgue.

Sub-inspector (SI) Abdul Motaleb of Tejgaon Shilpanchal Police Station said police recovered the body by breaking open the door. The body was covered in a bed sheet.

Residents of the house said a man introducing the woman as his wife rented the house on March 1. For the last three days, neighbours saw the room locked from outside. As a foul smell spread, they called police.

# ICT order on several petitions March 13

The International Crimes Tribunal will pass orders on March 13 on several petitions, including a discharge petition submitted by BNP leader Salauddin Quader Chowdhury in connection with a case accusing him of committing crimes against humanity during 1971.

The three-member tribunal headed by Justice Md Nizamul Huq fixed the date after both the prosecution and defence completed their arguments on the petitions yesterday.

Salauddin also submitted petitions seeking bail in the above-mentioned case, asking to be transferred from Gazipur's Kashimpur Jail-2 to any other prison and praying to carry out the tribunal proceedings following international covenants.

The Collaborators Act 1972, enacted to try collaborators of the Liberation War in 1971, was revoked through the Fifth Amendment to the constitution but reinstated through the Fifteenth Amendment, said the defence counsels.

This made way for "double jeopardy", meaning double trial for the same offence, which is forbidden by the constitution, they said.

Prosecutor Zead Al Malum argued that though the six cases were filed, the verdicts are yet to be delivered. He appealed to the tribunal to frame charges against Salauddin.

The tribunal will also pass an order today on a petition submitted by former Jamaat-e Islami ameer Ghulam Azam seeking permission to receive home-cooked food in his prison cell at Bangabandhu Sheikh Mujib Medical University (BSMMU).

Ghulam Azam was shifted to the cell after he was sent to jail on January 11 on charges of committing crimes against humanity during the 1971 Liberation War.

## DISTORTION OF HISTORY HC summons Prof Bari Mar 12

#### STAFF CORRESPONDENT The High Court yesterday summoned Prof Ershadul Bari, for-

mer vice chancellor of Bangladesh Open University (BOU), before it on March 12 in connection with a charge of distorting the history of the War of Liberation. During the hearing of a writ petition, the court issued the order

after Dhaka University Pro-Vice Chancellor Prof Harun-or Rashid told it that Prof Bari was responsible for the distortion of history in a textbook he had written for BOU students in 2000. It also requested former Bangladesh Bank governor Farash Uddin Ahmed, senior journalist Manjurul Ahsan Bulbul and BOU Treasurer Shanti Narayan Ghosh, members of a committee formed in 2010 to investigate the incident, to be present before it today and make statements about the distortion of history.

The HC also asked six academics, including Prof Harun, to appear before it today.

The five others are BOUVice Chancellor Prof Aminur Rashid, Prof Shawkat Ara Hossain, Prof Sadiha Sultana, Mahfuza Chowdhury and HM Delwar Hossain.

All except Prof Aminur appeared before the HC bench of Justice AHM Shamsuddin Choudhury Manik and Justice Jahangir Hossain Selim yesterday, petitioner Belal Hussain said. The bench on March 1 asked them to appear before it to

explain their roles in distorting information on the War of Liberation in two textbooks written by them under BOU. Supreme Court lawyers Altaf Uddin Ahmed and Mahmud

Hossain filed the petition with the HC in January 2010, saying that Sociology 2nd paper and Civics 2nd paper of HSC under the BOU termed late president Ziaur Rahman as the individual who had declared the country's independence, although the HC in a verdict in 2009 ruled that Bangabandhu Sheikh Mujibur Rahman had declared the independence on March 26, 1971.

The books also said that Zia was the greatest son of the country and nation, although the HC termed Bangabandhu the greatest Bangalee of a thousand years.
