Sramik Dal leader murdered

President of Moylakanda union unit Jatiyatabadi Sramik Dal was killed by criminals in Shyamganj Railway Station area in Gouripur upazila on Wednesday night.

Victim Shahadat Hossain, 35, was son of late Taleb Hossain of village Moylakanda.

Police arrested Bachchu Miah, 48, son of Abbas Ali of Moylakanda on charge of his involvement in the killing. Bachchu Miah is a maternal uncle of Shahadat.

Quoting family sources, police said that a group, numbering around six, entered the house while Shahadat was taking food at around 9pm.

The criminals picked him up and stabbed him with sharp weapons indiscriminately. Critically injured, he died on the spot.

Shahadat had a dispute over a piece of land with his maternalunclesforlongwhich might be the reason behind the killing, said Khalilur Rahman, a sub-inspector of Gouripur police station.

BSF picks up one from border

Members of Indian Border Security Force (BSF) picked up a young man from Jhalongi frontier in the district yesterday morning.

Border Guard Bangladesh (BGB) immediately sent a letter to its Indian counterpart asking to hand over the man to them, said Nayak Subedar Abdul Khaleque, Jhalongi camp commander of the BGB.

Khaleque quoting locals said that the BSF men at Duyadabri camp in Cooch Behar district abducted 32year-old Jahangir Hossain around 7:30am when he went toworkathis paddy field.

The paddy field is near the no-mans land in Jhalongi border area, Khaleque said.

Quoting BSF at Duyadabri camp he said, they picked up Jahangir when he entered Indian

territory to receive cattle. "Jahangir was held with Indian cattle and BSF will take legal action against him", Khaleque said.

The BSF disclosed this when the Jhalongi BGB camp commander asked their commander verbally about the incident at the time of sending the letter.

Jahangir is the son of one Shobha Miah of Burir Bari village in Patgram upazila of the district.

Journo flees home for 'fear of life'

A journalist in Hatibandha upazila received death threat allegedly from a local Awami League leader following publication of a report on misuse of fund for road repairing work in a newspaper on Saturday.

Iliyas Bosuniya Pabon, correspondent of The Daily Destiny and local daily Juger Alo, filed a general diary (GD) with Hatibandha police station, said Sazzad Hossain, officer in-charge of the police station.

Pabon, also joint secretary of Hatibandha upazila press club, on Wednesday said Alamgir

Hossain Rontu, upazila unit AL joint secretary, along with his party men, numbering 10/12, attacked him at the upazila office premises on the day for publishing the report in Juger Alo.

Hearing the news of filing GD, Rontu become more angry. He along with his men searched my home and other places for me, he told ournalists at Hatibandha press club.

He now does not stay at home for fear of life, Pabon's family members

Rontu, cousin of a state minister, however refuted the allegation.
