### Acid attack on woman

A young woman suffered acid burns on her legs after an alleged unidentified person clad in a burqa threw the corrosive liquid on her yesterday evening at a kitchen market of Mirpur-11 in the city.

Doctors at the burn unit of Dhaka Medical College Hospital said the victim, Suborna Akhter, 22, suffered around four percent burns.

Suborna, owner of a Mirpur beauty parlor, suspects that the attack was carried out by her exboyfriend against whom she had filed a case some months ago for threatening her.

### 'Make TCB corruption-free'

### Legal notice for Ducsu polls

A legal notice has been served on the Dhaka University authorities for taking an immediate step to hold election to Dhaka University Central Students' Union (Ducsu).

On behalf of the 31 university students, Supreme Court lawyer Manzill Murshid yesterday sent the notice to the vice chancellor of the DU, its proctor and treasurer.

The notice said a writ petition would be filed in the High Court against them, if the DU authorities fail to take steps in a week to hold the election.

The notice said thousands of students of the university are being deprived of their democratic rights for not holding Ducsu polls in the last 20 years.

### 10 Hizb-ut-Tahrir men remanded

Ten members of the banned outfit Hizb-ut-Tahrir were placed on a two-day remand each yesterday in a case on charge of creating anarchy across the country.

Metropolitan Magistrate MA Salam ordered the remand after Sub-Inspector (SI) Motlubur Rahman, also the investigation officer (IO) of the case, produced them to the court with a seven-day remand prayer for interrogation.

The detainees are Zayeem Abdullah, his brother Nayeem Abdullah, Robin Miah, Sohel Rana, Parvez Sikder, Towfiq Ashraf, Zahid Hasan, Mahmudul Alam Anik, Nurul Amin Emon and Tanveer Hossain.

In the forwarding report, Motlubur said the arrestees were involved with creating anarchy across the country. So, they need to be remanded to find out whereabouts of their accomplices who were also involved with the activities, he

### Stop extra-judicial punishment: HC

The High Court yesterday directed the inspector general of police (IGP) to issue a notification to all police stations for taking action against extra-judicial punishments taking place in the name of arbitration.

During the hearing of a rule, the court asked the IGP to mention in the notification that the police would have to record cases without any written allegation of such punishments. It ordered the LGRD secretary to issue another notification to

inform all local government bodies, including union parishads and municipalities, that their representatives cannot punish anybody in arbitration which is a punishable offence.

The HC bench of Justice AHM Shamsuddin Choudhury Manik and Justice Jahangir Hossain Selim also asked the information secretary to broadcast the directives through media.

The bench had issued the rule on February 22 following a report published in Prothom Alo stating that a woman and her husband's friend were lashed a total 101 times in an arbitration in Naogaon for "having an extramarital affair."

## President urges EC to work neutrally

President Zillur Rahman yesterday urged the newly formed Election Commission (EC) to work independently and neutrally. He was talking to the five-member Election Commission, in

Bangabhaban on a courtesy call, the first since their formation on February 8, led by Chief Election Commissioner Kazi Rakibuddin Ahmad. On his return to the Secretariat, Election Commissioner

Shahnewaz said, "We informed the president about the ongoing activities of the Election Commission" and holding polls to the bifurcated Dhaka City Corporation in the last week of May.

On the use of electronic voting machines (EVM) in national and local polls, he said, "The president encouraged the EC to use the EVM." However, he said the EC was yet to take a decision on the use of EVMs in the next parliamentary polls.
