# Patients suffer as docs at hospital on strike

Doctors at Jhenidah Sadar Hospital went on an indefinite strike following an attack by family members of a patient who died at the hospital Tuesday.

The strike caused untold sufferings to scores of patients who came to the hospital from far away places of the district.

Dr Rashed Al-Mamun, residential medical officer of the hospital, said eight people, who met a tragic road accident, were admitted to the hospital at around 7:00pm on Tuesday.

Of them, Kamrul Hossain, 9, son of Abul Hossain of Narayanpur village in Sadar upazila, succumbed to his injuries at around 7:30pm.

"As the news spread, family members of Kamrul rushed in and ransacked the hospital", he said.

"They vandalised emergency room and damaging equipment and a lot of medicine".

The indefinite work abstention would continue until the attackers are brought to book, said Rashed Al-Mamun.

Victim's father alleged that his son died due to negligence and demanded exemplary punishment of the on-duty doctor.

Refuting the allegation, on-duty doctor Ali Hasan Farid said the boy died because of excess bleeding.

Hazera Khatun, an outdoor patient of Chandpur village, said she brought her ailing daughter to the hospital, but no doctor came to treat her.

"What will I do now?" She posed adding she did not have the ability to consult a private physician.

Contacted, Civil Surgeon Nasrin Sultana said a three-member probe committee would probe the incident.

She also said that the duty doctors did not show negligence to any patient.

# 'Arrest UP chairman for torturing wife'

Hundreds of women held a rally and demanded immediate arrest of a UP chairman in Hatibandha upazila who allegedly tortured his wife, mother of four daughters, for failing to mother a male child.

The rally held under the banner of Woman Development Committee, was brought out from Gotamari Bazar and ended at the premise of UP office in the upazila yesterday noon.

They would call tougher programmes if Abdul Jalil, chairman of Gotamari

union parishad, is not arrested by a week, said Mukti Rani, vice chairman of the upazila.

Jalil has insulted all the women of the country through torturing his wife, said Nurunnahar Begum, a member of the committee.

On March 4, Shamsunnahar Begum, 38, also an assistant teacher at Sonar Deghee Registered Primary School, was beaten up by her husband at Gotamari village for failing to mother a baby boy.

Later, the daughters of the victim admitted her to the local upazila health complex with serious injuries.

# Upazila chairman beat up Gangni education officer

Gangni upazila chairman in Meherpur allegedly beat up the Upazila Education Officer over election schedule of Gangni Pilot High School on Tuesday afternoon.

School sources said, education officer Narendranath Moitra was recently nominated election commissioner by Gangni upazila nirbahi officer (UNO) to conduct the election of the school.

Accordingly, Narendra declared election schedule in all eight posts of the governing body on March 4.

As per rules, Monday was last date for submitting nomination papers.

Mosarraf Hossain, former president of the school governing body, also present president of Gangni upazila unit Jubo League and his panel submitted nomination papers to contest in all eight posts.

The election commission on Tuesday declared Mosarraf and his panel winner as nobody submitted nomination papers against his panel.

The incident angered upazila chairman advocate Shafiqui Alam, also joint secretary of Meherpur district Awami League.

Shafiqui intercepted education officer Narendra in the bazar area when he was returning home after office at about 5.30pm.

Witnesses said Shafiqui and his men beat up Narendra there and asked him to leave the upazila immediately.

"I have informed the matter to the Deputy Commissioner and higher authorities of my department," said Narendra.

After the incident, the upazila chairman arranged a press conference at his office at about 7.30pm where he refuted the allegation of beating up the education officer.

"I am the upazila chairman. I asked the education officer to explain the entire process of the election. As he showed bad temper, my people abused him," said Shafiqui when this correspondent talked to him over phone on Tuesday night.

Deputy Commissioner (DC) Shahan Ara Banu said they have informed the the matter to higher authorities.

### Fratricide in Noakhali

A man was killed by his younger brother over land dispute at Dharmapur village in Sadar upazila on Tuesday. The deceased was Abul Kashem Liton, son of late Mosharaf Hossain of the village. Police at Sudharam Model PS said there was a long standing conflict between Abul Kashem Liton and his younger brother Mostakin Sarwar Rahat over the ownership of lands. On Tuesday, Liton picked up an altercation with Rahat at about 3.30pm. At one stage Rahat hit Liton on his head with a stick, leaving him critically injured. He was rushed to Noakhali General Hospital where he succumbed to his injuries. Rahat went into hiding after the incident.

### Sand trader murdered

Police recovered the body of a sand trader from near the Karatoa River at Takherhat point under Baderganj upazila yesterday morning. The deceased was identified as Mahbubar Rahman, 40, of Balaarhat under Parbatipur upazila in Dinajpur district. The relatives of the victim alleged that a number of local criminals waylaid him while he was coming home on a motorbike. They tied his neck with rope and killed him. Later, they dumped the body near Karatoa. They also took away the motorbike.

# Man jailed for keeping arms, 2 women for drug peddling

UNB, Sylhet

A court here on Tuesday convicted a man and awarded him life imprisonment for possessing arms.

The convict was identified as Gias Uddin Sanu, 27, son of Chan Mia of Chhabria Majkandi village in Jakiganj upazila.

According to the prosecution, Rab-9 members arrested Sanu and recovered three foreign revolvers from his possession on November 28, 2007.

A case was filed with Jakiganj PS against him under the Arms Act.

After examining the records and witness, Judge M Manzurul Haque of Additional District and Sessions Judge

Court-3 handed down the verdict.

In Bogra, a mobile court on Tuesday sentenced two female drug peddlers to two years imprisonment each for possessing heroin.

The convicts were identified as Shaheda, 35, wife of Mohammad Bhasha and Rasheda, 32, wife of Azgar Ali of Betkher village of Sherpur upazila.

Police said on secret information they raided the houses of Shaheda and her neighbor Rasheda and arrested them along with 50 small packets of heroin.

Later, they were produced before the mobile court led by UNO Manzur Alam who awarded the punishment.

Locals said they were involved in drug peddling since long.
