# Taliban scrap peace talks

Karzai calls for Nato troops withdrawal to bases



Afghanistan's President Hamid Karzai called for Nato troops to leave Afghan villages after 16 civilians died in a shooting rampage by a US soldier, underscoring Afghan fury over the massacre and clouding US exit plans.

In a near-simultaneous statement, the Taliban said they were suspending nascent peace talks with the United States seen as a strong chance of ending the country's decade-long war, blaming "shaky, erratic and vague" US statements.

Karzai, in a statement from his office after meeting US Defense Secretary Leon Panetta, said as a result of the weekend massacre, "international security forces have to be taken out of Afghan village outposts and return to (larger) bases".

The soldier accused of carrying out the shooting was based at a small special forces compound similar to others around the country which underpin Nato's counter-insurgency strategy ahead of a 2014 deadline for most



Western combat forces to pull out.

Karzai said the incident had harmed relations between Afghanistan and the United States and said "all efforts have to be done to avoid such incident in the future", warning it also had hurt the trust Afghans had in foreign forces.

US and Taliban negotiators were

believed to have had preliminary contacts aimed at establishing an office for the Taliban in the Gulf state of Qatar to launch peace negotiations.

"The Islamic Emirate has decided to suspend all talks with Americans taking place in Qatar from (Thursday) onwards until the Americans clarify their stance on the issues concerned and until they show willingness in carrying out their promises instead of wasting time," the group said in a statement.

The Taliban also said talks with the government of Karzai's government were pointless and none had taken place.

Earlier on Thursday, a senior US commander defended moving the American soldier accused of the Kandahar village killings to a military detention centre in Kuwait, saying it would help ensure a proper investigation and trial.

Furious Afghan civilians and members of parliament have demanded the staff sergeant be tried in Afghanistan over the shooting, one of the worst of its kind since US-backed Afghan forces toppled the Taliban in late 2001.

Damascus, security forces broke up scattered anti-regime protests, according to the Local Coordination Committees, which organise demonstrations on the ground.

The Observatory, meanwhile, said 23 mutilated corpses were found near the protest city of Idlib in northwest Syria that was seized by regime forces earlier this week.

It said the victims had been blindfolded and handcuffed before being shot dead and the bodies dumped outside Idlib, in an apparent repeat of a "massacre" of dozens of women and children in the flashpoint city of Homs last weekend.



try said about 1,000 Syrian refugees, including a defecting general, had crossed into the country in the past 24 hours. Ankara accused the Syrian leadership of

planting landmines near its border with Turkey along routes used by refugees. Turkey's Red Crescent chief, Ahmet Lutfi

Akar, warned that up to 500,000 Syrians may cross into the country seeking refuge from the bloodshed.



## Senior China leader sacked in rare scandal

China's ruling Communist Party yesterday fired Bo Xilai, a charismatic leader famed for pushing a "red revival", in a move that exposes ideological rifts during a generational power handover.

In a highly unusual public rebuke, Bo's removal as party chief of the metropolis of Chongqing was announced a day after Premier Wen Jiabao delivered his strongest call yet for political reform in the country of 1.3 billion people.

Bo's removal was announced in a brief dispatch on the official Xinhua news agency that said he had been replaced as Chongqing party secretary by vice-premier Zhang Dejiang, and gave no reason for his dismissal.

But analysts said that Bo had alienated liberals in the party with his hardline crackdown on corruption in Chongqing, a southwestern city of more than 30 million people.

The 62-year-old former commerce minister had been seen as one of the leading contenders to join the Communist Party's Politburo Standing Committee -- the ninemembered body which effectively run China -- later this year.

Bo's political future was plunged into doubt last month when Wang Lijun, the former Chongqing police chief who ran the corruption crackdown, visited a US consulate and reportedly asked for asylum.

Court. He has always insisted that President Asif Ali Zardari is immune from prosecution as president and says the cases against him are politi-

"If I write a letter it will be a

violation of the constitution, which is treason and which carries the death sentence,' Gilani told PhD students in central Punjab province, with a few in the audience shouting "do not write, do not write". "If I don't write, I will be

convicted for contempt, the punishment for which is six months' imprisonment," Gilani said.

"It's better to face six months' imprisonment than face the death sentence.' Pakistan's top court last week ordered

Gilani to ask Switzerland to reopen corruption cases against Zardari by March 21.
