Dipu hopes for better relations with Myanmar

Foreign Minister Dipu Moni hoped that bilateral relation with Myanmar would be more positive and constructive after the landmark verdict on maritime boundary issue, as the row between the two countries settled in a peaceful way.

She was speaking yesterday in parliament informing the people about the country's victory in the maritime boundary dispute with Myanmar.

Bangladesh on March 14 won a landmark verdict at the International Tribunal for the Law of the Sea, which sustained its claim to 200-nautical-mile exclusive economic and territorial rights in the Bay of Bengal rejecting the claims of Myanmar.

During her speech, Dipu said the government will not hesitate to take any "brave decision" in future to protect the country's interest.

Two held with Indian currency

Rapid Action Battalion (Rab) yesterday seized around 59.95 lakh Indian Rupees from a local hotel in the city's Uttara and arrested two persons, including a Pakistani national, in this connection.

They are Mohammad Moyeen Uddin, 40, of Korongi in Karachi in Pakistan, and Shafiqur Rahman alias Arif, 37, of Chandpur in Bangladesh.

Commander M Sohail, director of Legal and Media Wing of Rab, said, while raiding a room of Hotel Najar Valley at Sector-4 in Uttara, they arrested the duo and recovered the currencies from the room.

Three brickfields fined Tk 11 lakh

Enclave people on hunger strike

People of 111 Indian enclaves yesterday started an indefinite hunger strike in Panchagarh to press home their three-point demand, including immediate implementation of the 1974 Indo-Bangla land boundary agreement.

The programme started at 4:00pm alongside the Dhaka-Panchagarh highway adjacent to Puthimari Indian enclave in Boda upazila. They also demanded that the two governments ensure

fundamental rights of the enclave people of both the sides and free movement with passports to perform religious rituals. The leaders said they would continue pressing their

demands until those are met. About 200 people, including women and children coming from different enclaves, are taking part in the fast.

The people are living in awful conditions in the enclaves amid lack of adequate employment opportunity, infrastructure, educational institutions, electricity, medical facilities and security, they added.

Leaders of the Bangladesh Chapter of India-Bangladesh Enclave Exchange Coordination Committee (IBEECC) declared the programmeatapress conference in Panchagarh town on Saturday.

The speakers said they were frustrated at no timeframe mentioned for exchange of the enclaves during Indian Prime Minister Manmohan Singh's visit to Bangladesh in September last year, when a protocol was signed to implement the 1974 land boundary agreement, also known as Mujib-Indira accord.

Left-leaning political parties of India including CPI (M) and Revolutionary Socialist Party (RSP), and human rights group APBRA extended their support to the programme, IBEECC Deputy General Secretary Diptiman Sengupta told The Daily Star.

Moinul Hossain, president of IBEECC's Bangladesh Chapter, General Secretary Golam Mostafa, enclave leaders Sirajul Islam, Mofidar Rahman and Bikash Roy also addressed the programme.

TORTURE ON STUDENTS : HARASSMENT ON CHALLENGED STUDENTS

HC summons teachers Report on govt steps: HC

The High Court yesterday directed the government to submit a report to it on the steps taken to stop harassment of and discrimination against challenged students in educational institutions as early as possible.

The court also issued a rule upon the authorities concerned to explain in four weeks why their inaction to formulate a policy to prevent such acts should not be declared illegal.

Secretaries of the ministries of home affairs, education health and social welfare, National Disability Welfare Coordination Committee, Rajshahi University vice chancellor and registrar, inspector general of police, director of health service and Bogra Saheed Ziaur Rahman Medical College principal were made respondents to the order and rule.

The HC bench of Justice Farid Ahmed and Justice Sheikh Hassan Arif came up with the order and rule after the hearing of a writ petition, filed on February 12 seeking directive on Selim also issued a rule upon the authorities to stop such acts.

It was jointly filed by Bangladesh Legal Aid and Services Trust (BLAST), Manusher Jonno Foundation, Centre for Disability in Manikganj to explain why Development, Shankar Chakrabartee, father of a challenged student, and Tanjim Al Islam, a Prothom Alojournalist.

Crimes by Rajshahi police on rise

Negligence of commanding officers blamed

Rajshahi policemen are increasingly engaging in crimes, a trend being encouraged by the negligence of the commanding officers, said law enforcers investigating such crimes.

Around 13 policemen of Rajshahi district and Rajshahi Metropolitan Police (RMP) has been suspended from August till date on charges including extortion, drug trade and even assault on female officers. A recent probe into the alleged assault of

a female constable revealed that a Superintendent of Police (SP) granted leave to the accused though he was scheduled to appear the next day before the officer investigating the case. The constable of Rajshahi district

Detective Branch (DB) filed the complaint with Rajshahi Deputy Inspector General (DIG) Siddigur Rahman on March 12, the same day the assault took place. In the complaint statement, she said DB

Sub Inspector (SI) Shafikur Rahman Mridha, who had been harassing her for the past one month, tried to violate her in Hossain, officer-in-charge (OC) of DB, the office. She feared that SP SM Rokon Uddin

would ignore her complaints as he had done so over previous complaints of four female constables, for he and the SI were on good terms, said the complainant. The SI was suspended that very day and

Additional DIG Nibash Chandra Majhi, investigating the allegation, on March 13, asked the accused and the complainant to appear before him on March 14. But the SP granted the SI medical leave

on March 13 though he knew the accused was scheduled to appear before the additional DIG the next day. The SI went to Dhaka to try to influence

the higher authorities in his favour, fears the complainant.

SP Rokon defended his actions, saying that he had no other option as doctors at Rajshahi Police Hospital had referred the SI to a hospital in Dhaka for the treatment of "severe chest pains".

On why the SI was not taken to Rajshahi Medical College Hospital which has a unit

specialising in such health ailments, SP Rokon said, "It is a matter for the doctors."

"Besides, it is good that he went to Dhaka. Otherwise, he would have tried to influence the witnesses and the investigation," he added.

On the allegation of ignoring the complaints of female constables, he said, "I did not get any (complaint)."

When Additional DIG Nibash was asked what they would do over the allegations against the SP, he said the matter was still under investigation.

Another crime came to light on March 2 when a narcotics control taskforce arrested three RMP DB constables carrying 954 bottles of smuggled Indian phensidyl from a drug trading spot in Rajpara area of Rajshahi. A case was later filed.

The three had seized the bottles from Tangon, a drug-smuggling zone under Motihar Police Station, in a raid and, instead of going to DB office, were taking them to the drug trading spot.

However, a Special Branch (SB) report following the incident held Tofazzal

responsible for it. Tofazzal had taken verbal permission from SB Assistant Commissioner M Rokonuzzaman to carry out the raid but did

not provide any update on the outcome. The four were suspended after Tofazzal presented a false command certificate and

the constables revealed that he had ordered the sale of the drugs. In another incident, an RMP assistant commissioner, Towfiqul Islam, and seven other police personnel were arrested at the Police Lines on August 22, 2011, hours after

an extortion case had been filed against them. A doctor, Rafiq Basunia, had filed a complaint against the policemen five days earlier, stating that the policemen realised

Tk 1 lakh from him after threatening to harass him over false accusations of illegally storing Indian garlic. RMP Commissioner M Obaidullah said,

"Judgment in the departmental cases will be given after the court judgements in both the cases."

290 small vessels seized in Buriganga

The Bangladesh Inland Water Transport Authority (BIWTA) with the law enforcement agencies in a drive seized at least 290 cargo vessels and boats in the Buriganga River yesterday.

BIWTA sources said Coast Guard, Rab, maritime police and BIWTA officials conducted the drive from Jazeera under South Keraniganj to Kholamora under Keraniganj Model Police Station from 7:00pm to 9:00pm. The drive would continue overnight.

They intercepted and seized 100 cargo vessels, 120 sand-loaded Belgrade and 60-70 engine-propelled goods-laden boats in two hours till 9:00pm on charge of plying in the river at night violating government order.

Locals alleged that the cargo vessels were plying after sunset in the river by managing a section of officials of the concerned department and some members of the lawenforcement agencies with money.

Earlier, the BIWTA imposed ban on plying cargo vessels and goods carrying water crafts at night to ensure a safe river zone.

The authorities issued warning that tougher action will be taken against cargo vessels and motorized boats if they defy the ban in future.

Rab nabs 3 'arms traders' after gunfight

Rapid Action Battalion (Rab) arrested 3 alleged arms traders at Char Kishoreganj in Munshiganj after a gunfight yesterday night.

The arrestees are Shahid, 28, Russel, 25, and Aziz, 23, all hailed from Char Kishoreganj.

Mejor Badruddoza, deputy director of Rab-3 in Dhaka, said Rab-3 personnel went to the traders to purchase arms in guise of customers.

However, sensing the presence of the elite force, the traders opened fire on Rab men, who also retaliated triggering a gunfight, he said.

Among the trio, Shahid sustained bullet injury in his leg and was admitted to Sadar Hospital where he is taking treatment now, he

added.

BHASHANTEK PROJECT

Flats handover demanded

Affected flat owners of the city's Bhashantek housing scheme yesterday demanded the land ministry handing over their respective flats immediately.

Otherwise, they said they would go for demonstration, forming human chain and observing fast unto death, if their demands are not met within two weeks. They were speaking at a press conference under the banner "Low income and slum dwellers rehabilitation council" at the Jatiya Press Club.

They also protested the alleged move to turn the designated community centre of Bhashantek Punarbashan Prokolpa (rehabilitation project) into a police station.

Zahirul Islam Masum, one of the flat owners, while reading out a statement, said only 1,100 out of around 4,500 applicants were handed their apartments so far while the rest are passing days in uncertainty and anxiety. The land ministry hired a private developer, North South

Property Development Ltd, to build 15,024 flats for the low income groups and slum dwellers. But the ministry dismissed the contract with the developer on allegations of anomalies around two years back

when the project was half way through, said Masum. Meanwhile, each flat applicant paid Tk2 to 8 lakhs to the developer depending on the size and category of the flats

Demanding investigation into the anomalies in the project, the speakers said the project caused untold sufferings to the flat owner's due to a corrupt section of the land ministry officials interfering with the project's implementation.

BSF obstructs Bangladeshi farmers to work

Indian Border Security Force (BSF) stopped farmers to cultivate vegetables inside 1,000 yards of Bangladesh land boundary at Padua border in Goainghat upazila on Friday morning.

Sources said more than 20/30 BSF jawans forcibly entered inside the Bangladesh territory and obstructed farmer Sadek Mia from working in vegetable field at about 10:00am.

At that time, Protappur Border Guard Bangladesh (BGB) members went to the spot and decided to hold a flag meeting.

The BGB and BSF held a flag meeting at No 1271 main pillar in the area at about 11:00am on Saturday.

BGB Company Commander Riaz confirmed the incident of BSF obstruction. He said the both sides at the flag meeting decided to stop cultivation in the disputed land for maintainingpeace at the border.
