

Mulayam Singh hints at early polls in India

Samajwadi Party chief Mulayam Singh Yadav yesterday spoke of the possibility of parliamentary elections in India earlier than scheduled in the year 2014.

"There is no guarantee when the Lok Sabha elections may take place," he said at a party function in Lucknow city, asking his son and Uttar Pradesh Chief Minister Akhilesh Yadav to implement the party manifesto and bring "visible changes" within six

months. Samajwadi Party's spectacular victory in recent assembly elections in India's biggest state Uttar Pradesh and India's ruling Congress' poor show in the polls in three other states recently had given rise to murmurs about the possibility of snap parliamentary elections.

Mulayam said that era of big parties ruling the country is over and coalition politics will play a major role in the coming election as well. So far, Mulayam has been cooperating with the UPA government but giving it outside issue based support but now he has hinted that the Congress cannot take SP's support in parliament for granted.

TENSIONS OVER N KOREA ROCKET LAUNCH

Japan prepares defences, UN warns over food aid

Japan yesterday readied its missile defence systems to shoot down a North Korean rocket if it threatens the country, as the UN chief warned that next month's launch could jeopardise food aid.

"I have ordered officials to prepare to deploy the PAC-3 and Aegis warships," Japan's Defence Minister Naoki Tanaka told reporters, referring to surface-to-air missiles and destroyers carrying missiles.

The nuclear-armed North has announced it will launch a rocket in mid-April to put a satellite into orbit, a move that the United States, South Korea and other nations see as a pretext for a longrange missile test banned by the UN.

The move by North Korea's new leadership has set off alarm bells across the region. The Philippines is calling for

help from the United States to monitor the rocket, part of which is expected to land off the archipelago.

Amid mounting tensions, North Korea's main ally China urged that "all parties should keep calm and exercise restraint", while a special adviser to US President Barack Obama warned any launch will generate a "strong response.

"If they go ahead anyway, we will want to work with our allies and partners for a strong response," Gary Samore, arms control coordinator at the National Security Council, told South Korea's Yonhap news agency in an interview.

The preparations by Japan, regularly the target of North Korean barbs, come as world leaders including Obama prepare to meet in Seoul for a summit officially focused on nuclear terrorism.

The North's atomic programme is expected to be the subject of discussion at the talks on Monday and Tuesday, which are also to be attended by the leaders of China, Japan and Russia.

Leading North Korean newspaper Rodong Sinmun yesterday again blasted the upcoming summit as a "burlesque" and part of a South Korean smear campaign.

It said Seoul's rulers hope to use the event to escalate the "nuclear racket" against the North and moves for a war against it.

UN Secretary General Ban Ki-moon, who plans to raise the rocket launch at the Seoul summit, said any launch could discourage international aid donors and worsen North Korea's already dire humanitarian situation.

Latifa Begum said the same culprits carried out the attack around 10:30pm on Thursday when Api was sleeping at the house.

ISRAELI SETTLEMENTS

UN rights body orders first probe

The UN Human Rights Council on Thursday passed a resolution ordering a first probe into how Israeli settlements may be infringing on the rights of the Palestinians.

The resolution was adopted by the 47-member council with 36 votes in favour and 10 abstentions. Only the United States voted against it.

Beyond ordering an investigation into the implications of settlements, the resolution also calls on Israel to "take and implement serious measures" such as confiscating arms to prevent acts of violence by Israeli

Condemning Israel's announcements of new settlement homes, it demanded a reversal of the policy.

The Palestinians welcomed the resolution as a "new victory."

But the move drew immediate rebuke from Israel. Israeli Prime Minister Benjamin Netanyahu slammed the move as "hypocritical".

The United States also spoke up against the move, saying it was "deeply troubled by this council's bias against Israel."

Israel's move to expand settlements has been criticised by the international community, which deems the action illegal.

Afghan massacre suspect charged

A US soldier is expected to be charged with 17 counts of murder yesterday over the killings of mostly women and children in a shooting rampage in southern Afghanistan. A US official confirmed the murder charges on

condition of anonymity and said Army Staff Sergeant Robert Bales, 38, would also be charged with six counts of assault and attempted murder.

In Kabul, a senior US official said it had "pretty much been decided" the trial would be held in the United States, but furious relatives of the victims demanded the proceedings take place in Afghanistan instead.

Libya-Iraq diplomatic ties restored

Libya has restored full diplomatic relations with Iraq and plans to send an ambassador to Baghdad more than eight years after cutting off ties, Iraq's deputy foreign minister said yesterday.

"There was a delegation that came here, and they said that this decision is under discussion at the foreign ministry in Libya and this step will be taken soon, and they took that step yesterday," Labid Abbawi told AFP.

Abbawi was referring to a visit to Baghdad by then Libyan interim premier Mahmud Jibril in October.

Pope in first Mexico, Cuba trip

Pope Benedict XVI sets off on an arduous journey to Latin America yesterday where he will address key issues including the war on drugs in Mexico and the evolution of the communist regime in Cuba.

In his first trip to Spanish-speaking Latin America, the pontiff, who turns 85 next month, will visit Silao, Leon and Guanajuato in Mexico from March 23 to 26, before heading on to Santiago de Cuba and Havana in Cuba for two days.
