Schoolboy 'killer' remanded

The Detective Branch (DB) of Police yesterday placed the alleged killer of eight-year-old schoolboy, Sifat Ali Tanmoy, on a three-day remand for interrogation.

Zahirul Islam, who said to have admitted the killing, was produced before a Dhaka court with a 10day remand. He was arrested Wednesday.

The victim's father, Hazrat Ali, demanded the cause behind the killing be exposed and the killer be given exemplary punishment. Tanmoy's body was found stuffed inside a bag in Zahirul's room on Wednesday, two days after he had gone missing.

The boy used to spend time playing games on the computer of Zahirul, who was a tenant in Hazrat Ali's two-storey building in the city's Darussalam area.

Water bottling factory owner jailed

HSC exams begin on Sunday

Higher Secondary Certificate (HSC) and its equivalent examinations begin on Sunday with 9,26,814 examinees appearing in 2,916 centres across the country.

Although the number of examinees rose by more than 1.47 lakh this year, around 1.70 lakh students of class XI will not sit for the exam owing to not registering for the exams.

Some 4,96,395 male and 4,30,419 female students of 7,556 educational institutions will appear under 10 education boards, including madrasa and technical boards.

The exams will also be held in four overseas centres in Doha, Abu Dhabi, Jeddah and Riyadh for 179 candidates. Physically challenged students will get an extra 20 minutes in the exam.

Among the examinees, some 7.56 lakh are regular students while over 1.60 lakh are irregular. Besides, 4,685 are private examinees and some 4,419 are giving improvement exams.

Announcing the figures at a press briefing at the Secretariat yesterday, Education Minister Nurul Islam Nahid said necessary measures had been taken to ensure a peaceful environment at the examination centres. "Increase in the number of

examinees is a positive trend for our education system," he said. Bangla First Paper, based on creative question method, the first time in the HSC exams, will be held on the first day. The written exams will end on May 20. The practical exams will be held from May 23 to June 6.

Around 7.50 lakh students will take the exam under eight general education boards; 85,226 students will take Alim exam under Madrasa Board; and 86,415 students will take Business

Management exam under Technical Board. Besides, 4,321 students of Diploma in Business Studies will sit under the Dhaka board.

As in previous years, the highest number of examinees, 2.35 lakh, will appear under the Dhaka board while the lowest, 37,743, will appear under the Sylhet board.

Yesterday, some students gathered before the Dhaka Board office, some claiming that they had not been provided with admit cards while others said theirs had errors in them.

Dhaka Board Chairman Prof Fahima Khatun blamed the irresponsibility of the college principals and the students for the complications regarding the admit cards.

No more than 50 students were facing such difficulties. They will get their admit cards as the office will remain open today and on Saturday, she said.

ROOPPUR NUCLEAR POWER PLANT

Draft law on realising compensation okayed

The cabinet yesterday approved a draft law with a provision for realising compensation from the operator of the country's first-ever nuclear power plant at Rooppur in Pabna for any damage due to accident.

According to the draft Bangladesh Atomic Energy Control Act-2012, the claim of damage will have to be filed within ten years after the accident and disposed of within 50 years, Cabinet Secretary M Musharraf Hossain Bhuiyan briefed reporters after the meeting.

The council of ministers on January 2 approved the draft in principle. The 2000MW plant will be constructed with the assistance of Russia.

The draft also has a provision on formation of a separate regulatory body since there is no such institution and legal framework at present, Musharraf said.

The five-strong regulatory authority

headed by a chairman will supervise the activities at the plant. Moreover, an advisory panel consisting experts will also be formed.

Besides these, the draft act also covers a

wide range of issues including security and safety measures against radiation and management of nuclear plant, the cabinet secretary added. The meeting yesterday also revised the

implementation date of National Wage Scale for the workers of state-owned mills and factories with effect from July 2009. The arrears will have to be paid in four equal instalments -- from September 2012 to December 2013.

Under the new scale, the maximum basic salary of a worker would be Tk 5,600 while Tk 4,150 would be the minimum wage including 50 percent house rent and other allow-

Pakistani journos welcome war crimes trial, urge Islamabad to seek apology

Pakistanis specially journalists welcomed Bangladesh's initiatives to try 1971 war criminals and urged their government to seek formal apology for their misdeeds.

Three Pakistani journalists and an NGO activist hold the same opinion in exclusive interviews with the news agency on the sidelines of an international conference held in Sri Lanka recently.

"We still feel sorry for the misdeeds of Pakistani forces in 1971," said Saleem Saikh, a senior journalist of widely circulated newspaper Dawn.

He said a formal apology by the Pakistan government for misdeeds in 1971 could smoothen the way for promoting friendly relations between the two countries.

Echoing the same, journalist Amar Guriro of Pakistan Today said, "The Pakistan government should hold a symbolic trial of the members of Pakistani troops, who are still alive, as they did crimes against humanity in 1971."

"There is still scope to try the Pakistani soldiers, who committed crimes during the Liberation War of Bangladesh in 1971 as the war criminals of the Second World War are

Decision on Ghulam Azam's indictment April 17

The International Crimes Tribunal-1 yesterday fixed April 17 to decide whether it would indict former Jamaate-Islami chief Ghulam Azam on 62 charges of crimes against humanity that he allegedly committed during the 1971 Liberation War.

If indicted, Ghulam Azam will face trial at the tribunal which was formed to deal with such crimes.

The three-judge tribunal headed by Justice Md Nizamul Huq fixed the date after both prosecution and defence presented their arguments over the charges.

The 89-year-old, arrested on January 11, was produced before the court yesterday. The formal charges accuse Ghulam

Azam of planning to commit atrocities, incitement, complicity and murder. They also say that he had exclusive control over the auxiliary forces, including the peace committee, Al Badr and Al Shams, which were formed to oppose

Bangladesh's liberation. The chief defence counsel, Abdur Razzaq, argued that Razakar, Al Badr

and Al Shams, among other fronts, were organised by Jamaat and Islami Chhatra Sangha, its student front.

So these were not auxiliary forces as the International Crimes (Tribunal) Act of 1973 says that auxiliary forces are those which are directly under the control of the Pakistani army, he said. Prosecutor Zead Al Malum, in his

counter arguments, said the Pakistan central government had issued a gazette in 1971 certifying Razakar, Al Badr and Al Shams as auxiliary forces of the court for the indictment. the Pakistani army. This gazette was read out by Prime

Minister Sheikh Hasina as opposition leader in 1992 in Parliament, urging the government to try Ghulam Azam and the other collaborators, he said.
