Hundreds join Sindurmoti fair in Lalmonirhat

Traditional Sindurmoti Fair was held at Panchogram union in Sadar upazila yesterday.

Hundreds of Hindu devotees from different areas of greater Rangpur and other parts of the country and also from India poured into the daylong fair that took place beside Sindurmoti pond.

Sindurmoti pond was dug by a Brahmin Zamindar a few hundred year ago. It is now regarded as a holy site by the Hindu community.

Devotees prayed at a temple there and took holy dip in the pond. They believe that bathing in the

pond water brings peace and purity in their life.

Dr Subhas Chandro Roy, president of the Sindurmoti Fair Celebration Committee, said the fair began around 300 years ago.

The fair is being held in the Bangla month Chaitra or on the first day of every Bangla year, he added.

Devotee Basonti Rani Roy, 50, said she had been coming to Sindurmoti fair for the last 20 years.

"I got divine peace by attending the fair. While bathing in the pond, I

prayed to the Almighty for the peace of the departed souls of my parents", said another devotee, Atul

Chandro Roy, 55.

Monoranjan Nath, 65, who hails from Gidaldah village under Dinhat police station in Coochbehar district of Paschim Banga, said he along with many other Indian devotees had been attending the fair every year to seek divine peace. "We feel great after bathing in the water", he said.

Muslims of the region also come to the fair for joining the festival and purchasing different goods.

Mokaddes Ali, 45, said a number of Muslim people from nearby villages come to the fair venue every year as it is now a part of their tradition.

ABDUCTION FOR RANSOM

'Bring killers of schoolboy Jewel to book'

A human chain was formed at Chowrangi intersection of Panchagarh-Dhaka highway in Panchagarh town yesterday, demanding harsh punishment to the culprits who abducted and killed primary school student Jewel on 26 March for ransom.

Jatiya Ganatantrik Party (Jagpa) organised the programme which was participated by scores of women and children of the victim's villages.

Earlier a procession paraded different streets of the town.

Quoting arrestees' confessional statement, sub-inspector of Panchagarh police station, also investigation officer of the case, Rezaul Islam Basunia told this correspondent over cell phone that main accused Munna, 22, also tenant of Abdur Rahim (victim's father) took Jewel, 10, out of home to 'visit different places' on March 25.

Then they went to Thakurgaon first. As per previous plan, Munna's accomplices Shaju and Biplob joined them at Thakurgaon bus stand.

Before start of journey to Rangpur, the abductors kept Jewel's school bag at a shop at Kalibai in Thakurgaon municipality.

In Rangpur, on March 26, when the boy started crying to return home, the three kidnapers decided to kill him.

As the area was lonely, they took Jewel to an under construction building in front of Rangpur Cadet College and strangled him.

On March 27, police arrested Munna from in front of Boda Hospital.

On his confession, they went to Rangpur and recovered Jewel's body from an under construction building in front of Rangpur Cadet College.

Police later arrested Saju and Biplob in connection with the abduction and killing.

ABSENCE OF PWS

Trial of Patradut editor murder case not held

Trial of the case for murder of daily Patradut editor S M Ala Uddin was not held yesterday as the prosecution witness (PW) could not be produced in the court.

The trial of the case resumed in July this year by recording the statement of prosecution witness Abdur Razzak, after 15 years of the gruesome murder.

The court so far has recorded the statements of 8 out of the 38 prosecution witnesses.

Earlier judge Obaidus Sobhan of Satkhira District and Sessions Judge's Court fixed April 1 for recording the statement of other PWs of the case.

As soon as the court resumed its proceeding, the prosecution lawyer submitted a petition to cancel the bail of the accused Abdus Sabur and Khalilullah Jhharu as they allegedly threatened the complainant of the case.

After hearing, the court

fixed May 8 for hearing of the petition and also recording the statements of the prosecution witnesses.

Daily Patradut editor SM Ala Uddin was shot dead by assailants at the office of the daily at Pransayer in the town on June 19 in 1996.

Police arrested an Awami Jubo League activist and also an alleged member of the killing squad Saiful Islam after five days of the incident disclosed the names of the accused.

The investigation officer (IO) in the case submitted charge sheet against 10 accused on May 5 in 1997.

The trial was delayed as five accused submitted a petition to the High Court seeking quashment. The High Court accepted the petitioners' prayer and quashed the case in 1998.

Later on an appeal from the government, the Supreme Court rejected the quashment order of the HC and asked the lower court to resume the trial on March 11 in 1999.

10-minute halt demanding RCC

Normal life in the city came to a standstill for 10 minutes yesterday as people stopped all activities demanding immediate declaration of Rangpur City Corporation (RCC).

Samaj Poribartan O Unnyan Forum of Rangpur organised the programme.

Different government and non-government organisations and business embellishments refrained from activities during the period. Besides, all types of vehicles remained off the roads.

People from all walks of life including

politicians, lawyers, businessmen, social and cultural activists, human rights activists and journalists took part at the programme.

At the programme, the forum president SM Piyal urged the prime minister to declare Rangpur as city corporation immediately.

"Comilla and Narayanganj have been declared as city corporations. So, why has Rangpur should not be made city corporation being a division?", he posed.

The speakers also threatened to go for tougher programmes like hartal if the demand was not met within 90 days.
