30 hurt as rival villagers clash over pond's share

Houses set on fire, shops looted in Tanore

At least 30 people were injured in a fierce clash between two rival groups of villagers over control of a government pond in Tanore municipality yesterday.

During the four-hour long clash, over 10 houses were set on fire and several shops looted, said police.

Quoting locals, Abul Hashem, officer incharge of Tanore police station, said residents of Gubirpara village had been enjoying a larger share of the pond, but Shindukai villagers recently claimed its while the rest were given equal share.

Hundreds of people

over 30 from both sides injured at around 7:00am when people of Shindukai village set up three water pumps in of Shindukai village, the pond.

On information, police rushed in and took the situation under control. However, no one was arrested in this connection, the OC added. Of the injured,

AL men resign to protest extortion by Jubo League activists

At least 58 Awami League (AL) men at newly formed Rangabali upazila in the district resigned yesterday, protesting, what they said, random extortion by local Jubo League men.

Bipul Das, president of AL of ward no 1 of Rangabali union unit, vice-president of the unit Sabuj Mollah, joint secretary Kuddus Mia, publication secretary Babul Mia and other $42\,general\,members\,of\,the\,unit$ placed their resignation letters before Ahsan Kabir Chan, president of Rangabali upazila ALatnoon.

Those who resigned from the party alleged that most leaders of upazila unit Jubo League, led by Duke Talukder, Babor Talukder and Rasel are extorting people, traders and organisations everywhere in the upazila for the last three years.

On Thursday, the gang went to local water melon farmers in the area and demanded toll.

CHT PEACE AGREEMENT

'Almost all vital clauses still not implemented'

Ethnic leaders at a regional dialogue on Sunday urged declaring roadmap for full implementation of Chittagong Hill Tracts (CHT) peace accord.

Marking three years of its formation, CHT Citizens Committee (CHT-CC) organised the dialogue at the conference room of Rangamati District Sports Association in the town.

Earlier the execution process of CHT peace accord remained stalled during the last BNP-led four-party alliance government, said speakers at the dialogue. After coming to power, the present Awami

League-led grand alliance government did nothing for full execution of the peace treaty although the same party government signed the deal in 1997, they said. Many indigenous people were killed and

many more injured in violence between the ethnic people and Bangalee settlers over land disputes in hills as the peace deal has not been implemented fully, they added. Slating CHT Affairs Minister Dipanker

Talukder for playing 'anti-peace treaty role', they said almost all vital clauses of the deal including land dispute have remained unresolved.

They urged all irrespective of party, race, caste and creed to come forward with positive mind for the betterment of hill people. Among others, U Kya Jen, member of the

committee, Nirmolendu Tripura, advocate Gyanendu Bikash Chakma, Nirupa Dewan, member of National Human Rights Commission, Kajal Talukder, Chingkiew Roaza, senior vice president of district AL, Nirapad Chakma, and Santoshita Chakma Bakul, president of CHT Jummo Refugee Kalyan Samity, spoke at the dialogue presided over by Goutam Dewan, chairperson of CHT-CC.

Prof Mong Shanoo Chowdhury presented the key note paper at the function while Josheswar Chakma, secretary of CHTCC, gave the welcome speech.

CHTCC put seven-point demand to the government -- declaration of a specific time frame for execution of the deal, activation of Hill District Council (HDC) acts, bringing amendment into CHT Land Dispute Resolution Commission to resolve land disputes, constitutional safeguard of all traditional and customary laws, steps for holding election to HDCs and resuming 34member body system of interim council in the HDCs for ensuring representation from all indigenous communities, rehabilitation of all jummo refugees in their own land and withdrawal of all makeshift security camps from the hills.

Two siblings drown

Cops closed in Satkhira

Two police officers were closed on charge of failing to maintain law and order situation in Kaliganj upazila yesterday. The accused are Satkhira police superintendent Habibur Rahman Khan and Syed Farid Uddin, officer in-charge of Kaliganj police station. Additional police superintendent Joydev Chowdhury said hundreds of unknown people torched at least seven houses and looted 10 others of Hindu community on Sunday night, protesting a remark on prophet Hazrat Mohammad (SM) in a drama staged by the students of Fatehpur High School on the occasion of Independence Day. Later, the authorities closed the duo as they failed to maintain law and order situation in the area, the ASP added. Earlier, two houses were set on fire, four houses and the school ransacked at Fatehpur village on Saturday over the same issue.

Houses, shop gutted



Imran as he tried to save Arman, leaving him seri-


ously injured. They were rushed to the Comilla Medical College Hospital where Arman died.


