Enclave people call off hunger strike

Enclave people yesterday called off their indefinite hunger strike at the request of a lawmaker.

Lawmaker Farida Akhter reached the venue in Boda upazila of Panchagarh district in the afternoon and assured the enclave people that Prime Minister Sheikh Hasina would take effective steps to meet their demands as soon as possible.

"As a representative of the prime minister, I have come here to convey the assurance of the government and request you to end the hunger strike," she told the agitating enclave people.

Indian Finance minister Pranab Mukherjee is expected to arrive in Dhaka on May 5. During his visit, all pending bilateral issues, including water sharing and enclave, will be discussed, the lawmaker said.

After her speech, president of India-Bangladesh Enclave Exchange Coordination Committee Moinul Haque announced withdrawal of the hunger strike. But he also vowed to continue agitation until the

demands were met. Taslimuddin, chairman of Puthimari

Indian enclave, Mofizer Rahaman, chairman of Garati Indian enclave, and chairman of Kajoldighi Indian enclave were present.

Later, they (enclave people) ended their hunger strike by sipping juice and coconut water offered by the lawmaker. Enclave people went on an indefinite

hunger strike on March 18 to press home their three-point demand including immediate implementation of India-Bangladesh land boundary agreement of 1974, popularly known as Indira-Mujib Pact. They also demanded a definite timeframe

to implement the enclave exchange deal. People from all 111 Indian enclaves inside

Bangladesh took part in the strike held beside Dhaka-Panchagarh Highway near Puthimari Indian enclave.

Bangladesh has 51 enclaves comprising around 3,000 acres of adversely possessed land inside India while India has 111 enclaves comprising 3,500 acres of land inside Bangladesh.

Indian enclaves inside Bangladesh are situated in Panchagarh, Lalmonirhat, Kurigram and Nilphamari districts while Bangladesh enclaves are in Indian Cooch Behar district.

Storms lash two districts, damage boro, houses

Storms hit Patuakhali and Gaibandha districts, damaging several hundred houses and boro plants on vast tracts of land yesterday and the day before.

Over 300 dwelling houses, and boro plants on vast areas were damaged as a nor'wester lashed at least 15 villages under Baufal upazila of Patuakhali on Monday evening, reports our correspondent.

The three-hour-long storm from 4pm to 7pm hit Char Barret, Char Miazan, Char Roy Saheb, Dhandi, Nimdee, Nazirpur, Nurainpur, Bara Dalima, Chhoto Dalima, Keshobpur, Mominpur, Dashpara,

Khajurbaria, Kalaiya, Bogi and several other villages.

According to a primary estimate, about 900 poultry at two poultry firms, one owned by Rokeya Begum and another by Al-Alafa, were also killed during the

Besides boro plants, huge watermelon, maize, chilli, pulse were also damaged as rainwater flooded the crop

In Gaibandha, a nor'wester accompanied with gusty wind and heavy shower damaged boro plants on vast tracts of land in Sundarganj upazila yesterday, reports our corre-

spondent. The storm lashed seven unions of the upazila and

destroyed a large portion of BR-28, BR-41, China and Chandina varieties of boro

"I cultivated boro plants on two bighas on share cropping basis. I won't get anything from the landowner now as all the plants have been razed to the ground due to torrential rain and wind," said Abdur Rahim, a landless peasant of Kapasia union.

Due to storms, production may be reduced by 30 percent. However, mild storms and gusty winds will not affect the paddy plants much if the farmers use standard dose of MP fertiliser, said Aftab Hossain, upazila Agriculture Officer in Sundarganj.

Cashing in on others' woes

BCL leader builds small dams on canal to cultivate fish while 15,000 farmers suffer for want of water

A local leader of Bangladesh Chhatra League (BCL) in Char Miazan, a coastal island in Baufal upazila under the district, has built several temporary dams by putting earthen barriers on a canal to cultivate fish there.

Siddiqur Rahman, president of Char Miazan unit of BCL, who did the callous act two years ago, also closed a sluice gate that let water from the river to the canal.

Consequently, local farmers are suffering from want of irrigation water for their agricultural fields. Most of around 15,000

residents in the char, about 20 km away from Baufal upazila headquarters, are dependent on agriculture, and Water Development Board (WDB) built 14-km-long flood control embankment around the island several years ago to protect the residents and 10,000 acres of agricultural land from tidal surge and saline water, said sources of local Najirpur union parishad. WDB also dug a 12-km

long canal from Char Roy Saheb to Char Kachua in the island to ensure smooth supply of water from the river considering interest of agricultural activities. Moreover WDB built a sluice gate on the canal near Roy Saheb Bazar to control water flow there 10 years ago.



But now local farmers the sluice gate and built are not getting benefit from the sluice gate or the lone canal in the island as BCL leader Siddiqur Rahman closed has been brought under

over 10 dams illegally on the canal to cultivate fish there.

"Over 5,000 acres of land

"Now we cannot get water from the river and the canal. All our crops will be destroyed if the sluice gate is not opened soon," he said.

Irrigation is badly hampered as the BCL leader and his accomplices built several dams on the canal and divided it into a few sections to cultivate fish two years ago, several farmers told this correspondent during his recent visit to the area.

However, they sought anonymity in fear of reprisal from the perpetrator.

Siddiqur Rahman, the BCL leader, said, "Nobody even MP or minister can cut my dams. I built those on my own land."

But he did not explain how the land under canal water could be his.

Ibrahim Faruq, chairman of Najirpur union parishad, said, "Local farmers are greatly suffering due to the dams on the canal. Nobody should not build such dams as it is the lone canal in the area and it is very useful to local farmers."

When contacted, Abul Kalam Azad, upazila nirbahi officer of Baufal, said, "After hearing the matter, I asked the upazila assistant commissioner of land to submit report over the matter after proper investigation within seven days from Sunday last."

Landslide kills youth

Witnesses said, a heavy chunk of mud collapsed on Sabinoy near his house, leaving him seriously injured. He was rushed to upazila hospital where the doctor declared him dead.

10 houses gutted in Rangpur

Quoting family members, police said Fazlul took poison on Monday midnight at his home following a family feud. He died at hospital yesterday morning.

Ansar Ali hanged himself from a mango tree beside his residence at midnight over a family dispute.

Morjina killed herself by hanging from the ceiling at her living room on Monday night following a quarrel with her husband.

Farhad, a BA student of Dinajpur Government College, took his life by hanging himself from a tree as his family members allegedly forced him to marry against his will, said police.

Instead of catching crabs, they hunted deer and sold venison to people of nearest localities, he said.


A case was filed in this regard. The three detainees were sent to jail.
