## 30 medical students get Rotary Club scholarship

### Buet asks teachers to withdraw work abstention

Bangladesh University of Engineering and Technology (Buet) authorities have urged the teachers to withdraw their work abstention programme led by the Buet Teachers' Association and resume academic activities.

The call came at an emergency syndicate meeting yesterday with the Buet Vice Chancellor (VC) Prof Nazrul Islam in the chair.

The syndicate sat to discuss the overall situation of the university as the academic activities are being hampered due to the work abstention since April 7 demanding resignation of the VC and pro-VC.

The association has brought 16 allegations against the VC and pro-VC.

They have announced that they will boycott class from April 15 if their demands are not met.

## Last witness turns in Azad's friend on war crimes reports

The last prosecution witness in Jamaat-e-Islami leader Delawar Hossain Sayedee's case yesterday gave the International Crimes Tribunal-1 several copies of newspaper reports on Sayedee's alleged crimes against humanity during the Liberation War.

The tribunal, the first of two formed to deal with crimes committed during the 1971 Liberation War, would resume recording, for the fifth consecutive day, the testimony of witness Helal Uddin this morning.

Helal Uddin, also the investigation officer probing the charges against Sayedee, presented old newspapers copies and some other documents related to the case before

the tribunal yesterday. He presented 84 copies of Bangla daily Janakantha, which were part of a series titled "Sei Rajakar" (That Collaborator) published between January and March, 2001. He also provided 40 copies of another daily Bhorer Kagoj. Those were part of a series of reports "Rajakarer Ekattarnama" published between October, 2007 and January, 2008.

## Student talent hunt from next year

The government will launch next year a nationwide talent hunt to pick out creative students from class VI to class XII through an annual competition on four subjects.

The main objective of this first-of-its-kind talent hunt is to flourish creativity in students and create a band of national icons, said Education Minister Nurul Islam Nahid.

The minister endorsed a draft of Creative Talent Hunt Policy 2012 at a meeting at the ministry's conference room yesterday.

According to the draft policy, the four subjects are Language and Literature (Bangla and English), Science (Physics, Chemistry and Biology), Mathematics and Computer, and Bangladesh Studies (History, Civics, Economics and Social Science).

Students from class VI to XII of all public and private educational institutions can participate in the competition, which will be held between January and March every year, it said.

The contestants will have to take part in a number of tests including essay competition, story telling, and extempore speech (Language and Literature), scientific write-up and presentation (Science), written and oral test (Mathematics and Computer), and MCQ and oral test (Bangladesh Studies).

A total of 96 students from eight divisions, three from each subject at each level, will become finalists. From them, 12 students, one from each subject of three levels, will be selected as champions.

"The champions will be recognised as national icons and will be provided with special merit scholarship", the policy said.

The competition will be held in three phases, starting with upazila level schools. Winners from this level will participate in the district level competition.

The district level winners will qualify for divisional competition, which will be held in seven divisions and in Dhaka metropolitan area.

A steering committee headed by Education Secretary Dr Kamal Abdul Naser Chowdhury will finalise the policy soon and the competition would begin next year.

Youth killed only for Tk 500 by fellow RMG worker in Ctg

A youth met a tragic end as his fellow worker stabbed him to death for only Tk 500 in the port city on Tuesday. The deceased,

Mohammed Parvez, 20, was a worker of the garment factory of Techno Dress Limited in the city's Dewanhat.

Police arrested Manjurul, 19, Hanif, 30, Nurul Nabi, 30, Shahjahan, 20, and Mohammad Shopon, 26, all workers of the factory, in connection with the killing. Manjurul, while talking

to journalists at Double Mooring Police Station yesterday, confessed that he gave Tk 500 to Hanif to kill Parvez. He and Nurul were also

present at the spot when Hanif stabbed Parvez in Wapda Colony area around 11:30pm on Tuesday, confessed Manjurul. Following the incident,

locals and relatives rushed Parvez to Chittagong Medical College Hospital where doctors declared him dead around 1:00am yesterday, said hospital sources. Manjurul said he had

been angry with Parvez following an altercation and scuffle between them on Sunday. Shahjahan and Shopon,

however, denied their

involvement in the killing while Manjurul said they knew about the incident. Inspector (Investigation)

Satyajit Barua of Double Mooring Police Station made the arrests after a case was filed in this regard.

## Teenaged boy commits suicide for cricket bat

A teenaged boy committed suicide as his maternal aunt refused to buy him a cricket bat at Uttar Goran of Khilgaon in the capital on

The deceased Yunus Hawlader Milon, 15, son of late Jahangir Hawlader, worked at an embroidery shop in Khilgaon Taltola area.

He had been living with his aunt Laboni Akhter, who works at a garment factory, at her Uttar Goran residence since his childhood as his father died and mother got married again.

He told his aunt to buy him a cricket bat on Tuesday noon, but Laboni refused to buy the bat as she did not have money.

After being refused, Yunus made scratches on his hands with a blade, which angered Laboni. She slapped him and left the

house for work. After returning home at night, Laboni found Yunus' body hanging from the ceiling of their tin-shade room.

#### Dyeing factory fined STAFF CORRESPONDENT

The Department of Environment (DoE) yesterday fined a dyeing factory Tk 21 lakh for running the factory by violating DoE orders. The dyeing factory,

Pacific Fiber Corporation, was also asked to stop its operation, says a DoE release. The factory owner in a

written statement informed the DoE on January this year that he stopped production as it had no effluent treatment plant (ETP). But an enforcement team led by Deputy Director of DoE Abdullah Hakkani in a sudden visit yesterday found that the factory was running.

The factory has been polluting the river Turag since 2006 by discharging untreated dyeing waste.
