Clashes kill 2 near Egypt-Libya border

AFP, Cairo

Two people were killed during clashes between residents of an Egyptian town close to the Libyan border and security forces, security officials told AFP yesterday.

Residents of Sallum in western Egypt on Tuesday night blocked the main motorway heading to Libya to protest security restrictions on cross-border traffic and increased tariffs for orries.

The move prompted security forces to intervene, leading to clashes that left two dead and four people injured, officials said.

By yesterday morning, dozens of Sallum residents again blocked the motorway to Libya, allowing access only to Libyan families returning home, the official said.

of PTWC and JMA, the coastal areas of Chittagong could have experienced a tsunami wave at 10:51 last night on the aftermath of the quakes. Immediately after the

declaration of the alert, panic gripped the people of char areas in Cox's Bazar and they started to leave their houses.

The Civil Aviation Authorities suspended flight operations and all other activities at Shah Amanat International Airport in Chittagong while the Chittagong Port Authority asked to keep all the vessels anchored.

The flight operations resumed at the airport after 8:00pm last night soon after the tsunami alert was with-

"According to the PTWC and Indian National Centre for Ocean Information Service (INCOIS) there is no sunami threat for Bangladesh coast," a statement of the met office said.

The earthquakes that occurred beneath the sea were great, experts said.

Prof Syed Humayun Akhter said, "There is no chance of tsunami this time as the displacement in the sea floor was horizontal, and it did not affect the water column in the sea."

Prof Humayun, director of the Earthquake Observatory Centre of Dhaka University and a teacher of geology department, said it was a preliminary alert.

Sensing the quake, many people in the capital left their offices and homes in panic and ran into the streets.

Bangladesh Meteorological Department asked all related agencies especially government officials of the coastal districts and upazila headquarters to be watchful from 3:00 pm to last midnight for the sake of safety of the coastal people.

According to the PTWC, the earthquakes of this size had the potential to generate widespread destructive sunami that can affect coastlines across the entire Indian Ocean basin.

The level of ground shaking of the earthquake was 324 on Modified Mercalli Intensity (MMI) scale in Bangladesh, said Prof Humayun, reports UNB.

"The tsunami route is east-west. Bangladesh is situated in the north o Indonesia. So, Bangladesh will remain safe from tsu-

nami," he said. Our correspondents in Cox's Bazar, Chittagong, Gopalganj, Barisal districts report of chaotic scenes as panic-stricken people rushed to the streets soon

after they felt the quakes. The Armed Forces Division said army, navy and air force installations particularly in Chittagong and Cox's Bazar were asked to get prepared to launch rescue campaigns in line with Prime Minister Sheikh Hasina's

directives, reports BSS. The control room of the disaster management ministry in a release yesterday said they were monitoring the situation in every hour.

talk to the four persons, but could reach only Enamul Huq at his Kamalapur Railway Station office. Yusuf Ali Mridha was

him in a microbus under the Khilgaon flyover at about 11:30pm on Tuesday. They said they were Detective Branch of police and accused him of peddling cannabis (ganja), local people quoted Nannu as saying.

Holding him hostage at gunpoint, the criminals took away Tk 80,000 and his mobile phone. They then tied his hands and legs and gagged him. After driving around the area for sometime, they pushed him off the vehicle around 12:30am at Khilgaon C Block.

a room in Pilkhana [on Monday night] and or Tuesday they freed three of us after verifying our identities but kept the driver detained," he said. Replying to a query,

Enamul said none intercepted them to know their identities when the driver drove the microbus into Pilkhana. It may be mentioned that

the BGB headquarters is heavily guarded and it is quite impossible for outsiders to enter it without the BGB members checking their identities.

Putin calls for unity to build strong Russia

President-elect Vladimir Putin yesterday called on Russians to unite to build a strong Russia with a booming population and economy after overcoming economic crisis and a tense election period.

After winning the March presidential election despite an outburst of protests against his rule, Putin in a speech to parliament outlined his vision for Russia's future as he prepares to return to the Kremlin for a six year mandate.

Putin told the State Duma lower house of parliament that the 2008-2009 economic crisis was so serious it could have endangered Russia's sovereignty but boasted that the country had now fully recovered under his rule.

He said that not only had Russia now "made a serious, significant, notable step forward. We became stron-

ger than we were before." But he said it was now time for all forces to work together after the turbulence of the election period that saw the opposition hold up to 100,000-strong rallies in protest at what they said

were rigged poll. "We only have one Russia and her modern development must be the goal that unites all the political forces of the country who want to work on this aim," he said.

Putin served the last four years as prime minister after emerging as Russia's undisputed number one in his 2000-2008 two terms as president, after which he temporarily handed the Kremlin to his protege Dmitry Medvedev.

Putin earmarked Russia's number one priority as reversing its post-Soviet population decline which has created worries about its ability to keep sustainable populations in its far-flung Siberia and Far East regions.

The PTWC issues advisory alerts across the region, which state authorities can use to issue their own emergency procedures. Indonesia straddles the Pacific Ring of Fire, a zone of major seismic activ-

Sutopo, a spokesman for Indonesia's disaster mitigation agency, said electricity had been cut in Aceh and there were traffic jams to access higher ground.

"Sirens and Koran recitals from mosques are everywhere," he told Reuters.

Tremors were felt as far away as Singapore, Thailand, Sri Lanka, Malaysia, Bangladesh and India. The French island of Reunion was also on alert.

Along the eastern coast of Africa, Kenya and Tanzania issued their own tsunami warnings.

"There was a tremor felt by all of us working in the building," a man called Vincent in Calcutta, India, told the BBC.

"All just ran out of the building and people were asked not to use the elevator. There was a minute of chaos where all started ringing up to their family and asking about their wellbeing."

The AFP correspondent said he saw the water recede around 10 metres (33 feet) -a strong sign that a tsunami is approaching -- and that residents were relieved when a one-metre wave came and went, causing

little bother. Tsunami warning sirens, set up in many vulnerable areas after the 2004 disaster, were heard in Phuket, Thailand, where correspondents said people were calmly following evacuation routes to safe zones.

Roger Musson, a seismologist from the British Geological Survey, said the quakes were unlike those seen off Indonesia in recent years, where ground had been pushed under the continental plate, "flipping up" the seabed.

"It seems to be a large earthquake within the Indian Plate and the plate has broken in a sort of lateral way," he said. "It's a sort of tearing

The BGB personnel wanted to hand them over to police but police refused to receive them, saying there was no case filed against them. Faruq, Yusuf and Enamul were eventually released but the driver is said to be still in BGB custody.

The Daily Star failed to reach the driver for comments despite repeated attempts on his two mobile

phones. Meanwhile, BNP acting secretary general Mirza Fakhrul Islam Alamgir during a demonstration in the capital against price hike of essentials called for Suranjit's resignation. He said the minister should shoulder the responsibilities of what has happened, reported UNB.

Apple, others in e-book antitrust suit

The US Justice Department is filing an antitrust suit against Apple and publishers alleging they conspired to curb competition over ebook pricing, the Wall Stree Journal reported yesterday.

The Justice Department scheduled an announcement for noon (1600 GMT) on a "significant antitrust matter," according to a statement, which had no details.

According to the report the lawsuit alleges Apple and the major book publishers reached an agreement where retail price competition would cease, retail ebook prices would increase significantly and Apple would be guaranteed a 30 percent commission on each e-book sold. The daily said a settle-

publishers is expected to be filed, according to a person familiar with the matter. Prior to the introduction of Apple's iPad in April 2010 online retail giant Amazon maker of the Kindle e-book reader, sold electronic ver-

But Apple forced a change in pricing for e-books when the iPad emerged as a rival ebook reading platform, moving publishers to a socalled "agency model' which calls for them to set book prices and for Apple to take a 30 percent cut.

European antitrust officials announced in December they were conducting a probe into Apple and the five publishers to determine whether they had struck illegal deals to fix the prices of e-books in Europe.
