FM for upholding CMAG mandate

Foreign Minister Dipu Moni underscored the need for upholding the positive spirit of the new mandate of the Commonwealth Ministerial Action Group (CMAG) when discussing the modalities for implementation of the report on strengthening the role of CMAG.

The report was endorsed by the Commonwealth heads of government meeting in Perth, Australia in October 2011.

The foreign minister was leading the Bangladesh delegation at the 37th meeting of CMAG in London on Monday, said a foreign ministry press release yesterday.

During the meeting, the Commonwealth ministers also discussed the proposal of the eminent persons group of the Commonwealth for establishment of a Commonwealth commissioner for democracy, the rule of law and human rights.

CMAG reviewed the prevailing political situations in Fiji and the Maldives.

She stressed the importance of continued engagement of the Commonwealth with the Maldives for strengthening the democratic institutions in the country, especially in the capacity-building of sectors like parliament, judiciary and the election commission.

3 policemen suspended

Three police constables were suspended yesterday on charge of their involvement in assaulting two reporters on Dhaka University (DU) campus on Saturday.

The policemen assaulted Masum Billah, DU Correspondent of the Dainik Samakal, and Pintu Ranjan Orko, a feature writer of Dainik Kaler Kantho, when they went to collect information from a police control room at the gate of Suhrawardy Udyan.

RAILWAYGATE SCANDAL

Suraniit's statments in question

Suranjit Sengupta's changing statements with the unfolding of the drama over the April 9 railwaygate scandal has raised questions about the credibility of the veteran politician.

It all began with the midnight recovery of Tk 70 lakh from the microbus of his close aide after the driver reportedly pulled over inside the Pilkhana BGB headquarters in the capital and its driver hollered that there was stash of bribe money in the vehicle.

BGB personnel on guard found Tk 70 lakh in the car. The money had allegedly been collected as bribe from railway job seekers.

At first Suranjit strongly defended his aides--Assistant Private Secretary (APS) Omar Faruq Talukder and Railway General Manager (East) Yusuf Ali Mridha and Dhaka Division Security Commandant Enamul Huq who were in the car that night.

He then dismissed his possible links to the scandal terming it conspiracy against him and promised to quit if needed, took a turnaround from the stance on the very next day; sacked his APS and suspended two other aides; and finally stepped down from his office on Monday.

On April 10, the day after the incident, Suranjit told the media that it is not illegal to carry money in the country, adding that he heard that the driver was trying to rob the money from his APS.

Moving away from this stance, the former minister on the very next day told journalists at the Jatiya Sangshad Bhaban that he had asked Faruq and Yousuf not to come to work until further notice.

Saying that the incident was "unwarranted" and has happened before in the country, Suranjit had said that the incident had created "problems" for him and he would face it. As questions arose about his possi-

ble links to the scandal that was hauled, Suranjit on April 12 dismissed the allegation terming it a conspiracy to ruin his political image. Some people were after him as he

has been trying to revive the longnot-cared-for railway sector, he said in a press briefing at Rail Bhaban on that day. He, however, clearly said he would resign if his involvement in

the incident could be proved. "I will not stay for a moment if any such situation arises." Suranjit took a complete U-turn on the very next day on April 13 and

outright rejected the notion of quit-

He told the BBC: "You mentioned that a railway officer was involved in the incident along with the APS and his car and if it is so, then where is my involvement? Why is there the question of resignation?"

pended, and that legal action would be taken against the trio. Suranjit, however, avoided making direct replies on why Mridha and Enamul were suspended, and not

He stepped down the next day taking full responsibility for the scandal surrounding the cash haul.

"At the meeting with the prime minister on Sunday night, I told her that I wanted to relieve myself of the charge of the railway ministry, and she happily accepted it," a palelooking Suranjit told a press briefing at the Rail Bhaban on the afternoon that day.

"As a minister, I'm responsible for all good and bad things in my

He however insisted that the vehicle with the money was not heading for his Jigatola residence in the capital, contrary to the claims of the APS and two other railway officials travelling in the microbus.

The seven-time parliamentarian from Sunamganj in the northeast region also hoped that the "truth" would emerge through the inquiry.

11 for his alleged involvement in crimes against humanity. On January 9, this year the International Crimes Tribunal

accepted formal charges against Ghulam Azam, after the prosecution submitted to the tribunal 62 charges of crimes against humanity against him on January 5.

Foetus in twin's belly!

Doctors in Rajshahi Medical College Hospital (RMCH) yesterday operated on a 10-month-old baby girl to bring out her 'dead' twin sister from her belly.

The baby named Tithi, daughter of Jamal Uddin at Iswardi in Pabna, was admitted to the hospital over a week ago with swollen abdomen and problems of taking food.

The 'dead' baby weighing 1.1 kilogrammes had a head, chest, belly and parts of hand and leg.

Dr Nawshad Ali, assistant professor of Pediatricts Surgery unit of the hospital, described the incident

"Actually, both of the babies were growing up as twin in their mother's womb. At one stage, physical development of one of the twins ceased and it somehow managed way into another's womb," said the doctor.

"We were astonished to see shadows of human skeleton inside the baby's womb and later studied out that the status is called fetus in feto in medical term."

Tithi was now safe and out of danger, he said.

Engage Bangladeshi expatriates

Parliamentary body tells Bapex

A parliamentary panel yesterday asked Bapex to engage renowned Bangladeshi expatriates, working in foreign oil and gas exploration companies, in its operations in order to make the state-owned company self-reliant. Members of the parliamentary standing committee on

public undertakings said the country still has to depend on foreign experts for exploration of oil and gas.

"Bangladesh Petroleum Exploration & Production Company (Bapex) will be benefited largely if it gets the service of the Bangladeshi expatriates working in foreign oil and gas exploration companies," ABM Ghulam Mostafa, chief of the parliamentary watchdog, told the meeting. "There are many Bangladeshi expatriates working effi-

ciently in different oil and gas companies abroad," Mayeen Uddin Khan Badal, a member of the panel, said after the meeting at Jatiya Sangsad Bhaban in the capital. "A Bangladeshi is also working in the US-based

ConocoPhillips, which was awarded for exploring oil and gas in our offshore area," said Badal, also a Jatiya Samajtantrik Dal MP. He said the committee has asked the Bapex high officials

to immediately contact such Bangladeshi expatriates and offer them work opportunities along with financial packages and other facilities, similar to the ones that they are getting from the foreign companies. It is imperative to turn Bapex into a self-reliant organisa-

tion, specially after winning huge maritime areas in the Bay of Bengal, he added. The committee asked Bapex to submit paper work related

to the issue at the committee's next meeting scheduled next month.

It also recommended that the government give an Independence Day award to Bapex for playing a 'historic' role in exploring the country's oil and gas resources. meeting.

Suranjit made scapegoat: BNP

BNP acting Secretary General Mirza Fakhrul Islam Alamgir yesterday said the government would not be able to survive by making Suranjit Sengupta scapegoat as, from the top to the bottom of the government, all are corrupt.
