The protest has stopped the academic activities of the university for the last 10 days as a number of teachers, including the leaders of the teachers' body, refrained from taking classes. The association leaders said they would keep from taking classes until the VC and Pro

VC resigned. Meanwhile, students of the university on several occasions formed human chains on the campus urging the teachers to resume classes. They implored that their academic progress would seriously be affected if the teachers continue to boycott classes.

In a press conference held on April 15 the teachers' association claimed that the university authorities' appointment of Habibur Rahman, a professor of the civil engineering department, to the post of Pro VC was based solely on his political affiliations.

Prof Rahman was September 23, 2009.

The university authorities had violated the Buet custom of maintaining seniority with regard to promotion and appointments, alleged the teachers' association. They also claimed that the VC had begun abnormal and massive restructuring of the university administration since he took charge on August 31, 2010.

The VC and Pro VC had flouted the university tradition by forming a separate sevenmember body comprised of partisan people for the appointment and promotion of Buet officials, they alleged.

Prof Muhammad Muzibur Rahman, president of the teachers' association, cited the appointment of partisan official Kamal Ahmed to the post of interim registrar by the VC as another example of violation of the university's hierarchy.

The administration was

also accused of changing the marks of two students and appointing teachers based on political considerations.

Buet VC Prof Nazrul Islam denied the allegations at a press conference in Buet Conference Building yesterday. He also refused to resign his post when asked by reporters, claiming no irregularities had taken place during his tenure.

"My resignation would solve nothing. If anything, the crisis would only get worse," said the VC.

Any allegations of violating traditions with regard to the appointment of Pro VC were absurd considering that the post had never existed in Buet prior to the current appointee, Prof Nazrul told The Daily Star.

He said President Zillur Rahman, the Chancellor of the university, had created the post of Pro VC at Buet and the appointment had met with his Excellency's approval.

He also defended the allegedly unusual restructuring of the administration, which had seen several officials being replaced. The appointed as Pro VC on administration had desperately needed a change in order to be restored to a position of strength, he said, adding that no irregularities had taken place during the transition. Earlier on April 11, Buet

Syndicate, the university's policy-making body, had urged the agitating teachers to discontinue their protest and resume their academic duties. On April 12 the Buet

Teachers' Association had called on Education Minister Nurul Islam Nahid at his office, urging him to intervene to solve the ongoing problem and ensure a return to the normal academic activities of the university.

The minister requested that they talk to the VC and Pro VC to reach a solution. Later that day, Nahid sat with the VC and Pro VC and asked them to sort out the problem in concert with the teachers' association.

Vietnam, US to hold naval drills

Vietnam and the US will hold five days of "non-combatant" naval exchange activities next week in the port city of Danang, the US Embassy said, amid rising tensions in the South China Sea. The exercises "underscore the closer ties between the US

and Vietnam", according a statement from the United States, which is increasingly seen as a counterweight to Beijing's growing naval assertiveness in the region. The US 7th Fleet Flagship USS Blue Ridge, the guided mis-

account after two and a half years and why no gazette notification on his resignation was issued.

He also demanded that the government issue a gazette notification in this regard, as he thinks his dignity and image of the government as well as the prime minister have been tarnished for not doing so.

"I want to know why an embarrassing situation has been created by not issuing a gazette notification. Why mysteriously huge amount of money was deposited to my account after two and a half years when I did not get a single coin as remuneration and allowances as a lawmaker since my resignation? I want answers from the cabinet secretary," commented Sohel Taj.

Sohel Taj, the only son of the country's first prime minister Tajuddin Ahmad, wrote two letters to the cabinet secretary in this regard on Monday and Tuesday respectively.

Cabinet Secretary M Musharraf Hossain Bhuiyan told The Daily Star he cannot take a decision on a matter related to the rank of a state minister. "I need the prime minister's guidelines in this regard," he said, adding that it is the duty of the Cabinet Division to give salary and

state minister if they officially belong to the government. He said a state minister

does not have to sign his/her cheque in receiving salary and wages as it goes automatically to their accounts. In the letter, Sohel Taj said he resigned from the post of

state minister for home on May 31, 2009, five months after the ruling Awami League-led grand alliance government assumed office, and sent his resignation letter to Prime Minister Sheikh Hasina on June 1 according to the Constitution. "But until today, no

gazette has been issued of my resignation," he said in the letter, adding, "As a result, for not issuing the gazette, the image of the present government as well as the prime minister and my personal dignity have been damaged and an untoward incident has been occurred centring it."

Moreover, the Cabinet Division has deposited at a time the remuneration and allowances of a state minister from August 2009 to December 2011 [29 months] to his personal account and kept depositing the cheque of monthly remuneration and allowances until today without informing him, he said adding that he didn't for that time.

A state minister gets Tk 1,20,800 per month including different allowances including house rent and fuel allowance.

Sohel Taj told The Daily

Star there is no provision in the Constitution that resignation of a state minister would not be accepted by the prime minister. He said he has been kept as state minister on the government's list forcibly and given remuneration and allowances against the position forcibly.
