2 Indians held with smuggled tortoises

Two Indians were arrested with 300 Indian star tortoises and 115 different species of turtles at Shahjalal International Airport in the capital yesterday.

The arrested, Zulfikar Ali Hasnayeen and Abhijit Das, were trying to smuggle those tortoises and turtles, packed in two suitcases, into Bangkok.

Tipped off, Tapan Kumar Dey, forest conservator at Wildlife Management and Nature Conservation Division, warned the customs and airport authorities about the smuggling attempt.

Zulfikar Ali Hasnayeen holds Indian passport Z-2218122 and Abhijit Das, who Tapan Dey believes was new to the syndicate, holds Indian passport K-0467869.

Abul Kashem, custom officials of Shahjala International Airport, yesterday filed a case with the airport police station in this regard.

The turtles and tortoises were taken to the forest department's Agargaon office from where those would be moved to Dula Hazra Safari Park in Cox's Bazar, he said.

The turtles seized yesterday have huge ornamental, medicinal and food value in different countries. News agency AFP reports that the seized turtles are worth around \$37,000 in the international black market.

Poaching and trading of exotic animals have increased in recent months, officials said. Since 2010, seven attempts including yesterday's to smuggle wildlife have been foiled by the customs and immigration officials of Dhaka airport and destination airports including Bangkok and Kuala Lumpur. Of the turtles, 300 were

rare Indian star tortoises, 90 three-keeled turtles and 25 were Indian roofed turtles, the forest official said. Indian star turtles are very popular as exotic pets in gardens.

All these species are available in Bangladesh and India. SM Rashid, the chief exec-

utive of Centre for Advanced Research in Natural Resources & Management, said there were at least seven species of turtles seized by customs.

Beside the Indian star ortoise, there were six other species of turtles; they are black turtle, tricarinate hill turtle, spotted pond turtle, crowned turtle, Sylheti roofed turtle and brown roofed turtle, he told The Daily Star via email yesterday.

hour sit-in from 9:30am in front of Chief Personnel Officer's (CPO) office at the central railway building, the headquarters of the east zone, in the port city.

The applicants said although they had been asked two weeks ago to collect police verification forms from the CPO's office submitting their joining report, the authorities stopped all the recruitment proceedings in the last two days.

However, talking to The Daily Star none of the applicants admitted to have bribed for the jobs although they complained about the other proceedings for recruitment.

CPO Md Gaus Al Muneer was found working in a room nearby his office.

Approached he said they had stopped distributing police verification forms as they had no clear instructions in this regard. They had only received the direction on recruitment suspension from the railway ministry but no clear instructions about the recruitments already done.

CPO Muneer said he would send the ministry a letter seeking clarification in this regard.

The Railway east zone had issued seven circulations in October and November last year to recruit for around 3,500 posts of 38 categories. Recruitment in 24 categories has been completed; four categories were under process while appointments in 10 other categories were stalled last year due to cases filed by applicants.

The recruitment in around 400 posts in the trade apprentice category had been completed recently.

Meanwhile, the Anti-Corruption Commission (ACC) has asked the Railway authorities to furnish documents of the recent recruitment in 3,500 posts in the east zone.

Railway officials of the zone said they had received a written direction from the ACC Dhaka office Monday.

The recruitment in the Railway (east zone) Department has recently been suspended over an allegation of corruption, on which the ACC is now investigating.

Senior Welfare Officer of Railway east zone Golam Kibria, also a member of the recruitment committee for the Trade Apprentice posts said they would send the documents to Dhaka as soon as possible.

Star that it is likely that the tour will go ahead and the two matches be played in Lahore on April 29 and 30, as it is unusual for the International Cricket Council (ICC) to send security observers after tour dates have been announced. The growing concern however centres around how Kamal is keeping everyone, including his colleagues in the cricket board, in the dark while he puts together the

'We haven't officially discussed the Pakistan tour in the cricket board, not even once," he said. "We have learned of the tour through newspaper reports but nothing was told to us directly by the board president. We discussed the tour in today's [Tuesday's] meeting since the ICC made the announcement on Sunday."

"It is important that we mention that the board doesn't have a problem with Bangladesh playing against Pakistan, but we have a problem to play in Pakistan. One must not make that mistake. But it will not be right to tour Pakistan at this time," he added.

Whether as a result of their discussion or due to a lack of new directive from the ICC, the cricket operations committee hasn't informed the players to come to training ahead of the two matches in Pakistan, despite it being so close to the start of the tour.

It was also learned that Kamal has tried to convince the leadership group of the Tigers, Mushfiqur Rahim and Mahmudullah Riyad, to tour Pakistan. They advised Kamal to speak to every member of the touring party and their parents.

What everyone is obviously concerned about is the security situation in Pakistan. Upon Kamal's arrival from Dubai, he has insisted that the ICC does not want the government to interfere in the running of the cricket activities in any country.

It is an interesting interpretation of the governing body's directive. The ICC has discouraged government interference, but not when it comes to security. In fact, governments in New Zealand, Australia, England and India have routinely shunned cricket teams from touring places like Zimbabwe, Kenya and Pakistan.

2,000 people in the UK to estimate how much sugar was in a range of drinks.

While many overestimated the amount in fizzy beverages, they underestimated levels in smoothies and fruit juices.

The research also found soft drinks could be accounting for a large chunk of their recommended calorie intake.

The British Soft Drinks Association says the sugar in soft drinks is not hidden because beverages carry clear labelling of nutritional content, including calorie and sugar content.

The researchers asked participants to assess their weekly drinking habits.

Their answers suggested 450 calories a day were being consumed - a quarter of the daily limit for women and a fifth for men.

But it was the lack of awareness about the sugar content of drinks that caused concern.

The participants were asked to guess the number of teaspoons of sugar in a range of popular drinks.

They underestimated it for pure apple juice and orange juice, a caffeinated energy drink and a smoothie by between two and four tea-

And for a pomegranatebased drink, they underestimated the sugar content by nearly 18 teaspoons.

Unsurprisingly, many participants were not taking the calorie content of their soft drinks into account when thinking about their diet.

The team warned that the over-consumption of soft drinks was contributing to obesity and was a major risk factor for conditions such as diabetes, high blood pressure, heart disease and stroke.

Lead researcher Prof Naveed Sattar said, "What you drink can be as damaging to the body as what you eat.

"There is no question that consuming too many sugarsweetened drinks can greatly contribute to obesity.

"Some varieties of drinks such as pure fruit juices and smoothies, which are perceived as 'healthy' options, are also very high in sugar.

"For many people struggling with their weight, reducing their intake of such drinks and replacing with water or diet drinks would be a sensible first target to help them lessen their calorie intake."

Contacted by The Daily Star, Communications Minister Obaidul Quader explained the government's change of heart in such a short time.

"He [Suranjit] was neither accused nor found guilty in the cash recovery incident. He was relieved of his charge by the prime minister to ensure a fair and transparent investigation. There is nothing wrong in it," he told The Daily Star last night.

Mahbubul Alam Hanif, joint general secretary of the ruling Awami league, echoed his views.

"The graft allegation against him [Suranjit] does not go with his 55-year political career. Considering this, making him a minister without portfolio is befitting," said Hanif.

And amid all these twists over Suranjit's fate, the railway ministry was without a minister yesterday.

The ministry was formed in December last year through splitting the communications ministry into two.

Barely five months into taking over as railway minister, Suranjit at a crowded press briefing on Monday announced he was stepping down in light of his discussion with the prime minister the night before.

"At the meeting with the prime minister on Sunday night, I told her that wanted to relieve myself of the charge of the railway ministry, and she happily accepted it," a pale-looking Suranjit had told the press briefing at the Rail Bhaban.

Cargo vessel involved in Meghnalaunch tragedy seized

After 34 days of the tragic launch capsize in Meghna river, coast guard personnel yesterday seized the cargo vessel 'MV City-1' responsible for the accident that claimed at least 147 lives.

Law enforcers seized the cargo vessel on Meghna river near Rajrajeshwar area in Chandpur sadar upazila at 10:40am and arrested 12 crew members aboard the vessel, said Jahurul Haque, commander of Chandpur coast guard station.

US drone kills 5 Qaeda in Yemen

A suspected US drone strike in Yemen's southeastern Shabwa province has killed five al-Qaedaaffiliated militants, a local government official said yesterday.

Speaking on condition of anonymity, the official said a "US drone" targeted the five men late on Monday in Shabwa, a mostly lawless region of Yemen where the extremist group has expanded its presence.

The strike was in the Kharama area between the towns of Ghazzan and Huta, the official said. The deadly raid comes

just days after three local al-Qaeda leaders were killed in an air strike on their car in the neighbouring province of Bayda, about 210 kilometres southeast of the capital Sanaa.

The defence ministry said Saturday's raid was conducted by Yemeni warplanes, but a security official told AFP that a US drone was responsible for the attack.
