Maoists to free abducted MLA

Maoists have agreed to free today an Indian legislator, held hostage for over a month, a lawyer who fights court cases for the rebels said yesterday.

Nihar Ranjan Patnaik, based in eastern state of Orissa's Koraput district, told a TV channel that the rebels would set Hikaka free by 10:00am today.

The rebels will hand him over to Patnaik and Kaushalya, the wife of the abducted legislator of Orissa's ruling party Biju Janata Dal, the lawyer said quoting a Maoist leader. The left-wing extremists, who had kidnapped 37year-old Hikaka from Laxmipur in Koraput on March 24, had announced they will hold a 'people's

Canada lifts Myanmar sanctions

Canada on Tuesday lifted most sanctions against Myanmar, Foreign Affairs Minister John Baird announced, saying the long-isolated nation has "changed course in a major way."

The move by Canada came one day after the suspension by the European Union of most sanctions against the country formerly known as Burma.

"Effective immediately, Canada is suspending our sanctions on Burma," Baird said. "Prohibitions on imports, exports and investment have for the most part been removed," as well as individual sanc-

Mad cow disease reported in US

The United States yesterday scrambled to contain the fallout from the discovery of mad cow disease in California as the top beef exporter insisted the outbreak posed no threat to consumers.

The US Department of Agriculture on Tuesday reported the country's fourth-ever case of bovine spongiform encephalopathy (BSE), but stressed the outbreak was contained and no contaminated meat had entered the food chain.

The admission of even a limited outbreak is highly sensitive. Previous cases of mad cow in the United States, Canada, Israel, Europe and Japan have caused disruptions to the global food trade

Beijing warns Manila on sea row

China warned the Philippines yesterday not to "internationalise" the two countries' simmering territorial dispute in the South China Sea, as US and Philippine forces staged war games in the area.

China has been locked in a maritime dispute with the Philippines over the Scarborough Shoal in the South China Sea, a body of water considered a potential Asian flashpoint due to the overlapping claims of several nations.

He spoke as US and Filipino soldiers staged a war exercise not far from the real-life maritime standoff.

N Korea accuses US, South of plotting war

North Korea's military chief of staff accused the United States and South Korea yesterday of plotting war but said his country's own weaponry could destroy their armaments in "a single blow".

Vice-Marshal Ri Yong-Ho also repeated threats of war against South Korea, vowing to "cut the throats" of those seen as defaming Pyongyang's leadership.

The North has made a series of increasingly strongly worded threats against the South in recent weeks. On Monday its military threatened "special actions" soon to turn parts of Seoul to ashes.

Some analysts believe the new young leader Kim Jong-Un is trying to bolster his military credentials and divert attention from a failed rocket launch this month.

Ri, in a speech marking army day, credited Jong-Un's late father Kim Jong-Il with strengthening the 1.2 million-strong military in the nuclear-armed state.

The launch, which attracted UN condemnation, was to have been the centerpiece of

celebrations in mid-April marking the 100th anniversary of the birth of founding leader Kim Il-Sung.

The North bridled at comments by the South's President Lee Myung-Bak and conservative media, who said the money spent on the launch could have bought food for the perennially hungry nation.

"Our military and people are full of rage against the Lee Myung-Bak's traitor groups, who dared to commit such an extreme criminal act as defaming our system and the top leadership," Ri told a national meeting in the April 25 House of Culture.

"Our military and people will launch a retaliatory war in our own way... to cut the throats of the reckless provocateurs and crush the source of provocations without a

The US and its ally the South were making "ever-intensifying plots for war", he said.

The ceremony attended by Kim Jong-Un and other top leaders marked what the North calls the 80th anniversary of the military's founding, during the guerrilla struggle against Japanese colonial forces.

New cabinet approved in Maldives

The Maldivian parliament yesterday approved the 14member cabinet appointed by President Mohamed Waheed who is accused of seizing power in a military and police-backed coup.

A vote in the 77-member assembly ratified Waheed's cabinet, which was named after he took office following the resignation of his predecessor Mohamed Nasheed who claimed he was forced to step down. Nasheed's Maldivian Democratic Party boycotted the vote.

Waheed has denied allegations that he was involved in any coup and has ordered an investigation into Nasheed's exit from office, but Waheed has rejected international calls for early presidential elections.

CONTEMPT OF COURT

Gilani faces crucial verdict today

Pakistan's embattled Prime Minister Yousuf Raza Gilani yesterday vowed to appear in person to face the verdict in a contempt of court case that could see him jailed and thrown out of office.

The Supreme Court will rule today whether Gilani is guilty of contempt for refus-

ing to write to the authorities in Switzerland to ask them to re-open corruption cases against President Asif Ali Zardari. The charges carry a maximum jail sentence of six months and

conviction could lead to Gilani being disqualified from office. "I will appear before the court tomorrow," the PM told a

cabinet meeting in Islamabad. "We are satisfied with the input given by our lawyers and

we are also satisfied with the input by the Attorney General." He did not say whether he would quit if he is convicted.

The Swiss shelved the cases against Zardari in 2008 when he became president and a prosecutor in Switzerland has said it will be impossible to re-open them as long as he remains head of state and is immune from prosecution.


