



Five families flee homesteads for fear of 'ghosts'

Five Hindu families of Yakubpur village in Salondar union under Thakurgaon Sadar upazila have left their ancestral home in fear of what they said ghostly goings-on.

Following suggestions from a few fortune-tellers, they removed 20 rooms of their adjoining houses in a day and set up new dwellings at different places of the same village last month.

During a visit to the area on April 7, this correspondent saw the emptied courtyard that showed signs of being used as dwellings by a few families only a couple of weeks ago.

"During the last two years, we faced a series of spooky events," said Narayan Roy, whose forefathers had been residing in the house for over 150 years.

"My wife Surabala Roy fell sick and she had to undergo two operations for appendicitis and eye. Then two cows and four goats died in last February. Surabala also saw ghosts walking on the courtyard during amabashya (the last day of the dark fortnight) and purnima (full moon).

"I went to fortune-tellers including Kokan Roy of Chaturakhor village and Ananda Sen of Dewgaon village under Sadar upazila for solution. Following their advice, we left our home and built new houses at different places in the same village last month. Now we feel better than before," he said.

The families of Narayan Roy, Khogeshwar Roy, Kalipada Barman, Dhaneshwar Barman and Harani Barman left the place after repeated suggestions from the so-called fortunetellers, said Bhabesh Chandra, a teacher of Kashalbari High School, and a neighbour of the families.

Contacted, 'fortuneteller' Ananda Sen, said, "The place is not good for their dwelling as three land demarcation lines meet there."

Fazle Elahi Chowdhury, chairman of Salondar union parishad, said, "After coming to know the matter from Sadar upazila nirbahi officer, I along with him visited the spot and came to know that the families left their houses as 'fortune-tellers' created misgivings in their minds. So far as I know the families have no enmity with their neighbours."

Gopal Chakrabarty, officer in charge of Sadar police station, said they are investigating whether any other factor led the five families to leave their ancestral home.

Brother-in-law of All 9 Khulna upazila health complexes in sorry state Besides, posts of five class

QUAZI AMANULLAH, Khulna

All the nine upazila health complexes in Khuna district are in a sorry state as none of them is well equipped to provide proper healthcare services for the patients.

These are Koira, Paikgacha, Dakope, Terokhada, Phultala, Batiaghata, Digholia, Dumuria and Rupsha upazila health complexes.

Apart from shortage of doctors and nurses, the health complexes do not have required manpower and necessary equipment.

According to sources in Khulna Civil Surgeon office, there are only 92 doctors against 175 posts at nine upazila health complexes.

The following is the situation at a glance at the health complexes.

Koira upazila: Ten out of 13 posts of doctors, 30 out of 96 posts of nurses and lab technicians and nine out of 20 posts of general staff are vacant at Koira Upazila Health Complex, said Medical Officer Dr Anup Kumar Das.

Paikgacha upazila: Medical Officer Dr Abul Fazal said only 12 doctors against 21 posts are now working at the health complex. Besides, 44 out of 167

posts for other jobs have been lying vacant for the last two years, making it quite difficult to ensure proper services to patients.

Dakope upazila: Medical Officer Dr Bidhan Chandra Ghose of upazila health complex said 22 out of 30 posts of doctors are vacant. Besides, 34 out of 132 posts of nurses and other employees are also lying vacant at the 50bed health complex which remains overcrowded with patients most of the time.

Terokhada upazila: According to Medical Officer Dr Abu Naser Sheikh, the upazila health complex has only six doctors against 15 posts. Besides, 20 out of 83 posts of employees are lying vacant.

Phultala upazila: Medical Officer Dr Manzur Morshed of the upazila health complex said 11 out of 25 posts of doctors are lying vacant. Besides, X-ray and ECG machines have remained out of order for two years, he said, adding that the health complex needs more nurses and general staff.

Batiaghata upazila: Medical Officer Dr Emdadul Huq said the 31-bed health complex has 14 out of 16 doctors and 76 out of 92 nurses and lab technicians.

eight out of 16 doctors and 82 out of 102 nurses, lab technicians and general staff at the upazila health complex.

Civil surgeon office sources said Koira, Phultala, Rupsha, Dumuria and Batiaghata upazila health complexes do not have X-ray and ECG machines while Batiaghata, Digholia Dakope and Terokhada upazila health complexes need equipment for treatment of dental patients.

Civil Surgeon Dr Golam Mortaza said none of the nine health complexes has ultra sonography machine.



60 hurt in AL infighting

At least 60 people were injured in a clash between two rival groups of Awami League over felling banana plants on a piece of disputed land at Goloknagar village in Shailkupa yesterday. Locals said there was a longstanding conflict between Goloknagar AL ward president Raihan Uddin, owner of the banana plants, and Feroz Ahmed, chairman of Mirzapur union parishad and AL secretary, over the disputed land. The followers of Raihan and Feroz locked in a clash at noon, leaving over 60 from both sides injured after the plants were cut down by rivals.



Victims of land subsidence around Barapukuria coalmine in Dinajpur yesterday formed a human chain, demanding quick payment of compensation and rehabilitation of the affected people. Sundarbans robbers abduct 10 fishermen for ransom

Ten fishermen were abducted by 'forest robbers' from Baikari point of Baro Canal of Mamundo River in the Sundarbans on Monday afternoon. The forest robber are now demanding Tk

20,000 ransom for release of each of them, police quoting the victims' relatives said. They have to pay the ransom in seven days, failing which the fishermen will face 'a

dire consequence', they added. The robbers are sending messages asking to arrange the ransom within the deadline or receive the dead bodies after that, the victims' relatives told police.

The ten fishermen are Didarul Islam of village Baishkhali, Azizul Islam of village Shailkhali, Safiqul Islam of village Kaikhali, Karim Barkandaz of village Malenga, Nazrul

Islam and Jahangir of village Jayakhali, Safiqul Islam of village Purbo Kaikhali, Anwar Sheikh of village Naikati, Shahidul Dhali of village Sapkati and Mosharraf Hossain of village Kalinch in Shyamnagar upazila.

They went to the Sundarbans on two boats taking pass from the Kaikhali Forest Office in the Sundarbans on Sunday.

While they were catching fish at Baikari point of Baro Canal on Monday, the robbers attacked them. They looted cash and other valuables from the boats and abducted the ten fishermen.
