FROM PAGE 20 Shakhawat Hossain, owner of Sebika Hospital and Diagnostic Centre, and produced him before a Dhaka court. The court

granted him bail. Victim Golam Arefin, 48, son of language movement veteran late Golam Mortuza, was an employee of a private firm and a resident of the capital's Rayerbazar area.

Last year, Arefin broke his left wrist and took treatment at this hospital where the doctors set metal plates in the wrist to help his recovery. On Monday, he got admitted to Sebika hospital to have the plates removed. The surgery began at 5:00pm.

Victim's brother Golam Mustoba filed a case with Mohammadpur Police Station late on Monday stating that Arefin died due to the mistakes made by the doctors.

Mustoba accused the hospital owner and the doctors who performed the operation.

"When the doctors realised that my brother had died due to their fault during the surgery, they told us that the patient's condition was deteriorating and needed to be shifted to Dhaka Medical College Hospital immediately," Mustoba told The Daily Star.

But they found Arefin dead when they entered the operating theatre, he said, adding that the doctors who performed the surgery were nowhere to be found right after the incident. "We tried to reach them over mobile phone but their phones rang out," Mustoba said. He also claimed that the

owner of the hospital had pledged Tk 10 lakh to the bereaved family as compensation but did not keep the Sub-Inspector Md

Kamruzzaman o Mohammadpur Police Station, who is also the investigation officer of the case, told The Daily Star that he could not arrest any of the doctors accused since they had gone into hiding right after the incident. But police would keep the effort on, added the SI.

The body of the deceased was sent to Dhaka Medical College morgue Monday night for an autopsy. Morgue sources said doctors kept the specimen of lung, liver, heart, kidneys and other organs for viscera test.

Arefin was laid to rest at Azimpur graveyard Tuesday afternoon.

Meanwhile, the staff of Sebika hospital yesterday said both the doctors accused remained absent from duties since Monday The owner of the hospital

was not found in the medical facility for his comment while the staff declined to provide his cell phone number when The Daily Star approached. The Daily Star also

repeatedly tried to reach doctor Hafizur, but his mobile phone was found switched off while none received the land phone at his home.

## Widow?

State minister writes off fate of Ilias Ali's wife

State Minister for Labour Mannujan Sufian caused a stir yesterday when she termed M Ilias Ali's wife a "widow", urging her to inform the prime minister about "the killers" of her husband.

The state minister also claimed that Tahsina Rushdir Luna, wife of the missing BNP leader, knows well "who has killed" her husband.

"Ilias Ali's wife, the widow, I want to say that you know in your heart who really killed your husband," Mannujan said, addressing a May Day programme at Osmani Memorial auditorium in the capital.

Prime Minister Sheikh Hasina was present on the occasion.

"I perceive your feelings that you cannot express what is in your heart when you appear on the television...and you know well who abducted your husband, where he is now, whether alive or dead, I don't know...Allah knows," the junior labour minister went on, now as if to contradict herself.

BNP organising secretary and former lawmaker Ilias Ali and his driver Ansar Ali went missing around midnight of April 17 from the capital's Banani area.

While the opposition chief Khaleda Zia claimed that government agencies had abducted the two men, Hasina claimed Ilias might be hiding on Khaleda Zia's instructions to create an issue. Refuting the opposition allegation, Mannujan

said, "Sheikh Hasina is Bangabandhu's daughter and she could never have done this." Insisting that Luna prepares to express herself

when she meets the prime minister, Mannujan said: "You [Luna] must provide the correct information to the prime minister so we can find your husband." It may be mentioned that Luna met the premier at

Gono Bhaban yesterday evening. Mannujan advised that Luna tell Hasina unhesi-

tatingly if Ilias Ali's disappearance had any link with intra-party disputes. The BNP and its 18-party alliance enforced in two

Kabori said the VC should resign for the greater interest of the university. She also told the demonstrators that she would talk to the prime minister on the issue.

On Tuesday, journalist Nurul Kabir, editor of daily New Age, media personalities Mamunur Rashid, Shampa Reza and Banya Mirza, singer Quazi Krishnakali Islam and Prof Anu Muhammad of JU economics department joined the demonstration and expressed solidarity with the students.

Ruling party MP Tarana Halim, also a JU senate member, the same day went to the university and talked to the agitating and antiagitation groups of teachers. She urged them to come to a mutual understanding to end the deadlock.

go for the fast-unto-death programme after Bangladesh Chhatra League men had beaten up at least 15 cultural activists on April 28 for protesting the pro-government student body's vandalism at a demonstration by the teachers the day before.

Shakila Sharmin, general secretary of Sangskritik Jote, told The Daily Star that they filed a case against 16 BCL activists on April 29 mentioning their profile but the law enforcers were yet to arrest any of the accused until yesterday. Badrul Alam, officer-in-

charge (OC) of Ashulia Police Station, said they had already taken necessary measures to nab the cul-

Prof Nasim Akhtar Hossain, convenor of Shikkhak Samaj, said the VC had to vacate his position for his alleged involvement in teachers' recruitment business, irregularities, leasing university property, and beating up and killing student using BCL activists on the campus.

Meanwhile, 273 teachers under the banner General Teachers of Jahangirnagar University yesterday urged the university's Chancellor Zillur Rahman, the president of the country, Prime Minister Sheikh Hasina, the education minister and law enforcement agencies to pay attention to the matter, said a press release.

The teachers, marked as loyal to the VC, also claimed that the agitating teachers had been creating chaos around the VC's residence by hurling abusive words. They alleged that the demonstrations were nothing but to fulfil the political motive of BNP-Jamaat alliance and personal interests of some teachers.

The education minister told The Daily Star, "We will soon take effective measures to dispel the impasse in Jahangirnagar University." He, however, did not elaborate on the steps his ministry may take.

"We have discussed the issue with the vicechancellor of the university today [Wednesday] morning. We hope to make a solution soon," Nahid said.

A top official of the ministry, wishing anonymity, said the minister met Prime Minister Sheikh Hasina Monday night at her office where they discussed about the ongoing stalemate at JU and Bangladesh University of Engineering and Technology (Buet).

Ambassador to the US Akramul Qader said the US Secretary of State's visit is a clear manifestation of excellent relations between the two countries.

"This visit carries special significance as it will also manifest US recognition to Bangladesh as a role model moderate Muslim majority country and of Bangladesh's continued economic growth," he said.

Asked about the agenda for discussion, the ambassador said the agenda is still being prepared. However he added that Dhaka will request for duty-free and quota free access of readymade garments, Bangladesh's inclusion in the Millennium Challenge Account (MCA) and reiterate an old demand by Bangladesh for the deportation of Bangabandhu's condemned killer Rashed Chowdhury from USA.

On signing of the proposed 'US-Bangladesh Partnership Dialogue', Akramul Qader said this may be signed as a guiding document or may come in as a joint declaration after bilateral talks between Hillary and

Dipu Moni. A senior official at the foreign ministry told The Daily Star that the text of the document is yet to be finalised, but both the sides are working to place it at the bilateral talks.

Meanwhile, US Ambassador in Dhaka Dan Mozena, met Foreign Minister Dipu Moni yesterday afternoon. Afterwards he told reporters about some of the things he was hoping would be accomplished during the visit of the US Secretary of State.

He said that both the foreign minister and he agreed that this visit was very important and would further boost bilateral relations between the two nations.

Another HC bench refused to hear the bail petitions of some opposition leaders, who have remained on the run since Monday fearing arrests, while yet another bench passed dissenting orders on a bail appeal.

Amid raids and arrests, several senior BNP leaders have gone into hiding, as the government's sudden tough stance against the opposition's continuous agitation on Monday sent waves of panic through the BNP-led 18-party alliance.

Over the last few days, police have arrested about a dozen top BNP leaders, including Joint Secretary General Ruhul Kabir Rizvi, and filed several cases against the opposition men in connection with Sunday's explosion in the secretariat compound and arson and vandalism during the hartal hours.

Party insiders told The Daily Star they did not go for fresh hartal programmes in view of the visits to Dhaka by US Secretary of State Hillary Clinton and Indian Finance Minister Pranab Mukherjee on May 5 and the Japanese deputy prime minister's visit today.

BNP Chairperson Khaleda Zia assured the US ambassador in Dhaka at a recent meeting of all-out cooperation during Hillary's Bangladesh visit, they added. Later in the day, Khaleda

held a meeting with some pro-BNP lawyers at her Gulshan office to find out a way to secure bails in the cases filed on Sunday night against top leaders of the 18-party alliance. The accused include Mirza
