Japan keen to invest

Asks govt to fix infrastructure first during talks, says metro rail financing is on

Japan has no reservations about changes in Dhaka's metro rail plan; rather, it is very positive about funding the project.

The statement came from Japanese Deputy Prime Minister Katsuya Okada during bilateral talks with Foreign Minister Dipu Moni at Sonargaon Hotel in the capital yesterday, official sources said.

Okada is the highest ranking Japanese official to tour Bangladesh since foreign minister Taro Aso's visit in 2006.

The most prestigious visit from Japan was by prime minister Yoshiro Mori in 2000. The last top-level trip from Bangladesh to Japan was by PM Sheikh Hasina in November 2010. Okada, who arrived here yesterday on a two-day offi-

cial visit, renewed the Japanese commitment to fund the \$2.9 billion Padma bridge project, coordinated by the World Bank.

try's economy. "The government should enact a law banning hartal. Hartal impacts negatively on the economy," FBCCI President AK Azad told The Daily Star after a meeting of the FBCCI governing council at its office in the capital's Motijheel.

The meeting was organised to discuss the current political situation and the economy.

The FBCCI held the discussion a day after a meeting of top business leaders on hartal and economy at Westin Hotel in Dhaka.
