Dr Mohammad Abu Yusuf was placed on a five-day remand yesterday in connection with a case filed against him for assisting war crimes suspect Abul Kalam Azad to flee the country.

Metropolitan Magistrate Mohammad Moniruzzaman issued the order after Sub-Inspector (SI) Nizam Uddin of Uttarkhan Police Station, also the investigation officer of the case, produced him before it with a seven-day remand prayer.

Rab arrested Dr Yusuf, a retired National University teacher, from a house at Agargoan on Wednesday.

Dr Yusuf helped Azad, a fugitive war crimes suspect widely known as Bachchu Razakar, to flee to India following the issuance of an arrest warrant against Azad by the International Crimes Tribunal-2 on April 3.

HILLARY'S VISIT

Joint document likely, says FM

Foreign Minister Dipu Moni yesterday said Dhaka and Washington are expected to sign a joint document during US Secretary of State Hillary Clinton's two-day visit here tomorrow.

The document styled 'Bangladesh-US Partnership Dialogue' will work as a platform to discuss full range of bilateral issues and cooperation for future development, she told a press conference at the foreign ministry.

Elaborating the United States' proposed dialogue, Dipu Moni said it will have two tiers. The first one will be jointly headed by the foreign secretary of Bangladesh and the under secretary of the US State Department and they will meet every year.

"This tier will function as foreign secretary level consultations, an official mechanism that Bangladesh has with different countries," she said,

adding "Foreign minister of Bangladesh and the US secretary of state will head the second politicallevel tier." Dipu Moni said at the official talks,

Dhaka will ask for duty-free and quota free access of readymade garments to US market, Bangladesh's inclusion in the Millennium Challenge Account and repatriation of Bangabandhu's convicted killer Rashed Chowdhury, who is hiding in the US. PRANAB'SVISIT

Talking about Indian Finance Minister Pranab Mukherjee's visit here tomorrow, Dipu Moni told reporters he will come basically to attend the closing ceremony of the 150th birth anniversary of Rabindranath Tagore.

During his visit, Pranab Mukherjee will call on Prime Minister Sheikh Hasina, she said adding that he will also hold a meeting with her where they will discuss a range of bilateral issues especially expediting the implementation of decisions taken during Hasina's visit to India in January 2010 and Manmohan's visit to Dhaka in September 2011.

ILIAS ALI ISSUE

At the press conference, Dipu Moni said the government is not worried about the human rights situation in the country.

Replying to a question about rights bodies' concern over the disappearances of Ilias Ali, Dipu Moni said, "Being a political leader, the missing incident of Ilias Ali is a matter of concern, and of course, we want its solution."

On a question about the proposal of forming a special commission by the Amnesty International and Human Rights Watch to find out Ilias Ali, the foreign minister said the proposal can be reviewed.

Youth stabs one-yr-old boy to death

A youth hacked a one-year-old boy to death and injured three others in Boktaboli area of the sadar upazila on Wednesday night.

The attacker is a paternal cousin of the victim, Azizul Haque, son of Imam Ali.

The injured are Tanzila, 10, and Tania, 9, two sisters of Azizul, and one of their neighbours, Razia Begum, 32.

The two sisters were admitted to Dhaka Medical College Hospital in a critical condition, while Razia was under treatment in Khanpur 200-bed hospital in the district town.

Locals rushed the injured to Khanpur 200-bed hospital where doctors declared Azizul dead.

The victims' mother Sultana Begum said the incident occurred soon after she went out of doors. Sultana's husband Imam Ali is an expatriate in Singapore.

HC injunction on 2 housing projects

Bela files petitions to save Bayezid Bostami shrine and Madarsha Sreebil

The High Court yesterday issued an injunction for six months on implementation of two separate housing projects to protect the environment and heritage of Bayezid Bostami shrine and Madarsha Sreebil areas in Chittagong. In response to separate writ petitions, the HC directed the

authorities to stop construction of a housing project on the bank of a century-old pond, where rare species of tortoises are living, near Bayezid Bostami shrine, which is also a national heritage site. JMG Holding Estate and Developer, a private housing

company, is implementing a housing project damaging the pond and its rare species of tortoises, petitioner's lawyer İqbal Kabir Lytton told The Daily Star. The rare species of tortoises, which are a part of the

national heritage, would go extinct, if the housing project was implemented near the pond, he said.

The court yesterday also ordered for stopping implementation of a housing project at Madarsha Sreebil, a water body and agricultural land area at Hathazari upazila in Chittagong. The HC bench of Justice AHM Shamsuddin Choudhury

Manik and Justice Jahangir Hossain Selim issued the orders

after hearing the writ petitions filed by Bangladesh Environmental Lawyers Association (Bela) recently. The court also issued separate rules upon the authorities concerned of the government and projects to explain in

three weeks why the projects should not be declared illegal and against the public interest. In the rules, the court asked the authorities to explain why they should not be directed to protect the environment and

heritage of the areas where the housing projects were being implemented. Bela filed the petitions seeking HC directives on the

authorities to save the environment and heritage near Bayezid Bostami shrine and Madarsha areas.

Tribunal-1 will decide on May 28 if it would indict Jamaat-e-Islami Ameer Motiur Rahman Nizami for his alleged involvement in crimes against humanity during the Liberation War of 1971.

The three-member tribunal set the date after Nizami's counsel Abdur Razzaq concluded the defence's arguments in favour of an application seeking discharge of the Jamaat chief.

If indicted, Nizami will face trial at the tribunal. Otherwise, he will be discharged.

The Jamaat chief was produced before the court yesterday. He is facing 15 charges of crimes against humanity allegedly committed in the 1971 war.

Abdur Razzaq, the chief defence counsel of Jamaat leaders, yesterday argued that the charges against Nizami were "too vague".

The counsel referred to some charges, which mentioned anti-liberation statements and speeches given by Nizami during the war.

Razzaq argued that the prosecution had failed to substantiate the statements and speeches' connection to any crimes.

"Where are the alleged crimes?" said the counsel, adding that the prosecution was "thousands of miles away" from connecting the statements to any crimes.

He also went on to add that several charges mentioned that the "supporters of Nizami" had conducted atrocities on his directives. "Who are these supporters?

This is too vague and should have been more specific". Upon hearing the arguments from the defence counsel, the tribunal fixed

Salauddin Quader Chowdhury was produced before the court yesterday. He is facing 23 specific charges of crimes against humanity committed during the Liberation War of 1971.

At one point during yesterday's proceedings, the BNP leader told the tribunal that there were some discrepancies between the formal charges the prosecution submitted to the tribunal, and the charges that were framed against him.

"One thing was given and another thing was taken", he said. Zaheer Ahmed, a judge of


